10	mounting crisis of gang-related violence perpetrated by gang members who threaten and
11	terrorize peaceful citizens and children; and
12	WHEREAS, the General Assembly both recognizes and defends the right of
13	Kentucky citizens to exercise the rights to freedom of speech and freedom of association
14	as protected by the First Amendment of the United States Constitution; and
15	WHEREAS, strengthening law enforcement's ability to prevent and end the
16	increasing gang-related violence in Kentucky will not infringe on the constitutional rights
17	of the citizens of Kentucky and instead will facilitate an end to the increasing gang-
18	related violence that present a clear and present danger to the Commonwealth;
19	NOW, THEREFORE,
20	Be it enacted by the General Assembly of the Commonwealth of Kentucky:

(b) Fifteen percent (15%) shall be paid to the Office of the Attorney General or, in the alternative, the fifteen percent (15%) shall be paid to the Prosecutors Advisory Council for deposit on behalf of the Commonwealth's attorney or county attorney who has participated in the forfeiture proceeding, as determined by the court pursuant to subsection (9) of this section. - (a) If the offense for which he presently stands convicted is a Class A or Class B felony, or if the person was previously convicted of one (1) or more sex crimes committed against a minor as defined in KRS 17.500 and presently stands convicted of a subsequent sex crime, a persistent felony offender in the first degree shall be sentenced to an indeterminate term of imprisonment, the maximum of which shall not be less than twenty (20) years nor more than fifty (50) years, or life imprisonment, or life imprisonment without parole for twenty-five (25) years for a sex crime committed against a minor;
- (b) If the offense for which he presently stands convicted is a Class C or Class D felony, a persistent felony offender in the first degree shall be sentenced to an indeterminate term of imprisonment, the maximum of which shall not be less than ten (10) years nor more than twenty (20) years.
- (7) A person who is found to be a persistent felony offender in the first degree shall not be eligible for probation, shock probation, or conditional discharge, unless all offenses for which the person stands convicted are Class D felony offenses which do not involve a violent act against a person or a sex crime as that term is defined in KRS 17.500, in which case, probation, shock probation, or conditional discharge may be granted. If the offense the person presently stands convicted of is a Class A, B, or C felony, the person shall not be eligible for parole until the person has served a minimum term of incarceration of not less than ten (10) years, unless another sentencing scheme applies. A violent offender who is found to be a persistent felony offender in the first degree shall not be eligible for parole except as provided in KRS 439.3401.

1	(8)	A conviction, plea of guilty, or Alford plea under KRS 218A.1415 shall not trigger
2		the application of this section, regardless of the number or type of prior felony
3		convictions that may have been entered against the defendant. A conviction, plea of
