22	with a qualified fire department in the Commonwealth.
23	(b) In order to evaluate the effectiveness of the credit in achieving the goal
24	stated in this subsection, the department shall report the following
25	information to the Legislative Research Commission on or before December
26	1, 2021, and on or before every December 1 thereafter as long as the credit
27	permitted by subsection (2) of this section is available:

(5) Statistics of crude oil as reported to the Department of Revenue under the crude oil excise tax requirements of KRS Chapter 137 and statistics of natural gas production as reported to the Department of Revenue under the natural resources severance tax requirements of KRS Chapter 143A may be made public by the department by release to the Energy and Environment Cabinet, Department for Natural Resources. Notwithstanding any provision of law to the contrary, beginning with mine-map (6) submissions for the 1989 tax year, the department may make public or divulge only those portions of mine maps submitted by taxpayers to the department pursuant to KRS Chapter 132 for ad valorem tax purposes that depict the boundaries of minedout parcel areas. These electronic maps shall not be relied upon to determine actual boundaries of mined-out parcel areas. Property boundaries contained in mine maps required under KRS Chapters 350 and 352 shall not be construed to constitute land surveying or boundary surveys as defined by KRS 322.010 and any administrative regulations promulgated thereto.
