1 AN ACT relating to administrative regulations. 2 Be it enacted by the General Assembly of the Commonwealth of Kentucky: 3 → SECTION 1. A NEW SECTION OF KRS CHAPTER 13A IS CREATED TO 4 **READ AS FOLLOWS:** 5 Except for an emergency administrative regulation promulgated under KRS 13A.190, 6 any administrative regulation that has a major economic impact as defined in Section 7 2 of this Act shall not take effect until the Kentucky General Assembly enacts 8 legislation ratifying the administrative regulation. Following the ratification, the 9 administrative regulation shall become effective on the effective date of the ratifying 10 legislation. 11 Section 2. KRS 13A.010 is amended to read as follows: 12 As used in this chapter, unless the context otherwise requires: 13 "Administrative body" means each state board, bureau, cabinet, commission, (1)14 department, authority, officer, or other entity, except the General Assembly and the 15 Court of Justice, authorized by law to promulgate administrative regulations; 16 (2)"Administrative regulation" means each statement of general applicability 17 promulgated by an administrative body that implements, interprets, or prescribes 18 law or policy, or describes the organization, procedure, or practice requirements of 19 any administrative body. The term includes an existing administrative regulation, a 20 new administrative regulation, an emergency administrative regulation, an 21 administrative regulation in contemplation of a statute, and the amendment or repeal 22 of an existing administrative regulation, but does not include: 23 Statements concerning only the internal management of an administrative (a) 24 body and not affecting private rights or procedures available to the public; 25 Declaratory rulings; (b) 26 (c) Intradepartmental memoranda not in conflict with KRS 13A.130; 27 Statements relating to acquisition of property for highway purposes and (d)

2		(e) Rules, regulations, and policies of the governing boards of institutions that
3		make up the postsecondary education system defined in KRS 164.001
4		pertaining to students attending or applicants to the institutions, to faculty and
5		staff of the respective institutions, or to the control and maintenance of land
6		and buildings occupied by the respective institutions;
7	(3)	"Adopted" means that an administrative regulation has become effective in
8		accordance with the provisions of this chapter;
9	(4)	"Authorizing signature" means the signature of the head of the administrative body
10		authorized by statute to promulgate administrative regulations;
11	(5)	"Commission" means the Legislative Research Commission;
12	(6)	"Effective" means that an administrative regulation has completed the legislative
13		subcommittee review established by KRS 13A.290, 13A.330, and 13A.331;
14	(7)	"Federal mandate" means any federal constitutional, legislative, or executive law or
15		order that requires or permits any administrative body to engage in regulatory
16		activities that impose compliance standards, reporting requirements, recordkeeping,
17		or similar responsibilities upon entities in the Commonwealth;
18	(8)	"Federal mandate comparison" means a written statement containing the
19		information required by KRS 13A.245;
20	(9)	"Filed" or "promulgated" means that an administrative regulation, or other
21		document required to be filed by this chapter, has been submitted to the
22		Commission in accordance with this chapter;
23	(10)	"Local government" means and includes a city, county, urban-county, charter
24		county, consolidated local government, special district, or a quasi-governmental
25		body authorized by the Kentucky Revised Statutes or a local ordinance;
26	(11)	"Major economic impact" means an overall annual economic impact from an
27		administrative regulation of five hundred thousand dollars (\$500,000) or more on

2	promulgating administrative bodies;
3	(12) "Proposed administrative regulation" means an administrative regulation that:
4	(a) Has been filed by an administrative body; and
5	(b) Has not become effective or been withdrawn;
6	(13)[(12)] "Regulatory impact analysis" means a written statement containing the
7	provisions required by KRS 13A.240;
8	(14)[(13)] "Small business" means a business entity, including its affiliates, that:
9	(a) Is independently owned and operated; and
10	(b) 1. Employs fewer than one hundred fifty (150) full-time employees or their
11	equivalent; or
12	2. Has gross annual sales of less than six million dollars (\$6,000,000);
13	(15)[(14)] "Statement of consideration" means the document required by KRS 13A.280
14	in which the administrative body summarizes the comments received, its responses
15	to those comments, and the action taken, if any, as a result of those comments and
16	responses;
17	(16)[(15)] "Subcommittee" means the Administrative Regulation Review Subcommittee,
18	any other subcommittee of the Legislative Research Commission, an interim joint
19	committee, or a House and Senate standing committee;
20	(17) [(16)] "Tiering" means the tailoring of regulatory requirements to fit the particular
21	circumstances surrounding regulated entities; and
22	(18)[(17)] "Written comments" means comments submitted to the administrative body's
23	contact person identified pursuant to KRS 13A.220(6)(d) via hand delivery, United
24	States mail, e-mail, or facsimile and may include but is not limited to comments
25	submitted internally from within the promulgating administrative body or from
26	another administrative body.
27	Section 3. KRS 13A.250 is amended to read as follows:

An administrative body that promulgates an administrative regulation shall consider 2 the cost that the administrative regulation may cause state or local government and 3 *regulated entities* to incur. 4 (2)(a) A two (2) part cost analysis shall be completed for each administrative 5 regulation. 6 (b) In the first part, the cost analysis shall include the projected cost or cost 7 savings to the Commonwealth of Kentucky and each of its affected agencies, 8 and the projected cost or cost savings to affected local governments, including 9 cities, counties, fire departments, and school districts. 10 (c) In the second part, the cost analysis shall include the projected cost or costs 11 savings to the regulated entities affected by the administrative regulation. 12 Agencies or entities affected by the administrative regulation may submit (d)13 comments in accordance with KRS 13A.270(1) to the promulgating 14 administrative body or to a subcommittee reviewing the administrative 15 regulation. 16 $(3)^{[(2)]}$ Each administrative body that promulgates an administrative regulation shall 17 prepare and submit with the administrative regulation a fiscal note. The fiscal note 18 shall state: 19 (a) The number of the administrative regulation; 20 (b) The name, e-mail address, and telephone number of the contact person of the 21 administrative body identified pursuant to KRS 13A.220(6)(d), and, if 22 applicable, the name, e-mail address, and telephone number of an alternate 23 person to be contacted with specific questions about the fiscal note; 24 *Each*[The] unit, part, or division of state or local government the (c) 25 administrative regulation will affect; 26 (d) In detail, the aspect or service of state or local government to which the 27 administrative regulation relates, including identification of the applicable

3	(e)	The estimated effect of the administrative regulation on the expenditures and

11		effect. If specific dollar estimates cannot be determined, the administrative

13		administrative regulation; and
14	<u>(g)</u>	The conclusion of the promulgating administrative body as to whether the
15		administrative regulation will have an overall economic impact of five
16		hundred thousand dollars (\$500,000) or more on state and local

19	Com	mission in the preparation of the fiscal note.

- 2 \rightarrow Section 6. This Act shall be known and may be cited as the Kentucky REINS
- 3 Act, or the Kentucky Regulations from the Executive in Need of Scrutiny Act.
