6		Section 2 of this Act shall comply with the Kentucky Building Code.
7	<u>(2)</u>	An agritourism building built prior to December 31, 2016, shall be exempt from
8		the following requirements within the Kentucky Building Code:
9		(a) An agritourism building built prior to December 31, 2016, shall not be
10		required to comply with the seismic requirements within the Kentucky
11		Building Code; and
12		(b) If an agritourism building has a capacity of four hundred (400) persons or
13		is six thousand (6,000) square feet or less, an agritourism building built
14		prior to December 31, 2016 shall not require the services of an architect
15		licensed by the Commonwealth of Kentucky.

20		that are an integral part of an agritourism activity, including certain hazards,
21		such as surface or subsurface conditions; natural conditions of land, vegetation,
22		or water; the behavior of wild or domestic animals; and the ordinary dangers of
23		structures or equipment used in farming and ranching operations; and

2	(2)	"Cabinet" means the Cabinet for Health and Family Services or its designee;
3	(3)	"Hotel" means every building or structure kept, used, maintained, advertise

- 3 (3) "Hotel" means every building or structure kept, used, maintained, advertised, or 4 held out to the public as a place where sleeping accommodations are furnished to 5 the public, and includes motels, tourist homes, and similar establishments, but 6 excludes boarding houses and rooming houses;

- 16 (a) Having five (5) or fewer guest rooms or suites for occupancy;
- 17 (b) In which breakfast and other meals may be served to guests; and
- 18 (c) Whose innkeeper resides on the premises or property adjacent to the premises 19 during periods of occupancy;
- 20 (7) "Bed and breakfast inn" means a private inn or other unique residential facility:
- 21 (a) Having six (6) or more guest rooms or suites for occupancy;
- 22 (b) In which breakfast and other meals may be served to the guests; and
- 23 (c) Whose innkeeper resides on the premises or property adjacent to the premises 24 during periods of occupancy; and
- 25 (8) "Farmstay" means a bed and breakfast establishment at a farm location whose focus includes agritourism as defined in *Section 2 of this Act*[KRS 247.800].
