

1 AN ACT relating to the reemployment of retired police officers by a postsecondary
2 institution.

3 *Be it enacted by the General Assembly of the Commonwealth of Kentucky:*

4 ➔SECTION 1. A NEW SECTION OF KRS CHAPTER 164 IS CREATED TO
5 BE NUMBERED AS KRS 164.950 TO 164.980 AND TO READ AS FOLLOWS:

6 (1) As used in this section:

7 (a) "Postsecondary institution" means any public institution of postsecondary
8 education who is authorized to establish a police department pursuant to
9 KRS 164.950 to 164.980 who participates in the Kentucky Employees
10 Retirement System; and

11 (b) "Police officer" has the same meaning as "police officer" in KRS 15.420,
12 as police officer in 164.950 to 164.980, and as "officer" in KRS 16.010.

13 (2) Subject to the limitations of subsection (7) of this section, a postsecondary
14 institution may employ individuals as police officers under this section who have
15 retired from the Kentucky Employees Retirement System, the County Employees
16 Retirement System, or the State Police Retirement System.

17 (3) To be eligible for employment under this section, an individual shall have:

18 (a) Participated in the Law Enforcement Foundation Program fund under KRS
19 15.410 to 15.510, retired as a commissioned officer pursuant to KRS
20 Chapter 16, or retired as a police officer from a postsecondary institution;

21 (b) Retired with at least twenty (20) years of service credit;

22 (c) Been separated from service for the period required by Section 2 of this Act
23 so that the member's retirement is not voided;

24 (d) Retired with no administrative charges pending; and

25 (e) Retired with no preexisting agreement between the individual and the
26 postsecondary institution prior to the individual's retirement for the
27 individual to return to work for the postsecondary institution.

1 (4) Individuals employed under this section shall:

2 (a) Serve for a term not to exceed one (1) year. The one (1) year employment
3 term may be renewed annually at the discretion of the employing
4 postsecondary institution;

5 (b) Receive compensation according to the standard procedures applicable to
6 the employing postsecondary institution; and

7 (c) Be employed based upon need as determined by the employing
8 postsecondary institution.

9 (5) Notwithstanding any provisions of KRS 16.505 to 16.652, 18A.225 to 18A.2287,
10 61.510 to 61.705, or 78.510 to 78.852 to the contrary:

11 (a) Individuals employed under this section shall continue to receive all
12 retirement and health insurance benefits to which they were entitled upon
13 retiring in the applicable system administered by Kentucky Retirement
14 Systems;

15 (b) Individuals employed under this section shall not be eligible to receive
16 health insurance coverage through the employing postsecondary
17 institution;

18 (c) The postsecondary institution shall not pay any employer contributions or
19 retiree health expense reimbursements to the Kentucky Retirement Systems
20 required by subsection (17) of Section 2 of this Act for individuals employed
21 under this section; and

22 (d) The postsecondary institution shall not pay any insurance contributions to
23 the state health insurance plan, as provided by KRS 18A.225 to 18A.2287,
24 for individuals employed under this section.

25 (6) Individuals employed under this section shall be subject to any legislative due
26 process provisions applicable to police officers of the employing postsecondary
27 institution. A decision not to renew a one (1) year appointment term under this

1 section shall not be considered a disciplinary action or deprivation subject to due
2 process.

3 (7) The number of retired police officers a postsecondary institution may hire under
4 the provisions of this section shall be limited to five (5) retired police officers or a
5 number equal to twenty-five percent (25%) of the police officers employed by the
6 postsecondary institution in calendar year 2018, whichever is greater.

7 ➔Section 2. KRS 61.637 is amended to read as follows:

8 (1) A retired member who is receiving monthly retirement payments under any of the
9 provisions of KRS 61.510 to 61.705 and 78.510 to 78.852 and who is reemployed
10 as an employee by a participating agency prior to August 1, 1998, shall have his
11 retirement payments suspended for the duration of reemployment. Monthly
12 payments shall not be suspended for a retired member who is reemployed if he
13 anticipates that he will receive less than the maximum permissible earnings as
14 provided by the Federal Social Security Act in compensation as a result of
15 reemployment during the calendar year. The payments shall be suspended at the
16 beginning of the month in which the reemployment occurs.

17 (2) Employer and employee contributions shall be made as provided in KRS 61.510 to
18 61.705 and 78.510 to 78.852 on the compensation paid during reemployment,
19 except where monthly payments were not suspended as provided in subsection (1)
20 of this section or would not increase the retired member's last monthly retirement
21 allowance by at least one dollar (\$1), and the member shall be credited with
22 additional service credit.

23 (3) In the month following the termination of reemployment, retirement allowance
24 payments shall be reinstated under the plan under which the member was receiving
25 payments prior to reemployment.

26 (4) (a) Notwithstanding the provisions of this section, the payments suspended in
27 accordance with subsection (1) of this section shall be paid retroactively to the

1 retired member, or his estate, if he does not receive more than the maximum
2 permissible earnings as provided by the Federal Social Security Act in
3 compensation from participating agencies during any calendar year of
4 reemployment.

5 (b) If the retired member is paid suspended payments retroactively in accordance
6 with this section, employee contributions deducted during his period of
7 reemployment, if any, shall be refunded to the retired employee, and no
8 service credit shall be earned for the period of reemployment.

9 (c) If the retired member is not eligible to be paid suspended payments for his
10 period of reemployment as an employee, his retirement allowance shall be
11 recomputed under the plan under which the member was receiving payments
12 prior to reemployment as follows:

13 1. The retired member's final compensation shall be recomputed using
14 creditable compensation for his period of reemployment; however, the
15 final compensation resulting from the recalculation shall not be less than
16 that of the member when his retirement allowance was last determined;

17 2. If the retired member initially retired on or subsequent to his normal
18 retirement date, his retirement allowance shall be recomputed by using
19 the formula in KRS 61.595(1);

20 3. If the retired member initially retired prior to his normal retirement date,
21 his retirement allowance shall be recomputed using the formula in KRS
22 61.595(2), except that the member's age used in computing benefits shall
23 be his age at the time of his initial retirement increased by the number of
24 months of service credit earned for service performed during
25 reemployment;

26 4. The retirement allowance payments resulting from the recomputation
27 under this subsection shall be payable in the month following the

1 termination of reemployment in lieu of payments under subparagraph 3.
2 The member shall not receive less in benefits as a result of the
3 recomputation than he was receiving prior to reemployment or would
4 receive as determined under KRS 61.691; and

5 5. Any retired member who was reemployed prior to March 26, 1974, shall
6 begin making contributions to the system in accordance with the
7 provisions of this section on the first day of the month following March
8 26, 1974.

9 (5) A retired member, or his estate, shall pay to the retirement fund the total amount of
10 payments which are not suspended in accordance with subsection (1) of this section
11 if the member received more than the maximum permissible earnings as provided
12 by the Federal Social Security Act in compensation from participating agencies
13 during any calendar year of reemployment, except the retired member or his estate
14 may repay the lesser of the total amount of payments which were not suspended or
15 fifty cents (\$0.50) of each dollar earned over the maximum permissible earnings
16 during reemployment if under age sixty-five (65), or one dollar (\$1) for every three
17 dollars (\$3) earned if over age sixty-five (65).

18 (6) (a) "Reemployment" or "reinstatement" as used in this section shall not include a
19 retired member who has been ordered reinstated by the Personnel Board under
20 authority of KRS 18A.095.

21 (b) A retired member who has been ordered reinstated by the Personnel Board
22 under authority of KRS 18A.095 or by court order or by order of the Human
23 Rights Commission and accepts employment by an agency participating in the
24 Kentucky Employees Retirement System or County Employees Retirement
25 System shall void his retirement by reimbursing the system in the full amount
26 of his retirement allowance payments received.

27 (7) (a) Effective August 1, 1998, the provisions of subsections (1) to (4) of this

1 section shall no longer apply to a retired member who is reemployed in a
2 position covered by the same retirement system from which the member
3 retired. Reemployed retired members shall be treated as new members upon
4 reemployment. Any retired member whose reemployment date preceded
5 August 1, 1998, who does not elect, within sixty (60) days of notification by
6 the retirement systems, to remain under the provisions of subsections (1) to
7 (4) of this section shall be deemed to have elected to participate under this
8 subsection.

9 (b) A retired member whose disability retirement was discontinued pursuant to
10 KRS 61.615 and who is reemployed in one (1) of the systems administered by
11 the Kentucky Retirement Systems prior to his or her normal retirement date
12 shall have his or her accounts combined upon termination for determining
13 eligibility for benefits. If the member is eligible for retirement, the member's
14 service and creditable compensation earned as a result of his or her
15 reemployment shall be used in the calculation of benefits, except that the
16 member's final compensation shall not be less than the final compensation last
17 used in determining his or her retirement allowance. The member shall not
18 change beneficiary or payment option designations. This provision shall apply
19 to members reemployed on or after August 1, 1998.

20 (8) A retired member or his employer shall notify the retirement system if he has
21 accepted employment or is serving as a volunteer with an employer that participates
22 in the retirement system from which the member retired. The retired member and
23 the participating employer shall submit the information required or requested by the
24 systems to confirm the individual's employment or volunteer status.

25 (9) If the retired member is under a contract, the member shall submit a copy of that
26 contract to the retirement system, and the retirement system shall determine if the
27 member is an independent contractor for purposes of retirement benefits. The

1 retired member and the participating employer shall submit the information required
2 or requested by the systems to confirm the individual's employment or volunteer
3 status.

4 (10) If a member is receiving a retirement allowance, or has filed the forms required for
5 a retirement allowance, and is employed within one (1) month of the member's
6 initial retirement date in a position that is required to participate in the same
7 retirement system from which the member retired, the member's retirement shall be
8 voided and the member shall repay to the retirement system all benefits received.
9 The member shall contribute to the member account established for him prior to his
10 voided retirement. The retirement allowance for which the member shall be eligible
11 upon retirement shall be determined by total service and creditable compensation.

12 (11) (a) If a member of the Kentucky Employees Retirement System retires from a
13 department which participates in more than one (1) retirement system and is
14 reemployed within one (1) month of his initial retirement date by the same
15 department in a position participating in another retirement system, the retired
16 member's retirement allowance shall be suspended for the first month of his
17 retirement and the member shall repay to the retirement system all benefits
18 received for the month.

19 (b) A retired member of the County Employees Retirement System who after
20 initial retirement is hired by the county from which the member retired shall
21 be considered to have been hired by the same employer.

22 (12) (a) If a hazardous member who retired prior to age fifty-five (55), or a
23 nonhazardous member who retired prior to age sixty-five (65), is reemployed
24 within six (6) months of the member's termination by the same employer, the
25 member shall obtain from his previous and current employers a copy of the
26 job description established by the employers for the position and a statement
27 of the duties performed by the member for the position from which he retired

1 and for the position in which he has been reemployed.

2 (b) The job descriptions and statements of duties shall be filed with the retirement
3 office.

4 (13) If the retirement system determines that the retired member has been employed in a
5 position with the same principal duties as the position from which the member
6 retired:

7 (a) The member's retirement allowance shall be suspended during the period that
8 begins on the month in which the member is reemployed and ends six (6)
9 months after the member's termination;

10 (b) The retired member shall repay to the retirement system all benefits paid from
11 systems administered by Kentucky Retirement Systems under reciprocity,
12 including medical insurance benefits, that the member received after
13 reemployment began;

14 (c) Upon termination, or subsequent to expiration of the six (6) month period
15 from the date of termination, the retired member's retirement allowance based
16 on his initial retirement account shall no longer be suspended and the member
17 shall receive the amount to which he is entitled, including an increase as
18 provided by KRS 61.691;

19 (d) Except as provided in subsection (7) of this section, if the position in which a
20 retired member is employed after initial retirement is a regular full-time
21 position, the retired member shall contribute to a second member account
22 established for him in the retirement system. Service credit gained after the
23 member's date of reemployment shall be credited to the second member
24 account; and

25 (e) Upon termination, the retired member shall be entitled to benefits payable
26 from his second retirement account.

27 (14) (a) If the retirement system determines that the retired member has not been

1 reemployed in a position with the same principal duties as the position from
2 which he retired, the retired member shall continue to receive his retirement
3 allowance.

4 (b) If the position is a regular full-time position, the member shall contribute to a
5 second member account in the retirement system.

6 (15) (a) If a retired member is reemployed at least one (1) month after initial
7 retirement in a different position, or at least six (6) months after initial
8 retirement in the same position, and prior to normal retirement age, the retired
9 member shall contribute to a second member account in the retirement system
10 and continue to receive a retirement allowance from the first member account.

11 (b) Service credit gained after reemployment shall be credited to the second
12 member account. Upon termination, the retired member shall be entitled to
13 benefits payable from the second member account.

14 (16) A retired member who is reemployed and contributing to a second member account
15 shall not be eligible to purchase service credit under any of the provisions of KRS
16 16.505 to 16.652, 61.510 to 61.705, or 78.510 to 78.852 which he was eligible to
17 purchase prior to his initial retirement.

18 (17) Notwithstanding any provision of subsections (1) to (7)(a) and (10) to (15) of this
19 section, the following shall apply to retired members ~~[who retired prior to January~~
20 ~~1, 2019, and]~~who are reemployed by an agency participating in one (1) of the
21 systems administered by Kentucky Retirement Systems on or after September 1,
22 2008:

23 (a) Except as provided by paragraphs (c) and (d) of this subsection, if a member is
24 receiving a retirement allowance from one (1) of the systems administered by
25 Kentucky Retirement Systems, or has filed the forms required to receive a
26 retirement allowance from one (1) of the systems administered by Kentucky
27 Retirement Systems, and is employed in a regular full-time position required

1 to participate in one (1) of the systems administered by Kentucky Retirement
2 Systems or is employed in a position that is not considered regular full-time
3 with an agency participating in one (1) of the systems administered by
4 Kentucky Retirement Systems within three (3) months following the member's
5 initial retirement date, the member's retirement shall be voided, and the
6 member shall repay to the retirement system all benefits received, including
7 any health insurance benefits. If the member is returning to work in a regular
8 full-time position required to participate in one (1) of the systems
9 administered by Kentucky Retirement Systems:

- 10 1. The member shall contribute to a member account established for him or
11 her in one (1) of the systems administered by Kentucky Retirement
12 Systems, and employer contributions shall be paid on behalf of the
13 member by the participating employer; and
 - 14 2. Upon subsequent retirement, the member shall be eligible for a
15 retirement allowance based upon total service and creditable
16 compensation, including any additional service or creditable
17 compensation earned after his or her initial retirement was voided;
- 18 (b) Except as provided by paragraphs (c) and (d) of this subsection, if a member is
19 receiving a retirement allowance from one (1) of the systems administered by
20 Kentucky Retirement Systems and is employed in a regular full-time position
21 required to participate in one (1) of the systems administered by Kentucky
22 Retirement Systems after a three (3) month period following the member's
23 initial retirement date, the member may continue to receive his or her
24 retirement allowance during the period of reemployment subject to the
25 following provisions:
- 26 1. Both the employee and participating agency shall certify in writing on a
27 form prescribed by the board that no prearranged agreement existed

1 between the employee and agency prior to the employee's retirement for
2 the employee to return to work with the participating agency. If an
3 elected official is reelected to a new term of office in the same position
4 and retires following the election but prior to taking the new term of
5 office, he or she shall be deemed by the system as having a prearranged
6 agreement under the provisions of this subparagraph and shall have his
7 or her retirement voided. If the participating agency or employer fail to
8 complete the certification, the member's retirement shall be voided and
9 the provisions of paragraph (a) of this subsection shall apply to the
10 member and the employer;

11 2. Notwithstanding any other provision of KRS Chapter 16, 61, or 78 to
12 the contrary, the member shall not contribute to the systems and shall
13 not earn any additional benefits for any work performed during the
14 period of reemployment;

15 3. Except as provided by KRS 70.291 to 70.293, ~~and~~ 95.022, **and Section**
16 **1 of this Act** and except for any retiree employed as a school resource
17 officer as defined by KRS 158.441, the employer shall pay employer
18 contributions as specified by KRS 61.565 and 61.702 on all creditable
19 compensation earned by the employee during the period of
20 reemployment. The additional contributions paid shall be used to reduce
21 the unfunded actuarial liability of the systems; and

22 4. Except as provided by KRS 70.291 to 70.293, ~~and~~ 95.022, **and Section**
23 **1 of this Act** and except for any retiree employed as a school resource
24 officer as defined by KRS 158.441, the employer shall be required to
25 reimburse the systems for the cost of the health insurance premium paid
26 by the systems to provide coverage for the retiree, not to exceed the cost
27 of the single premium. Effective July 1, 2015, local school boards shall

1 not be required to pay the reimbursement required by this subparagraph
2 for retirees employed by the board for eighty (80) days or less during the
3 fiscal year;

4 (c) If a member is receiving a retirement allowance from the State Police
5 Retirement System or from hazardous duty retirement coverage with the
6 Kentucky Employees Retirement System or the County Employees Retirement
7 System, or has filed the forms required to receive a retirement allowance from
8 the State Police Retirement System or from hazardous duty retirement
9 coverage with the Kentucky Employees Retirement System or the County
10 Employees Retirement System, and is employed in a regular full-time position
11 required to participate in the State Police Retirement System or in a hazardous
12 duty position with the Kentucky Employees Retirement System or the County
13 Employees Retirement System within one (1) month following the member's
14 initial retirement date, the member's retirement shall be voided, and the
15 member shall repay to the retirement system all benefits received, including
16 any health insurance benefits. If the member is returning to work in a regular
17 full-time position required to participate in one (1) of the systems
18 administered by Kentucky Retirement Systems:

19 1. The member shall contribute to a member account established for him or
20 her in one (1) of the systems administered by Kentucky Retirement
21 Systems, and employer contributions shall be paid on behalf of the
22 member by the participating employer; and

23 2. Upon subsequent retirement, the member shall be eligible for a
24 retirement allowance based upon total service and creditable
25 compensation, including any additional service or creditable
26 compensation earned after his or her initial retirement was voided;

27 (d) If a member is receiving a retirement allowance from the State Police

1 Retirement System or from hazardous duty retirement coverage with the
2 Kentucky Employees Retirement System or the County Employees Retirement
3 System and is employed in a regular full-time position required to participate
4 in the State Police Retirement System or in a hazardous duty position with the
5 Kentucky Employees Retirement System or the County Employees Retirement
6 System after a one (1) month period following the member's initial retirement
7 date, the member may continue to receive his or her retirement allowance
8 during the period of reemployment subject to the following provisions:

- 9 1. Both the employee and participating agency shall certify in writing on a
10 form prescribed by the board that no prearranged agreement existed
11 between the employee and agency prior to the employee's retirement for
12 the employee to return to work with the participating agency. If an
13 elected official is reelected to a new term of office in the same position
14 and retires following the election but prior to taking the new term of
15 office, he or she shall be deemed by the system as having a prearranged
16 agreement under the provisions of this subparagraph and shall have his
17 or her retirement voided. If the participating agency or employer fail to
18 complete the certification, the member's retirement shall be voided and
19 the provisions of paragraph (c) of this subsection shall apply to the
20 member and the employer;
- 21 2. Notwithstanding any other provision of KRS Chapter 16, 61, or 78 to
22 the contrary, the member shall not contribute to the systems and shall
23 not earn any additional benefits for any work performed during the
24 period of reemployment;
- 25 3. Except as provided by KRS 70.291 to 70.293, ~~and~~ 95.022, **and Section**
26 **1 of this Act** and except for any retiree employed as a school resource
27 officer as defined by KRS 158.441, the employer shall pay employer

- 1 contributions as specified by KRS 61.565 and 61.702 on all creditable
2 compensation earned by the employee during the period of
3 reemployment. The additional contributions paid shall be used to reduce
4 the unfunded actuarial liability of the systems; and
- 5 4. Except as provided by KRS 70.291 to 70.293, ~~and~~ 95.022, **and Section**
6 **I of this Act** and except for any retiree employed as a school resource
7 officer as defined by KRS 158.441, the employer shall be required to
8 reimburse the systems for the cost of the health insurance premium paid
9 by the systems to provide coverage for the retiree, not to exceed the cost
10 of the single premium;
- 11 (e) Notwithstanding paragraphs (a) to (d) of this subsection, a retired member
12 who qualifies as a volunteer for an employer participating in one (1) of the
13 systems administered by Kentucky Retirement Systems and who is receiving
14 reimbursement of actual expenses, a nominal fee for his or her volunteer
15 services, or both, shall not be considered an employee of the participating
16 employer and shall not be subject to paragraphs (a) to (d) of this subsection if:
- 17 1. Prior to the retired member's most recent retirement date, he or she did
18 not receive creditable compensation from the participating employer in
19 which the retired member is performing volunteer services;
- 20 2. Any reimbursement or nominal fee received prior to the retired
21 member's most recent retirement date has not been credited as creditable
22 compensation to the member's account or utilized in the calculation of
23 the retired member's benefits;
- 24 3. The retired member has not purchased or received service credit under
25 any of the provisions of KRS 61.510 to 61.705 or 78.510 to 78.852 for
26 service with the participating employer for which the retired member is
27 performing volunteer services; and

1 4. Other than the status of volunteer, the retired member does not become
2 an employee, leased employee, or independent contractor of the
3 employer for which he or she is performing volunteer services for a
4 period of at least twenty-four (24) months following the retired
5 member's most recent retirement date.

6 If a retired member, who provided volunteer services with a participating
7 employer under this paragraph violates any provision of this paragraph, then
8 he or she shall be deemed an employee of the participating employer as of the
9 date he or she began providing volunteer services and both the retired member
10 and the participating employer shall be subject to paragraphs (a) to (d) of this
11 subsection for the period of volunteer service; and

12 (f) Notwithstanding any provision of this section, any mayor or member of a city
13 legislative body who has not participated in the County Employees Retirement
14 System prior to retirement, but who is otherwise eligible to retire from the
15 Kentucky Employees Retirement System or the State Police Retirement
16 System, shall not be:

17 1. Required to resign from his or her position as mayor or as a member of
18 the city legislative body in order to begin drawing benefits from the
19 Kentucky Employees Retirement System or the State Police Retirement
20 System; or

21 2. Subject to any provision of this section as it relates solely to his or her
22 service as a mayor or member of the city legislative body.

23 ~~[(18) Notwithstanding any provision of subsections (1) to (7)(a) and (10) to (17) of this~~
24 ~~section, the following shall apply to retired members, retirees, or annuitants of the~~
25 ~~systems or plans administered by the Kentucky Retirement Systems, the Judicial~~
26 ~~Form Retirement System, and the Teachers' Retirement System, who retire and~~
27 ~~begin drawing a retirement allowance on or after January 1, 2019, and are~~
