

1 AN ACT relating to the legislative branch of the Commonwealth of Kentucky.

2 ***Be it enacted by the General Assembly of the Commonwealth of Kentucky:***

3 ➔Section 1. KRS 6.160 is amended to read as follows:

4 (1) The chief clerk of each house shall file and preserve in the office of his house a
5 correct copy of the journal of its proceedings. At the close of each session of the
6 General Assembly, he shall make an inventory of all the books, stationery and
7 furniture belonging to his house, box up all the books, and deliver the books,
8 stationery and furniture to the co-chairmen of the Legislative Research Commission
9 and take a receipt for them.

10 (2) The chief clerk and assistant clerk of each house shall keep an accurate journal of
11 each day's proceedings; do all necessary engrossing of bills; and read and compare
12 enrolled bills.

13 (3) The enrolling clerk shall promptly and accurately enroll all bills delivered to him for
14 that purpose which originated in the house of which he is enrolling clerk.

15 (4) Either house may prescribe additional duties for the chief clerk, assistant clerk or
16 enrolling clerk.

17 **(5) *In remembrance and honor of the founders and the framers of the United States***
18 ***Constitution, the chief clerk shall ensure that each citation, resolution, and each***
19 ***day's journal of proceedings shall have in the appropriate places, "the (insert***
20 ***ordinal number) day of (insert month) in the year of our Lord (insert year)".***

21 ➔Section 2. KRS 6.161 is amended to read as follows:

22 **(1)** The chief clerk of each house shall furnish a correct journal of its proceedings for
23 each day to the Legislative Research Commission as soon as the journal is approved
24 by the house. The Legislative Research Commission shall carefully compare or
25 have compared the proofs of the journals.

26 **(2) *In remembrance and honor of the founders and the framers of the United States***
27 ***Constitution, the chief clerk of each house shall ensure that the journal for each***

1 day has in its appropriate place, "the (insert ordinal number) day of (insert
2 month) in the year of our Lord (insert year)".

3 ➔Section 3. KRS 7.100 is amended to read as follows:

4 It shall be the duty of the Legislative Research Commission to:

- 5 (1) Maintain in the State Capitol or State Capitol Annex for the use and information of
6 the General Assembly, a legislative reference room and working library; collect,
7 summarize, and index information of a legislative and governmental nature relating
8 to legislation and legislative policies and index all bills introduced in the General
9 Assembly. Permanent office space for the Legislative Research Commission and for
10 the director thereof and employees or subcommittees shall be provided on the third
11 floor of the State Capitol. When the General Assembly is not in session, the
12 Commission shall have jurisdiction over the use of the House and Senate chambers
13 and over the allocation of all rooms used by the General Assembly while in session.
14 The Commission may provide for such other office space as it may deem
15 necessary;[-]
- 16 (2) Make or cause to be made such investigations into statute law, legislation,
17 governmental agencies and institutions, and matters of public policy as will aid the
18 General Assembly in performing its duties in the most efficient and economical
19 manner. In making such studies and investigations between the regular sessions of
20 the General Assembly, the Commission shall give priority to those subjects
21 requested by the General Assembly. The Commission shall promptly consider any
22 requests of the General Assembly by bill or resolution for the creation of task
23 forces, committees, subcommittees, or other entities for the purpose of studying or
24 reviewing issues or subjects. Provisions of the bill or resolution to the contrary
25 notwithstanding, the Commission, in its sole discretion, may grant or deny the
26 request to create an entity or alternatively assign the subject matter of the proposed
27 study or review to an existing committee or task force, including interim joint

- 2 (3) Afford to any member of the General Assembly or any committee of either house of
3 the General Assembly such information and assistance as may be practicable in the
4 preparation of bills, memorials, resolutions, amendments, alterations and changes
5 thereto, and revisions and substitutes thereof, proposed to be introduced into the
6 General Assembly;[redacted]
- 7 (4) The Commission, at the close of each legislative session, shall assume custody of
8 all furniture, equipment, records, materials and supplies, and printed copies of bills
9 in the possession of the clerks of the Senate and House. Immediately prior to the
10 convening of the next session, the Commission shall transfer all furniture,
11 equipment, materials, and supplies to the clerks of the respective houses. The
12 Commission may, when the General Assembly is not in session, authorize the
13 expenditure of funds appropriated to the General Assembly for the purchase, repair,
14 or maintenance of furniture, equipment, materials, and supplies and contract for
15 services needed by the General Assembly;[redacted]
- 16 (5) The Commission shall prepare and publish or contract for the preparation and
17 publishing of a daily index and digest of the content of and legislative action on all
18 measures introduced in the General Assembly;[redacted]
- 19 (6) After each election the Commission shall conduct a pre-session orientation
20 conference for members of the General Assembly;[redacted]
- 21 (7) The Commission shall notify the members of the General Assembly of the reports
22 filed with the Commission for distribution to the members of the General Assembly
23 and of the reports and publications of the Commission which are available for the
24 members of the General Assembly. Each member of the General Assembly shall
25 indicate upon a form provided by the Commission which reports shall be forwarded
26 to the member;[redacted]
- 27 (8) Conduct, while the General Assembly is not in session, any and all business of the

1 legislative department of government, except for the passage of legislation, which
2 could be conducted by the legislative department of government or the General
3 Assembly if the General Assembly were in session;[-]

4 (9) Conduct such other business and possess such other powers and duties as may be
5 assigned or authorized by the General Assembly by statute or otherwise; and[-]

6 (10) Ensure that the forms of citations and resolutions produced for use by the
7 General Assembly shall have in the appropriate places, "the (insert ordinal
8 number) day of (insert month) in the year of our Lord (insert year)". This shall
9 include the daily journal of proceedings for each chamber.
