4	(1)	The	cabinet shall[not] permit the off-site disposal of construction or demolition	
5		wast	te at a site <i>initially no larger</i> [less] than one (1) acre <i>if</i> [unless], as a minimum,	
6		the following conditions are imposed:		
7		(a)	The applicant shall provide a written certification that a copy of the	
8			application has been delivered to the governing body of the solid waste	
9			management area and that disposal of construction and demolition waste at	
10			the proposed site will not violate local land use regulations;	
11		(b)	Disposal shall only occur during daylight hours in accordance with a posted	
12			schedule that will allow inspection by local or state officials;	
13		(c)	The applicant shall erect on the site a sign clearly indicating that the site is	
14			permitted for disposal of construction and demolition debris only, and the	
15			operating hours shall appear on the sign along with the applicant's permit	
16			number;	
17		(d)	The cabinet shall establish a schedule for closing and covering the site,	
18			including provisions for intermediate cover when flammable waste is	
19			involved;	
20		(e)	Notwithstanding any other provision of law, the applicant shall not allow the	
21			disposal of tires in a waste disposal facility regulated by this section; and	
22		(f)	The cabinet shall require the applicant to post a bond in the amount of ten	
23			thousand dollars (\$10,000) to insure compliance with the conditions of the	
24			permit.	
25	(2)	<u>Upo</u>	n request of the applicant, the cabinet may increase the size of a construction	
26		or demolition waste site permitted under subsection (1) of this section to a total of		
27	no more than two (2) acres if the applicant:

1	(a) Is compliant with all permit requirements for the currently permitted
2	construction or demolition waste disposal site; and
3	(b) Complies with the requirements of subsection (1) of this section with regard
4	to the additional permitted waste site area, including posting an additional
5	bond with the cabinet in the amount of ten thousand dollars (\$10,000) to
6	insure compliance with the conditions of the permit for the newly permitted
7	<u>area.</u>
8	(3) The cabinet may waive the requirement of subsection (1)(b) of this section, that the
9	hours of operation shall be posted, and the requirements of subsection (1)(c) and (d)
10	of this section, if the cabinet determines that the area of land to be affected, the
11	limited duration of the disposal operation, or the materials to be disposed of do not
12	require imposition of these standards to assure the safety of the public.
13	(4)[(3)] This section shall not apply to beneficial reuse of industrial solid waste.
