2 ~~(4) (a) *By June 1, 2022, the secretary of the Finance and Administration Cabinet*~~

10 ➔Section 2. KRS 132.590 is amended to read as follows:

11 (1) The compensation of the property valuation administrator shall be based on the
 12 schedule contained in subsection (2) of this section as modified by subsection (3) of
 13 this section. The compensation of the property valuation administrator shall be
 14 calculated by the department annually. Should a property valuation administrator for
 15 any reason vacate the office in any year during his term of office, he shall be paid
 16 only for the calendar days actually served during the year.

17 (2) The salary schedule for property valuation administrators provides for nine (9)
 18 levels of salary based upon the population of the county in the prior year as
 19 determined by the United States Department of Commerce, Bureau of the Census
 20 annual estimates. To implement the salary schedule, the department shall, by
 21 November 1 of each year, certify for each county the population group applicable to
 22 each county based on the most recent estimates of the United States Department of
 23 Commerce, Bureau of the Census. The salary schedule provides four (4) steps for
 24 yearly increments within each population group. Property valuation administrators
 25 shall be paid according to the first step within their population group for the first
 26 year or portion thereof they serve in office. Thereafter, each property valuation
 27 administrator, on January 1 of each subsequent year, shall be advanced

1 automatically to the next step in the salary schedule until the maximum salary figure
 2 for the population group is reached. If the county population as certified by the
 3 department increases to a new group level, the property valuation administrator's
 4 salary shall be computed from the new group level at the beginning of the next year.
 5 A change in group level shall have no affect on the annual change in step. Prior to
 6 assuming office, any person who has previously served as a property valuation
 7 administrator must certify to the department the total number of years, not to exceed
 8 four (4) years, that the person has previously served in the office. The department
 9 shall place the person in the proper step based upon a formula of one (1)
 10 incremental step per full calendar year of service:

- 5 (3) (a) For calendar year 2000, the salary schedule in subsection (2) of this section
6 shall be increased by the amount of increase in the annual consumer price
7 index as published by the United States Department of Commerce for the year
8 ended December 31, 1999. This salary adjustment shall take effect on July 14,
9 2000, and shall not be retroactive to the preceding January 1.
- 10 (b) For each calendar year beginning after December 31, 2000, upon publication
11 of the annual consumer price index by the United States Department of
12 Commerce, the annual rate of salary for the property valuation administrator
13 shall be determined by applying the increase in the consumer price index to
14 the salary in effect for the previous year. This salary determination shall be
15 retroactive to the preceding January 1.
- 16 (c) In addition to the step increases based on service in office, each property
17 valuation administrator shall be paid an annual incentive of six hundred
18 eighty-seven dollars and sixty-seven cents (\$687.67) per calendar year for
19 each forty (40) hour training unit successfully completed based on continuing
20 service in that office and, except as provided in this subsection, completion of
21 at least forty (40) hours of approved training in each subsequent calendar year.
22 If a property valuation administrator fails without good cause, as determined
23 by the commissioner of the department, to obtain the minimum amount of
24 approved training in any year, the officer shall lose all training incentives
25 previously accumulated. No property valuation administrator shall receive
26 more than one (1) training unit per calendar year nor more than four (4)
27 incentive payments per calendar year. Each property valuation administrator

1 shall be allowed to carry forward up to forty (40) hours of training credit into
2 the following calendar year for the purpose of satisfying the minimum amount
3 of training for that year. This amount shall be increased by the consumer price
4 index adjustments prescribed in paragraphs (a) and (b) of this subsection.
5 Each training unit shall be approved and certified by the department. Each unit
6 shall be available to property valuation administrators in each office based on
7 continuing service in that office. The department shall promulgate
8 administrative regulations in accordance with KRS Chapter 13A to establish
9 guidelines for the approval and certification of training units.

10 (4) Notwithstanding any provision contained in this section, no property valuation
11 administrator holding office on July 14, 2000, shall receive any reduction in salary
12 or reduction in adjustment to salary otherwise allowable by the statutes in force on
13 July 14, 2000.

14 (5) Deputy property valuation administrators and other authorized personnel may be
15 advanced one (1) step in grade upon completion of twelve (12) months' continuous
16 service. The department may make grade classification changes corresponding to
17 any approved for department employees in comparable positions, so long as the
18 changes do not violate the integrity of the classification system. Subject to
19 availability of funds, the department may extend cost-of-living increases approved
20 for department employees to deputy property valuation administrators and other
21 authorized personnel, by advancement in grade.

22 (6) Beginning with the 1990-1992 biennium, the department shall prepare a biennial
23 budget request for the staffing of property valuation administrators' offices. An
24 equitable allocation of employee positions to each property valuation administrator's
25 office in the state shall be made on the basis of comparative assessment work units.
26 Assessment work units shall be determined from the most current objective
27 information available from the United States Bureau of the Census and other similar

1 sources of unbiased information. Beginning with the 1996-1998 biennium,
2 assessment work units shall be based on parcel count per employee. The total sum
3 allowed by the state to any property valuation administrator's office as
4 compensation for deputies, other authorized personnel, and for other authorized
5 expenditures shall not exceed the amount fixed by the department. However, each
6 property valuation administrator's office shall be allowed as a minimum such funds
7 that are required to meet the federal minimum wage requirements for two (2) full-
8 time deputies.

9 (7) Beginning with the 1990-1992 biennium each property valuation administrator shall
10 submit by June 1 of each year for the following fiscal year to the department a
11 budget request for his office which shall be based upon the number of employee
12 positions allocated to his office under subsection (6) of this section and upon the
13 county and city funds available to his office and show the amount to be expended
14 for deputy and other authorized personnel including employer's share of FICA and
15 state retirement, and other authorized expenses of the office. The department shall
16 return to each property valuation administrator, no later than July 1, an approved
17 budget for the fiscal year.

18 (8) Each property valuation administrator may appoint any persons approved by the
19 department to assist him in the discharge of his duties. Each deputy shall be more
20 than twenty-one (21) years of age and may be removed at the pleasure of the
21 property valuation administrator. The salaries of deputies and other authorized
22 personnel shall be fixed by the property valuation administrator in accordance with
23 the grade classification system established by the department and shall be subject to
24 the approval of the department. The Personnel Cabinet shall provide advice and
25 technical assistance to the department in the revision and updating of the personnel
26 classification system, which shall be equitable in all respects to the personnel
27 classification systems maintained for other state employees. Any deputy property

1 valuation administrator employed or promoted to a higher position may be
 2 examined by the department in accordance with standards of the Personnel Cabinet,
 3 for the position to which he is being appointed or promoted. No state funds
 4 available to any property valuation administrator's office as compensation for
 5 deputies and other authorized personnel or for other authorized expenditures shall
 6 be paid without authorization of the department prior to the employment by the
 7 property valuation administrator of deputies or other authorized personnel or the
 8 incurring of other authorized expenditures.

9 (9) Each county fiscal court shall annually appropriate and pay each fiscal year to the
 10 office of the property valuation administrator as its cost for use of the assessment, as
 11 required by KRS 132.280, an amount determined as follows:

25 (10) The total sum to be paid by the fiscal court to any property valuation administrator's
 26 office under the provisions of subsection (9) of this section shall not exceed the
 27 limits set forth in the following table:

12 This allowance shall be based on the assessment as of the previous January 1 and
 13 shall be used for deputy and other personnel allowance, supplies, maps and
 14 equipment, travel allowance for the property valuation administrator and his
 15 deputies and other authorized personnel, and other authorized expenses of the
 16 office.

17 (11) Annually, after appropriation by the county of funds required of it by subsection (9)
 18 of this section, and no later than August 1, the property valuation administrator shall
 19 file a claim with the county for that amount of the appropriation specified in his
 20 approved budget for compensation of deputies and assistants, including employer's
 21 shares of FICA and state retirement, for the fiscal year. The amount so requested
 22 shall be paid by the county into the State Treasury by September 1, or paid to the
 23 property valuation administrator and be submitted to the State Treasury by
 24 September 1. These funds shall be expended by the department only for
 25 compensation of approved deputies and assistants and the employer's share of FICA
 26 and state retirement in the appropriating county. Any funds paid into the State
 27 Treasury in accordance with this provision but unexpended by the close of the fiscal

1 year for which they were appropriated shall be returned to the county from which
2 they were received.

3 (12) After submission to the State Treasury or to the property valuation administrator of
4 the county funds budgeted for personnel compensation under subsection (11) of this
5 section, the fiscal court shall pay the remainder of the county appropriation to the
6 office of the property valuation administrator on a quarterly basis. Four (4) equal
7 payments shall be made on or before September 1, December 1, March 1, and June
8 1 respectively. Any unexpended county funds at the close of each fiscal year shall
9 be retained by the property valuation administrator, except as provided in KRS
10 132.601(2). During county election years the property valuation administrator shall
11 not expend in excess of forty percent (40%) of the allowances available to his office
12 from county funds during the first five (5) months of the fiscal year in which the
13 general election is held.

14 (13) The provisions of this section shall apply to urban-county governments and
15 consolidated local governments. In an urban-county government and a consolidated
16 local government, all the rights and obligations conferred on fiscal courts or
17 consolidated local governments by the provisions of this section shall be exercised
18 by the urban-county government or consolidated local government.

19 (14) When an urban-county form of government is established through merger of
20 existing city and county governments as provided in KRS Chapter 67A or when a
21 consolidated local government is established through merger of existing city and
22 county governments as provided by KRS Chapter 67C, the annual county
23 assessment shall be presumed to have been adopted as if the city had exercised the
24 option to adopt as provided in KRS 132.285. For purposes of this subsection, the
25 amount to be considered as the assessment for purposes of KRS 132.285 shall be
26 the amount subject to taxation for full urban services.

27 (15) Notwithstanding the provisions of subsection (9) of this section, the amount

1 appropriated and paid by each county fiscal court to the office of the property
 2 valuation administrator for 1996 and subsequent years shall be equal to the amount
 3 paid to the office of the property valuation administrator for 1995, or the amount
 4 required by the provisions of subsections (9) and (10) of this section, whichever is
 5 greater.

6 **(16) Notwithstanding this section or any other Kentucky Revised Statute to the**
 7 **contrary, the total compensation for the office of the property valuation**
 8 **administrator in an urban-county government shall be \$420,000 per year.**

9 ➔SECTION 3. A NEW SECTION OF KRS CHAPTER 164 IS CREATED TO
 10 READ AS FOLLOWS:

11 **(1) The Kentucky Center for Cannabis**[Research]**is hereby established at the**
 12 **University of Kentucky to advance the study of the use of cannabis and cannabis**
 13 **derivatives for the treatment of certain medical conditions and diseases as**
 14 **indicated and recommended by the center's advisory board.**

15 **(2) The role and mission of the center shall be to:**

16 **(a) Conduct and fund research related to cannabis and cannabis derivatives**[**
 17 **including pharmaceutical development and the efficacies of cannabis and**
 18 **cannabis derivatives for the treatment of certain medical conditions and**
 19 **diseases]**:**

20 **(b) Conduct and fund research related to the health effects, including the**
 21 **potential risks or side effects, of the use of cannabis and cannabis**
 22 **derivatives;**

23 **(c) Conduct and fund research related to the efficacy and potential health**
 24 **effects of various cannabis delivery methods, including but not limited to**
 25 **vaporizing, ingestibles, topical applications, and combustion;**

26 **(d) Review current and future cannabis research literature, clinical studies,**
 27 **and clinical trials;**

1 (e) Monitor, to the extent that appropriate and sufficient data are available,
 2 patient outcomes in states with medicinal cannabis programs; and

3 (f) Examine, to the extent that sufficient data are available, the health effects
 4 of the use of combustible cannabis.

5 (3) The university shall:

6 (a) Develop and maintain the center in accordance with its administrative and
 7 governing regulations related to the formation of multidisciplinary research
 8 centers and institutes;

9 (b) Establish an internal advisory board to oversee the activities, research
 10 agenda, and finances of the center. Members of the advisory board shall be
 11 appointed by the president of the University of Kentucky**[~~and may~~
 12 include:

13 1. The director of the University of Kentucky Center for Cannabis
 14 Research;

15 2. The director of the University of Kentucky Center on Drug and
 16 Alcohol Research;

17 3. The dean of the University of Kentucky College of Agriculture, Food
 18 and Environment or his or her designee;

19 4. The dean of the University of Kentucky College of Pharmacy or his or
 20 her designee;

21 5. The dean of the University of Kentucky College of Medicine or his or
 22 her designee;

23 6. Physicians who are licensed by the Kentucky Board of Medical
 24 Licensure and who are certified by the appropriate board in the
 25 following specialties:

26 a. Oncology;

27 b. Pain and addiction medicine;

- 1 ~~e.—Neurology;~~
- 2 ~~d.—Psychiatry; and~~
- 3 ~~e.—Ophthalmology;~~
- 4 ~~7.—Researchers from a college or university that currently conducts~~
- 5 ~~cannabis research or that receives funds from the center pursuant to~~
- 6 ~~subsection (5) of this section, if any; and~~
- 7 ~~8.—Any other individual appointed at the discretion of the president of the~~
- 8 ~~University of Kentucky]**;~~
- 9 (c) Report to the secretary of the Cabinet for Health and Family Services and
- 10 the Legislative Research Commission by September 1 each year for the
- 11 preceding fiscal year, outlining the center's activities and expenditures; and
- 12 (d) Ensure that the center complies with subsection (4) of this section.
- 13 (4) The center shall:
- 14 (a) Employ a director and necessary staff;
- 15 (b) Seek, accept, and expend gifts, grants, or donations from private or public
- 16 sources to support the role and mission of the center;
- 17 (c) Conduct clinical research, clinical studies, and clinical trials as approved by
- 18 appropriate federal agencies;
- 19 (d) Establish an application for individuals interested in participating in
- 20 cannabis-related clinical research, clinical studies, or clinical trials and a
- 21 screening protocol to place interested applicants in appropriate research
- 22 participant pools;
- 23 (e) Publicly disseminate the research conducted or funded by the center;
- 24 (f) Host an annual cannabis research symposium; and
- 25 (g) Notwithstanding any provision of law to the contrary, and upon request
- 26 from the Cabinet for Health and Family Services, enter into a
- 27 memorandum of understanding with the cabinet for data collected by the

- 1 center or any researcher associated with or funded by the center.
- 2 (5) (a) The center may award research funds to any nonprofit Kentucky-based
3 research entity or any Kentucky institution of higher education and any
4 research entity association with such an institution.
- 5 (b) If the center awards research funds to any other entity, the center shall use
6 an open, competitive grant application process using national best practices.
- 7 (c) Any entity or institution that receives research funds from the center shall
8 present the results of its research at the center's annual research
9 symposium in the year after the research is concluded and shall, upon
10 request from the center, present an update on any ongoing research at the
11 center's annual research symposium if the research has not concluded.
- 12 (6) The application developed pursuant to subsection (4)(d) of this section shall be
13 made publicly available on the center's Web site.
- 14 (7) The university, the center, and any researcher or staff employed by, associated
15 with, or funded by the center or the university shall immediately notify the
16 Cabinet for Health and Family Services and the Legislative Research
17 Commission of any imminent or serious public health risk, or potentially
18 imminent or serious public health risk, associated with cannabis identified as
19 part of a research project associated with or approved by the center or the
20 university's internal review board.
- 21 (8) If at any time the Commonwealth establishes a medicinal cannabis program, the
22 application to receive a medicinal cannabis card shall include a question asking
23 whether the patient is interested in participating in clinical research conducted by
24 the center. If the patient indicates his or her interest in participating in the
25 center's research, the department or state agency responsible for approving
26 medicinal cannabis cards is authorized to share the patient's name, phone
27 number, and address with the center.

4 ➔SECTION 4. A NEW SECTION OF KRS CHAPTER 210 IS CREATED TO
 5 READ AS FOLLOWS:

6 (1) As used in this section:

7 (a) "Cabinet" means the Cabinet for Health and Family Services;

8 (b) "CMHC" means a community mental health center;

9 (c) "Fund" means the mobile crisis services fund; and

10 (d) "Mobile unit" means any vehicle which a CMHC uses to travel within its
 11 region to provide community services for Kentuckians who experience
 12 issues with mental health, developmental and intellectual disabilities, and
 13 substance use disorder.

14 (2) (a) The mobile crisis services fund is hereby established within the cabinet to
 15 provide loans to CMHCs for:

16 1. Increasing access to mental health services; and

17 2. Providing services to individuals who lack sufficient access to
 18 transportation and who are:

19 a. Residing in rural areas;

20 b. Residing in homeless shelters; or

21 c. Disadvantaged mentally, physically, or economically.

22 (b) Any loan issued by the cabinet shall not exceed a five (5) year term and the
 23 interest rate shall not exceed one percent (1%).

24 (3) The cabinet shall:

25 (a) Determine the terms and conditions of each loan, including the repayment
 26 to be deposited back in the fund for issuance of future loans to other
 27 CMHCs;

- 1 (b) Review and adjudicate applications submitted by CMHCs that apply for a
2 loan;
- 3 (c) Monitor the performance of each CMHC in the program; and
- 4 (d) By December 1, 2022, and by each December 1 thereafter, report to the
5 Interim Joint Committee on Health, Welfare, and Family Services
6 information about each CMHC in the program, including:
- 7 1. The name and location of each CMHC that received a loan;
8 2. The amount of principal originally loaned; and
9 3. How each CMHC used the funds.
- 10 (4) In order to apply for loan, a CMHC shall:
- 11 (a) Submit an application to the cabinet;
- 12 (b) Agree to use the funds for the purchase, operation, or establishment of
13 mobile units; and
- 14 (c) Agree to provide services to individuals who lack sufficient access to
15 transportation and who are:
- 16 1. Residing in rural areas;
17 2. Residing in homeless shelters; or
18 3. Disadvantaged mentally, physically, or economically.
- 19 (5) (a) The fund created in subsection (2) of this section shall be a trust and agency
20 account.
- 21 (b) The fund shall be administered by the cabinet.
- 22 (c) The fund shall include moneys appropriated by the General Assembly,
23 contributions, donations, gifts, or federal funds.
- 24 (d) Moneys in the fund shall be used by the cabinet to administer this section.
- 25 (e) Notwithstanding KRS 45.229, any moneys remaining in the fund at the
26 close of the fiscal year shall not lapse but shall be carried forward into the
27 succeeding fiscal year.

1 (f) Interest earned on any moneys in the fund shall accrue to the fund.

2 (g) Moneys deposited in the fund are hereby appropriated for the sole purpose
 3 of providing loans to CMHCs.

4 (6) The appropriation provided by the General Assembly for fiscal years 2022-2023
 5 and 2023-2024 for mobile crisis services shall be considered startup funds to
 6 support the establishment of additional mobile crisis units and shall only be
 7 appropriated once.

8 (7) The Cabinet for Health and Family Services may promulgate administrative
 9 regulations in accordance with KRS Chapter 13A to implement this section.

10 ➔Section 5. KRS 262.330 is amended to read as follows:

11 (1) The board may make available or lease, on such terms as it prescribes, to
 12 landowners and occupiers within the district, agricultural and engineering
 13 machinery and equipment, including heavy or specialized equipment**[acquired
 14 pursuant to Section 6 of this Act]**; fertilizer, seeds, seedlings and such other
 15 material or equipment as will assist the landowners and occupiers to carry on
 16 operations upon their lands for the conservation of soil resources and for the
 17 prevention and control of soil erosion.

18 (2) As a condition to the extending of any benefits under this chapter to, or the
 19 performance of work upon, any lands not owned or controlled by this state or any of
 20 its agencies, the board may require contributions in money, services, materials or
 21 otherwise to any operations conferring such benefits, and require landowners and
 22 occupiers to enter into and perform such agreements or covenants as to the
 23 permanent use of their lands as will tend to prevent or control erosion.

24 ➔Section 6. KRS 262.610 is amended to read as follows:

25 (1) (a) The Soil and Water Conservation Commission as referred to in KRS Chapter
 26 146, subject to the supervision of the commissioner of the Department for
 27 Natural Resources~~[for natural resources]~~, to the restrictions provided in

1 Section 5 of this Act and KRS 262.610 to 262.660, and to the requirements of
 2 KRS Chapters 42 and 45A, is hereby authorized to acquire and to make
 3 available, or to assist in acquiring or making available to soil and water
 4 conservation districts, heavy or specialized equipment or infrastructure which
 5 an individual district cannot itself economically obtain.
