6	The Government Resources Accelerating Needed Transformation Program of 2024 is
7	intended exclusively for the federal grants identified by the Interagency Working
8	Group on Coal and Power Plant Communities and Economic Revitalization
9	established by Presidential Executive Order 14008, issued on January 27, 2021.
10	→SECTION 2. A NEW SECTION OF KRS CHAPTER 246 IS CREATED TO
11	READ AS FOLLOWS:
12	As used in Sections 1 to 8 of this Act:
13	(1) "Commission" means the GRANT Commission established in Section 8 of this
14	Act.
15	(2) "County population ranking" means the score of each county determined by
16	department under subsection (7) of Section 5 of this Act;
17	(3) "Department" means the Department of Agriculture;
18	(4) "Eligible grant recipient" means a grant applicant that is a county or city
19	governing body or nonprofit charitable organization organized under 26 U.S.C.
20	sec. 501(c)(3) and engaged in public benefit improvements;
21	(5) ''Eligible project'' means a project that:
22	(a) Benefits the public or substantially benefits the public and satisfies the
23	evaluation criteria in Section 5 of this Act and that is initiated on:
24	1. Publicly owned property;
25	2. Property to be acquired, which comes with either a:
26	a. Legally binding letter of intent or option for the sale to an
27	eligible grant recipient; or

1	b. Legally binding sale agreement for the sale to an eligible grant
2	recipient; or
3	3. Private property on which a project is located that is in the public
4	interest and for a public purpose and that benefits an eligible
5	community; and
6	(b) Requires local matching funds based on the county population ranking as
7	provided in Section 5 of this Act;
8	(6) "Eligible use" means the authorized purpose for which an awarded grant may be
9	used depending on the source of funds from the Commonwealth;
10	(7) "Interagency Working Group" means the Interagency Working Group on Coal
11	and Power Plant Communities and Economic Revitalization established by
12	Presidential Executive Order 14008, issued on January 27, 2021;
13	(8) "Population density":
14	(a) Means the number of persons per square mile of a county;
15	(b) Is calculated by dividing the total county population by the square miles in
16	the county;
17	(c) Is determined by using the population estimate from the most recent
18	available five (5) year American Community Survey as published by the
19	United States Census Bureau; and
20	(d) Is used to rank each county in descending order, with the county having the
21	largest population density receiving a rank of one (1) and the county with
22	the smallest population density receiving a rank of one hundred twenty
23	<u>(120);</u>
24	(9) ''Regional project'' means an eligible project that is proposed by eligible grant
25	recipients residing or having a primary business address in different counties in
26	this Commonwealth who submit a single grant application; and
27	(10) 'Ten (10) year percentage change in population':

1	(a) Means the percentage change in population within a county;
2	(b) Is determined by comparing the population estimate from the most recent
3	available five (5) year American Community Survey as published by the
4	United States Census Bureau to the same survey ten (10) years prior to the
5	most recent available survey; and
6	(c) Is used to rank each county in descending order, with the county having the
7	largest positive percentage change in population receiving a rank of one (1)
8	and the county with the largest negative percentage change receiving a rank
9	of one hundred twenty (120).
10	→SECTION 3. A NEW SECTION OF KRS CHAPTER 246 IS CREATED TO
11	READ AS FOLLOWS:
12	(1) The Government Resources Accelerating Needed Transformation Program of
13	2024 is hereby established under the department, subject to the approval of the
14	commission established in Section 8 of this Act. The department's administration
15	of the program includes but is not limited to the following:
16	(a) Creating and making available a standardized grant application and a
17	regional grant application for the obligation of state funds under Sections 1
18	to 8 of this Act to apply for matching federal funds;
19	(b) Developing a standardized scoring system pursuant to this section and
20	Section 5 of this Act;
21	(c) Reviewing and processing the applications submitted by the proposed
22	eligible grant recipients to the department;
23	(d) Verifying and determining whether a match applicant is an eligible grant
24	recipient that is seeking a federal grant for an eligible project;
25	(e) Evaluating the project proposed by the match application in accordance
26	with the evaluation criteria set forth in this section and Section 5 of this
27	\underline{Act} ;

1		(f) Scoring each match application pursuant to the scoring system described in
2		Section 5 of this Act;
3		(g) Ranking each match application:
4		1. To prioritize the greatest return on investment and relative positive
5		impact of the eligible project; and
6		2. Based on the project evaluation and the project score described in this
7		section and Section 5 of this Act;
8		(h) Compiling a list of proposed match applicants whose eligible project
9		demonstrates a high level of investment potential if a match is provided, as
10		revealed by the evaluation, scoring, and ranking process described in this
11		section and Section 5 of this Act;
12		(i) Providing detailed feedback to the match applicants after the project
13		evaluation and project score are completed and the match application is
14		approved or denied by the department, unless otherwise prohibited by
15		federal or state law;
16		(j) Obligating matching funds to selected eligible grant recipients;
17		(k) Compiling the monthly report to be submitted under Section 7 of this Act;
18		<u>and</u>
19		(l) Compiling the annual report to be submitted under Section 7 of this Act.
20	<u>(2)</u>	The department shall determine the terms, conditions, and requirements of
21		application for match funds awarded from the Government Resources
22		Accelerating Needed Transformation Program of 2024 fund. The department
23		may establish procedures and standards for the review and approval of obligation
24		of match funds through the promulgation of administrative regulations in
25		accordance with KRS Chapter 13A. By December 1, 2024, the department shall
26		submit recommended legislative changes to the Legislative Research Commission
27		for referral to and for consideration by the Senate Standing Committee on

1		Appropriations and Revenue, and the House Standing Committee on
2		Appropriations and Revenue or the Interim Joint Committee on Appropriations
3		and Revenue.
4	<u>(3)</u>	The commissioner of the department shall have the authority to hire staff,
5		contract for services, expend funds, and operate the normal business activities of
6		the Government Resources Accelerating Needed Transformation Program of
7		2024. Notwithstanding KRS Chapter 45A, the department may contract with a
8		third party for implementation and administration of the program.
9	<u>(4)</u>	The Government Resources Accelerating Needed Transformation Program of
10		2024 as provided in Sections 1 to 8 of this Act shall sunset on December 31, 2026,
11		unless authorized by the General Assembly to continue its work for a specified
12		period of time.
13	<u>(5)</u>	The Kentucky Council of Area Development Districts and local area development
14		districts shall assist eligible grant recipients in identifying available federal grant
15		opportunities and preparing federal grant applications and Government
16		Resources Accelerating Needed Transformation Program of 2024 applications.
17		Nothing in this subsection shall prevent any public agency or nonprofit entity
18		from assisting eligible grant recipients in identifying available federal grant
19		opportunities and preparing federal grant applications and Government
20		Resources Accelerating Needed Transformation Program of 2024 applications.
21	<u>(6)</u>	Upon request of the local area development districts, a local public institution in
22		the postsecondary education system as defined in KRS 164.001 shall assist the
23		eligible grant recipients in their area by including but not limited to:
24		(a) Identifying opportunities for federal grants;
25		(b) Rendering supplemental support for federal grant applications on behalf of
26		the communities including but not limited to providing data and analysis for
27		the federal grant application; or

1	(c) Acting as the contact person for the local public institution to the Kentucky
2	Council of Area Development Districts and to the area development district
3	in which the local public institution is located and updating the contact
4	person information.
5	→ SECTION 4. A NEW SECTION OF KRS CHAPTER 246 IS CREATED TO
6	READ AS FOLLOWS:
7	(1) (a) To participate in the Government Resources Accelerating Needed
8	Transformation Program of 2024, grant applicants shall submit either a
9	standardized or a regional application to the department for consideration
10	by the commission.
11	(b) The department shall provide a preliminary evaluation of the application
12	within five (5) business days of receipt of the application. As part of the
13	preliminary evaluation, the department shall consider the following:
14	1. Applicant's eligibility when evaluated against the requirements of the
15	federal grant; and
16	2. Application completeness when evaluated against the requirements of
17	the federal grant.
18	(c) The department shall provide a final decision of approval or denial on the
19	application within twenty-one (21) calendar days of receipt of the
20	application.
21	(2) If a grant application is selected as an eligible match recipient approved under
22	Sections 1 to 8 of this Act, it shall comply with any match agreement and
23	reporting requirements deemed necessary by the department to verify that the
24	awarded funds to go toward an eligible use.
25	(3) If the selected match recipient fails to comply with subsection (2) of this section
26	or uses the awarded match money for any purpose other than an eligible use, the
27	selected eligible match recipient shall forfeit and be liable to the department for

1		the full award amount.
2		→SECTION 5. A NEW SECTION OF KRS CHAPTER 246 IS CREATED TO
3	REA	AD AS FOLLOWS:
4	<u>(1)</u>	The department shall identify and certify the areas for grant funding designated
5		by the Interagency Working Group as a priority for obligation of match funds.
6		Any area in Kentucky that is eligible for federal grant resources, but is not an
7		Interagency Working Group designated community, may be eligible for
8		obligation of state funds under this section. The department shall not approve a
9		project unless it finds that the project is in the public interest and the grant funds
10		will be used for a public purpose. For purposes of this subsection, projects that
11		are in the public interest and for a public purpose can include a derivative private
12		benefit, if the department finds the following:
13		(a) The project will enhance a community or region;
14		(b) The granting entity for which the department's matching grant is being
15		used requires a public purpose for grant eligibility; or
16		(c) The department in its judgment concludes the proposal will enhance the
17		quality of life or services in a community or region.
18	<u>(2)</u>	The department shall evaluate each applicant's eligible project according to the
19		criteria described in this section for the purpose of compiling a recommendation
20		and score for the eligible project pursuant to this section.
21	<u>(3)</u>	If a match applicant is selected as an eligible grant recipient approved under the
22		Government Resources Accelerating Needed Transformation Program of 2024, it
23		shall comply with any incentive agreements and reporting requirements deemed
24		necessary by the department to verify that the awarded grant shall go toward an
25		eligible use.
26	<u>(4)</u>	In the administration of the Government Resources Accelerating Needed
27		Transformation Program of 2024, the department shall develop a scoring system

1	•	for i	the project proposed by each match applicant based on the total projected
2		<u>retu</u>	rn on investment and the relative positive impact in the community.
3	<u>(5)</u>	The	scoring system shall include a:
4		<u>(a)</u>	Score in each category as specified in subsection (6) of this section; and
5		<u>(b)</u>	Total weighted score, which is the average of the scores in each category.
6	<u>(6)</u>	The	scoring categories shall include but are not limited to:
7		<u>(a)</u>	Projected return on investment the project will yield, which includes an
8			assessment of the:
9			1. Likelihood of project completion both with the department's funding
10			and without;
11			2. Application content when evaluated against the federal grant
12			program's publicly available scoring rubric or evaluation criteria, if
13			any;
14			3. Projected gross economic impact of the proposed project on the
15			community;
16			4. Projected number of jobs created by the proposed project and
17			subsequent impact on the community;
18			5. Determination of the cost of the project based on the cost expended by
19			the department if it obligates the requested grant amount to the
20			applicant;
21			6. Evidence of community support for the project;
22			7. Likelihood that the applicant can successfully manage the federal
23			grant's administration requirements; and
24			8. Likelihood of success based on a federal agency prioritization of a
25			particular applicant; and
26		<u>(b)</u>	Overall positive impact the project will have on the surrounding community
27			as evidenced by clear and feasible projected outcomes of the grant-funded

1		project.
2	(7) (a)	On or before May 1, 2024, and not later than May 1 every two (2) years
3		thereafter, the department shall determine a county population ranking for
4		each county by adding the following two (2) factors:
5		1. The population density ranking; and
6		2. The ten (10) year percentage change in population ranking.
7	<u>(b)</u>	The required local match for each county shall be as follows:
8		1. Eligible projects in counties where the county population ranking is
9		greater than or equal to one hundred ninety-three (193) shall provide
10		a minimum amount of local matching funds equal to one percent (1%)
11		of the state match;
12		2. Eligible project in counties where the county population ranking is
13		less than one hundred ninety-three (193) but greater than or equal to
14		one hundred forty-five (145) shall provide a minimum amount of local
15		matching funds equal to two percent (2%) of the state match;
16		3. Eligible project in counties where the county population ranking is
17		less than one hundred forty-five (145) but greater than or equal to
18		ninety-seven (97) shall provide a minimum amount of local matching
19		funds equal to three percent (3%) of the state match;
20		4. Eligible project in counties where the county population ranking is
21		less than ninety-seven (97) but greater than or equal to forty-nine (49)
22		shall provide a minimum amount of local matching funds equal to
23		four percent (4%) of the state match; and
24		5. Eligible project in counties where the county population ranking is
25		less than forty-nine (49) shall provide a minimum amount of local
26		matching funds equal to five percent (5%) of the state match.
2.7	(c)	On or before November 1, 2024, and no later than November 1 every two (2)

1		years thereafter, the department shall report to the Legislative Research

13	<u>(b)</u>	A county that is an eligible grant recipient involved in a regional project
14		shall provide that county's local matching funds based on the county
15		population ranking determined under subsection (7) of this section and
16		each county's local matching funds may be pooled as described in
17		paragraph (a) of this subsection.
18	(9) Beg	inning no later than November 1, 2024, and annually thereafter until the
19	<u>auth</u>	norized appropriation is spent or returned, the department shall compile and
20	<u>subi</u>	mit a report for each application approved by the GRANT Commission
21	<u>esta</u>	blished in Section 8 of this Act for the for the Government Resources
22	Acc	elerating Needed Transformation Program of 2024. The report shall be
23	<u>elec</u>	tronically delivered to the Legislative Research Commission and the Interim
24	<u>Join</u>	nt Committee on Appropriations and Revenue and contain the following

1		(b) The date the application was approved by the GRANT Commission;

4		(e) The round of funding for which each project received approval.
5	<u>(10)</u>	The Government Resources Accelerating Needed Transformation Program of
6		2024 shall begin April 15, 2024. The department shall begin accepting
7		applications for the program on May 15, 2024.
