3	→SECTION 1. A NEW SECTION OF KRS CHAPTER 158 IS CREATED TO

6	(a) "Designated terrorist organization" means an organization that has been
7	designated as a terrorist organization under the Immigration and
8	Nationality Act, 8 U.S.C. sec. 1189;
9	(b) "Material support or resources" has the same meaning as in 18 U.S.C. sec.
10	2339A; and
11	(c) "School" means a public school or public charter school located in
12	Kentucky.
13	(2) A school shall act to protect its Jewish students from credible threats of violence
14	or violence motivated by antisemitism.
15	(3) (a) A school or student organization affiliated with a school shall not provide
16	material support or resources to a designated terrorist organization.
17	(b) If a school determines that an affiliated student organization has provided
18	material support or resources to a designated terrorist organization, the
19	school shall submit a report to the proper authorities and the school shall
20	defund and disband the student organization.
21	→SECTION 2. A NEW SECTION OF KRS CHAPTER 164 IS CREATED TO
22	READ AS FOLLOWS:
23	(1) As used in this section:
24	(a) "Designated terrorist organization" means an organization that has been
25	designated as a terrorist organization under the Immigration and
26	Nationality Act, 8 U.S.C. sec. 1189;
27	(b) "Institution" means a public postsecondary institution and includes all

6	(d) "Public funds" has the same meaning as in KRS 446.010.
7	(2) (a) An institution shall act to protect its Jewish students from credible threats of
8	violence or violence motivated by antisemitism.
9	(b) Notwithstanding any statute to the contrary, the General Assembly shall not
10	appropriate any public funds to an institution that the General Assembly
11	determines has not acted to protect its Jewish students from credible threats
12	of violence or violence motivated by antisemitism.
13	(3) An institution or student or faculty organization of the institution shall not
14	provide material support or resources to a designated terrorist organization. If an
15	institution determines that a student or faculty organization has provided
16	material support or resources to a designated terrorist organization, the
17	institution shall:
18	(a) Submit a report to the proper authorities;
19	(b) Defund the student or faculty organization; and
20	(c) Terminate the student or faculty organization's registration or affiliation
21	with the institution.
22	→SECTION 3. A NEW SECTION OF KRS CHAPTER 61 IS CREATED TO
23	READ AS FOLLOWS:
24	In addition to considerations of unlawful discrimination on the basis of race, religion,
25	or natural origin, if there is an allegation that an unlawful discriminatory conduct or
26	practice is targeting an individual or group based on any actual or perceived
27	connection to any aspect of Jewish identity, a law enforcement officer shall also
