

1 AN ACT relating to exemptions for disaster response businesses and employees.

2 ***Be it enacted by the General Assembly of the Commonwealth of Kentucky:***

3 ➔Section 1. KRS 141.010 is amended to read as follows:

4 As used in this chapter, for taxable years beginning on or after January 1, 2018:

5 (1) "Adjusted gross income," in the case of taxpayers other than corporations, means  
6 the amount calculated in KRS 141.019;

7 (2) "Captive real estate investment trust" means a real estate investment trust as defined  
8 in Section 856 of the Internal Revenue Code that meets the following requirements:

9 (a) 1. The shares or other ownership interests of the real estate investment trust  
10 are not regularly traded on an established securities market; or

11 2. The real estate investment trust does not have enough shareholders or  
12 owners to be required to register with the Securities and Exchange  
13 Commission;

14 (b) 1. The maximum amount of stock or other ownership interest that is owned  
15 or constructively owned by a corporation equals or exceeds:

16 a. Twenty-five percent (25%), if the corporation does not occupy  
17 property owned, constructively owned, or controlled by the real  
18 estate investment trust; or

19 b. Ten percent (10%), if the corporation occupies property owned,  
20 constructively owned, or controlled by the real estate investment  
21 trust.

22 The total ownership interest of a corporation shall be determined by  
23 aggregating all interests owned or constructively owned by a  
24 corporation; and

25 2. For the purposes of this paragraph:

26 a. "Corporation" means a corporation taxable under KRS 141.040,  
27 and includes an affiliated group as defined in KRS 141.200, that is

1 required to file a consolidated return pursuant to KRS 141.200;  
2 and

3 b. "Owned or constructively owned" means owning shares or having  
4 an ownership interest in the real estate investment trust, or owning  
5 an interest in an entity that owns shares or has an ownership  
6 interest in the real estate investment trust. Constructive ownership  
7 shall be determined by looking across multiple layers of a  
8 multilayer pass-through structure; and

9 (c) The real estate investment trust is not owned by another real estate investment  
10 trust;

11 (3) "Commissioner" means the commissioner of the department;

12 (4) "Corporation" has the same meaning as in Section 7701(a)(3) of the Internal  
13 Revenue Code;

14 (5) "Critical infrastructure" means property and equipment owned or used by  
15 communications networks, electric generation, transmission or distribution  
16 systems, gas distribution systems, or water or wastewater pipelines that service  
17 multiple customers or citizens, including but not limited to real and personal  
18 property such as buildings, offices, lines, poles, pipes, structures, or equipment;

19 (6) "Declared state disaster or emergency" means a disaster or emergency event for  
20 which:

21 (a) The Governor has declared a state of emergency pursuant to KRS 39A.100;

22 or

23 (b) A presidential declaration of a federal major disaster or emergency has  
24 been issued;

25 (7) "Department" means the Department of Revenue;

26 (8) ~~((6))~~ "Dependent" means those persons defined as dependents in the Internal  
27 Revenue Code;

1 (9) "Disaster or emergency-related work" means repairing, renovating, installing,  
 2 building, or rendering services that are essential to the restoration of critical  
 3 infrastructure that has been damaged, impaired, or destroyed by a declared state  
 4 disaster or emergency;

5 (10) "Disaster response business" means any entity:

6 (a) That has no presence in the state and conducts no business in the state,  
 7 except for disaster or emergency-related work during a disaster response  
 8 period;

9 (b) Whose services are requested by a registered business or by a state or local  
 10 government for purposes of performing disaster or emergency-related work  
 11 in the state during a disaster response period; and

12 (c) That has no registrations, tax filings, or nexus in this state other than  
 13 disaster or emergency-related work during the calendar year immediately  
 14 preceding the declared state disaster or emergency;

15 (11) "Disaster response employee" means an employee who does not work or reside in  
 16 the state, except for disaster or emergency-related work during the disaster  
 17 response period;

18 (12) "Disaster response period" means a period that begins ten (10) days prior to the  
 19 first day of the Governor's declaration under KRS 39A.100, or the President's  
 20 declaration of a federal major disaster or emergency, whichever occurs first, and  
 21 that extends thirty (30) calendar days after the declared state disaster or  
 22 emergency;

23 (13)~~(7)~~ "Doing business in this state" includes but is not limited to:

- 24 (a) Being organized under the laws of this state;
- 25 (b) Having a commercial domicile in this state;
- 26 (c) Owning or leasing property in this state;
- 27 (d) Having one (1) or more individuals performing services in this state;

- 1 (e) Maintaining an interest in a pass-through entity doing business in this state;
- 2 (f) Deriving income from or attributable to sources within this state, including
- 3 deriving income directly or indirectly from a trust doing business in this state,
- 4 or deriving income directly or indirectly from a single-member limited
- 5 liability company that is doing business in this state and is disregarded as an
- 6 entity separate from its single member for federal income tax purposes; or
- 7 (g) Directing activities at Kentucky customers for the purpose of selling them
- 8 goods or services.

9 Nothing in this subsection shall be interpreted in a manner that goes beyond the

10 limitations imposed and protections provided by the United States Constitution or

11 Pub. L. No. 86-272;

13 Revenue Code;

15 Revenue Code;

16 ~~(16)~~~~(10)~~ "Fiduciary" has the same meaning as in Section 7701(a)(6) of the Internal

- 19 (a) A national bank organized as a body corporate and existing or in the process

- 22 1997, exclusive of any amendments made subsequent to that date;

- 24 state, except a banker's bank organized under KRS 286.3-135;

6 established after December 31, 1997, that meets the requirements of 12 U.S.C.  
7 sec. 3101 in effect on December 31, 1997;

8 ~~(18)~~~~(12)~~ "Fiscal year" has the same meaning as in Section 7701(a)(24) of the Internal  
9 Revenue Code;

10 ~~(19)~~~~(13)~~ "Gross income":

11 (a) In the case of taxpayers other than corporations, has the same meaning as in  
12 Section 61 of the Internal Revenue Code; and

13 (b) In the case of corporations, means the amount calculated in KRS 141.039;

20 withholding exemptions claimed in a withholding exemption certificate in effect  
21 under KRS 141.325, except that if no such certificate is in effect, the number of  
22 withholding exemptions claimed shall be considered to be zero;

23 ~~(27)~~~~(21)~~ "Part-year resident" means any individual that has established or abandoned  
24 Kentucky residency during the calendar year;

25 ~~(28)~~~~(22)~~ "Pass-through entity" means any partnership, S corporation, limited liability  
26 company, limited liability partnership, limited partnership, or similar entity  
27 recognized by the laws of this state that is not taxed for federal purposes at the

1 entity level, but instead passes to each partner, member, shareholder, or owner their  
2 proportionate share of income, deductions, gains, losses, credits, and any other  
3 similar attributes;

4 ~~(29)~~~~(23)~~ "Payroll period" has the same meaning as in Section 3401(b) of the Internal  
5 Revenue Code;

6 ~~(30)~~~~(24)~~ "Person" has the same meaning as in Section 7701(a)(1) of the Internal  
7 Revenue Code;

8 **(31) "Registered business" means a business entity that owns or otherwise possesses**  
9 **critical infrastructure and that is registered to do business in the state prior to the**  
10 **declared state disaster or emergency;**

11 ~~(32)~~~~(25)~~ "Resident" means an individual domiciled within this state or an individual  
12 who is not domiciled in this state, but maintains a place of abode in this state and  
13 spends in the aggregate more than one hundred eighty-three (183) days of the  
14 taxable year in this state;

15 ~~(33)~~~~(26)~~ "S corporation" has the same meaning as in Section 1361(a) of the Internal  
16 Revenue Code;

17 ~~(34)~~~~(27)~~ "State" means a state of the United States, the District of Columbia, the  
18 Commonwealth of Puerto Rico, or any territory or possession of the United States;

19 ~~(35)~~~~(28)~~ "Taxable net income":

20 (a) In the case of corporations that are taxable in this state, means "net income" as  
21 defined in subsection ~~(24)~~~~(18)~~ of this section;

22 (b) In the case of corporations that are taxable in this state and taxable in another  
23 state, means "net income" as defined in subsection ~~(24)~~~~(18)~~ of this section  
24 and as allocated and apportioned under KRS 141.120;

25 (c) For homeowners' associations as defined in Section 528(c) of the Internal  
26 Revenue Code, means "taxable income" as defined in Section 528(d) of the  
27 Internal Revenue Code. Notwithstanding the provisions of subsection

4           (d) For a corporation that meets the requirements established under Section 856  
5           of the Internal Revenue Code to be a real estate investment trust, means "real  
6           estate investment trust taxable income" as defined in Section 857(b)(2) of the  
7           Internal Revenue Code, except that a captive real estate investment trust shall  
8           not be allowed any deduction for dividends paid;

9           ~~(36)~~~~(29)~~ "Taxable year" means the calendar year or fiscal year ending during such  
10          calendar year, upon the basis of which net income is computed, and in the case of a  
11          return made for a fractional part of a year under the provisions of this chapter or  
12          under administrative regulations prescribed by the commissioner, "taxable year"  
13          means the period for which the return is made; and

14          ~~(37)~~~~(30)~~ "Wages" has the same meaning as in Section 3401(a) of the Internal Revenue  
15          Code and includes other income subject to withholding as provided in Section  
16          3401(f) and Section 3402(k), (o), (p), (q), and (s) of the Internal Revenue Code.

17          ➔Section 2. KRS 141.020 is amended to read as follows:

18          (1) An annual tax shall be paid for each taxable year by every resident individual of this  
19          state upon his entire net income as defined in this chapter. The tax shall be  
20          determined by applying the rates in subsection (2) of this section to net income and  
21          subtracting allowable tax credits provided in subsection (3) of this section.

22          (2) (a) For taxable years beginning on or after January 1, 2018, the tax shall be five  
23          percent (5%) of net income.

24          (b) For taxable years beginning after December 31, 2004, and before January 1,  
25          2018, the tax shall be determined by applying the following rates to net  
26          income:

27                  1. Two percent (2%) of the amount of net income up to three thousand



- 1                   dollars (\$3,000);
- 2                   2.   Three percent (3%) of the amount of net income over three thousand
- 3                   dollars (\$3,000) and up to four thousand dollars (\$4,000);
- 4                   3.   Four percent (4%) of the amount of net income over four thousand
- 5                   dollars (\$4,000) and up to five thousand dollars (\$5,000);
- 6                   4.   Five percent (5%) of the amount of net income over five thousand
- 7                   dollars (\$5,000) and up to eight thousand dollars (\$8,000);
- 8                   5.   Five and eight-tenths percent (5.8%) of the amount of net income over
- 9                   eight thousand dollars (\$8,000) and up to seventy-five thousand dollars
- 10                  (\$75,000); and
- 11                  6.   Six percent (6%) of the amount of net income over seventy-five
- 12                  thousand dollars (\$75,000).
- 13   (3)   (a)   The following tax credits, when applicable, shall be deducted from the result
- 14                  obtained under subsection (2) of this section to arrive at the annual tax:
- 15                  1.   a.   For taxable years beginning before January 1, 2014, twenty dollars
- 16                                  (\$20) for an unmarried individual; and
- 17                                  b.   For taxable years beginning on or after January 1, 2014, and before
- 18                                  January 1, 2018, ten dollars (\$10) for an unmarried individual;
- 19                  2.   a.   For taxable years beginning before January 1, 2014, twenty dollars
- 20                                  (\$20) for a married individual filing a separate return and an

5                   separate return and an additional ten dollars (\$10) for the spouse of  
6                   a taxpayer if a separate return is made by the taxpayer and if the  
7                   spouse, for the calendar year in which the taxable year of the  
8                   taxpayer begins, had no Kentucky gross income and is not the  
9                   dependent of another taxpayer; or twenty dollars (\$20) for married  
10                  persons filing a joint return, provided neither spouse is the  
11                  dependent of another taxpayer. The determination of marital status  
12                  for the purpose of this section shall be made in the manner  
13                  prescribed in Section 153 of the Internal Revenue Code;
- 14                  3. a. For taxable years beginning before January 1, 2014, twenty dollars  
15                  (\$20) credit for each dependent. No credit shall be allowed for any  
16                  dependent who has made a joint return with his or her spouse; and

18                  January 1, 2018, ten dollars (\$10) credit for each dependent. No  
19                  credit shall be allowed for any dependent who has made a joint  
20                  return with his or her spouse;

22                  age of sixty-five (65) before the close of the taxable year;
- 23                  5. An additional forty dollars (\$40) credit for taxpayer's spouse if a

- 9 8. In the case of a fiduciary, other than an estate, the allowable tax credit
- 10 shall be two dollars (\$2);
- 11 9. In the case of an estate, the allowable tax credit shall be ten dollars
- 12 (\$10); and
- 13 10. An additional twenty dollars (\$20) credit shall be allowed if the taxpayer
- 14 is a member of the Kentucky National Guard at the close of the taxable
- 15 year.
- 16 (b) In the case of nonresidents, the tax credits allowable under this subsection
- 17 shall be the portion of the credits that are represented by the ratio of the
- 18 taxpayer's Kentucky adjusted gross income as determined by KRS 141.019 to
- 19 the taxpayer's adjusted gross income as defined in Section 62 of the Internal
- 20 Revenue Code. However, in the case of a married nonresident taxpayer with
- 21 income from Kentucky sources, whose spouse has no income from Kentucky
- 22 sources, the taxpayer shall determine allowable tax credit(s) by either:
- 23 1. The method contained above applied to the taxpayer's tax credit(s),
- 24 excluding credits for a spouse and dependents; or
- 25 2. Prorating the taxpayer's tax credit(s) plus the tax credits for the
- 26 taxpayer's spouse and dependents by the ratio of the taxpayer's Kentucky
- 27 adjusted gross income as determined by KRS 141.019 to the total joint

1 federal adjusted gross income of the taxpayer and the taxpayer's spouse.

2 (c) In the case of a part-year resident, the tax credits allowable under this  
3 subsection shall be the portion of the credits represented by the ratio of the  
4 taxpayer's Kentucky adjusted gross income as determined by KRS 141.019 to  
5 the taxpayer's adjusted gross income as defined in Section 62 of the Internal  
6 Revenue Code.

7 (4) An annual tax shall be paid for each taxable year as specified in this section upon  
8 the entire net income except as herein provided, from all tangible property located  
9 in this state, from all intangible property that has acquired a business situs in this  
10 state, and from business, trade, profession, occupation, or other activities carried on  
11 in this state, by natural persons not residents of this state. A nonresident individual  
12 shall be taxable only upon the amount of income received by the individual from  
13 labor performed, business done, or from other activities in this state, from tangible  
14 property located in this state, and from intangible property which has acquired a  
15 business situs in this state; provided, however, that the situs of intangible personal  
16 property shall be at the residence of the real or beneficial owner and not at the  
17 residence of a trustee having custody or possession thereof. **For taxable years**  
18 **beginning on or after January 1, 2021, but before January 1, 2025, the tax**  
19 **imposed by this section shall not apply to a disaster response employee or to a**  
20 **disaster response business.** The remainder of the income received by such  
21 nonresident shall be deemed nontaxable by this state.

22 (5) Subject to the provisions of KRS 141.081, any individual may elect to pay the  
23 annual tax imposed by KRS 141.023 in lieu of the tax levied under this section.

24 (6) A part-year resident is subject to taxation, as prescribed in subsection (1) of this  
25 section, during that portion of the taxable year that the individual is a resident and,  
26 as prescribed in subsection (4) of this section, during that portion of the taxable year  
27 when the individual is a nonresident.

1           ➔Section 3. KRS 141.040 is amended to read as follows:

2       (1) Every corporation doing business in this state, except those corporations listed in  
3       paragraphs (a) and (b) of this subsection, shall pay for each taxable year a tax to be  
4       computed by the taxpayer on taxable net income at the rates specified in this  
5       section:

6       (a) For taxable years beginning prior to January 1, 2021:

- 7           1. Financial institutions, as defined in KRS 136.500, except bankers banks  
8           organized under KRS 286.3-135;
- 9           2. Savings and loan associations organized under the laws of this state and  
10          under the laws of the United States and making loans to members only;
- 11          3. Banks for cooperatives;
- 12          4. Production credit associations;
- 13          5. Insurance companies, including farmers' or other mutual hail, cyclone,  
14          windstorm, or fire insurance companies, insurers, and reciprocal  
15          underwriters;
- 16          6. Corporations or other entities exempt under Section 501 of the Internal  
17          Revenue Code;
- 18          7. Religious, educational, charitable, or like corporations not organized or  
19          conducted for pecuniary profit; and
- 20          8. Corporations whose only owned or leased property located in this state

- 17          (2) For taxable years beginning on or after January 1, 2018, the rate of five percent  
18          (5%) of taxable net income shall apply.
- 19          (3) For taxable years beginning on or after January 1, 2007, and before January 1, 2018,  
20          the following rates shall apply:
  - 21          (a) Four percent (4%) of the first fifty thousand dollars (\$50,000) of taxable net  
22          income;
  - 23          (b) Five percent (5%) of taxable net income over fifty thousand dollars (\$50,000)  
24          up to one hundred thousand dollars (\$100,000); and
  - 25          (c) Six percent (6%) of taxable net income over one hundred thousand dollars  
26          (\$100,000).
- 27          (4) (a) An S corporation shall pay income tax on the same items of income and in the

1 same manner as required for federal purposes, except to the extent required by  
2 differences between this chapter and the federal income tax law and  
3 regulations.

4 (b) 1. If the S corporation is required under Section 1363(d) of the Internal  
5 Revenue Code to submit installments of tax on the recapture of LIFO  
6 benefits, installments to pay the Kentucky tax due shall be paid on or  
7 before the due date of the S corporation's return, as extended, if  
8 applicable.

9 2. Notwithstanding KRS 141.170(3), no interest shall be assessed on the  
10 installment payment for the period of extension.

11 (c) If the S corporation is required under Section 1374 or 1375 of the Internal  
12 Revenue Code to pay tax on built-in gains or on passive investment income,  
13 the amount of tax imposed by this subsection shall be computed by applying  
14 the highest rate of tax for the taxable year.

15 ➔Section 4. KRS 68.180 is amended to read as follows:

16 (1) The fiscal court of each county having a population of three hundred thousand  
17 (300,000) or more may by order or resolution impose license fees on franchises,  
18 provide for licensing any business, trade, occupation, or profession, and the using,  
19 holding, or exhibiting of any animal, article, or other thing.

20 (2) License fees on such business, trade, occupation, or profession for revenue  
21 purposes, except those of the common schools, shall be imposed at a percentage  
22 rate not to exceed one and one-fourth percent (1.25%) of:

24 (d) A boiler mechanic pursuant to KRS 236.210;

25 (e) A master or journeyman plumber pursuant to KRS 318.030;

26 (f) An onsite sewage disposal system installer pursuant to KRS 211.357; or

27 (g) An electrician or master electrician employed by an electrical contractor

1           pursuant to KRS 227A.010 to 227A.140.

2   (11) The provisions of KRS 227A.010 to 227A.140 shall not apply to work performed at  
3       industrial manufacturing facilities or natural gas pipeline facilities by employees of  
4       those facilities.

5   *(12) Notwithstanding subsection (6) of this section, KRS 227A.010 to 227A.140 shall*  
6       *not apply to a disaster response employee as defined in Section 1 of this Act who*  
7       *is licensed as an electrician or master electrician in another state.*

8   *(13) KRS 227A.010 to 227A.140 shall not apply to a disaster response business as*  
9       *defined in Section 1 of this Act that is licensed as an electrical contractor in*  
10      *another state.*

11       ➔SECTION 10. A NEW SECTION OF KRS 67.750 TO 67.790 IS CREATED  
12   TO READ AS FOLLOWS:

13   *(1) The exceptions contained in subsection (3)(g) of Section 4 of this Act, subsection*  
14      *(5)(d) of Section 5 of this Act, subsection (3)(h) of Section 6 of this Act, and*  
15      *subsection (2)(a)4. and (b)3. of Section 7 of this Act shall not be interpreted,*  
16      *construed, or otherwise relied upon in any way to establish a minimum nexus or*  
17      *other minimum contact requirements for the purposes of determining the liability*  
18      *for either a tax or fee placed upon a business or employee by a taxing*  
19      *jurisdiction, except as related to disaster response businesses and disaster*  
20      *response employees for work performed within the taxing jurisdiction during a*  
21      *disaster response period.*

22   *(2) As used in this section, the terms "disaster response business," "disaster*  
23      *response employee," and "disaster response period" shall have the same*  
24      *meaning as in Section 1 of this Act.*
