2	Be it enacted by the General Assembly of the Commonwealth of Kentucky:
3	→SECTION 1. A NEW SECTION OF KRS CHAPTER 525 IS CREATED TO
4	READ AS FOLLOWS:
5	(1) For the purposes of this section:
6	(a) "Abuse" means the intentional or wanton:
7	1. Infliction of unnecessary pain, suffering, or contact; or
8	2. Neglect or abandonment, including the failure to provide adequate
9	food, drink, space, or health care;
0	(b) "Body condition score" means a score attributed by a veterinarian based
1	upon the Henneke Body Condition Scoring System; and
2	(c) "Equine" means any animal of the equine species.
3	(2) A person is guilty of cruelty to equines when an individual abuses an equine and
4	the abuse results in:
5	(a) Serious physical injury or death;
6	(b) A body condition score of three (3) or less; or
7	(c) Sexual contact between the individual and an equine for the purpose of
8	sexual arousal, sexual gratification, exercising power over the equine, or
9	financial gain.
20	(3) Cruelty to equines is a Class D felony.
21	(4) If a person is convicted of or pleads guilty to an offense under subsection (2) of
22	this section arising from the person's treatment of an equine, the court shall
23	impose the following penalties against the person, in addition to fines and
24	imprisonment:
25	(a) An order that the person pay restitution for damage to the property of others
26	and for costs incurred by others, including reasonable costs, as determined
2.7	by agreement or by the court after a hearing, incurred in feeding.

24		(g) In defense of another equine against an aggressive or diseased equine;

4	<u>(6)</u>	The acts specified in this section shall not constitute cruelty to animals under
5		<u>KRS 525.130.</u>
6		→ Section 2. This Act shall be known and may be cited as Klaire's Law.
7		→ Section 3. The restrictions of KRS 6.945(1) shall not apply to Section 1 of this
8	Act.
