- the United States.

- 20 the United States, federal agencies, or state governments that would compromise the
- 21 mission or religious integrity of pregnancy help centers.
- → Section 4. The General Assembly disapproves of the actions of any national,
- state, or local group attempting to prevent pregnancy help centers from effectively serving
- women and men facing unplanned pregnancies.
