| 3 | WHEREAS, the right to vote in a free, honest, and fair election is the most basic |
| 4 | civil right, one of the most important rights on which the American people depend; and |
| 5 | WHEREAS, citizens must have confidence in our electoral process, free from fraud |

| 7 | WHEREAS, it is incumbent upon the state governments to safeguard the electoral |
| 8 | process and ensure that every American citizen's right to cast a ballot is protected; and |

| 18 | →Section 1. The Legislative Research Commission shall establish the Election |
| 19 | Integrity and Security Task Force to study current election processes in Kentucky. |
| 20 | → Section 2. The Election Integrity and Security Task Force shall assess, examine, |
| 21 | and evaluate current election processes: |
| 22 | (1) Before an election; |
| 23 | (2) During an election; |
| 24 | (3) After an election; and |
| 25 | (4) Any ongoing maintenance activities associated with elections that take place |
| 26 | in the Commonwealth. |
