| 3 | WHEREAS, Paul W. Rowe was born on August 15, 1932, to William D. and Lizzie |
| 4 | Lee Prater-Rowe of Salyersville, the sixth of their seven children; and |
| 5 | WHEREAS, Paul W. Rowe was raised in Salyersville, where he graduated from |
| 6 | Salyersville High School; and |
| 7 | WHEREAS, Paul W. Rowe was drafted into the United States Army in 1954, where |
| 8 | he served until 1956. He also served in the United States Army Reserves for eight years |
| 9 | after his honorable discharge; and |
| 10 | WHEREAS, Paul W. Rowe attended Eastern Kentucky University, where he earned |
| 11 | both undergraduate and graduate degrees in Education and obtained a Rank I Education |
| 12 | certificate; and |
| 13 | WHEREAS, after his education at Eastern Kentucky University, Paul W. Rowe and |
| 14 | his wife, Marjie, returned to Magoffin County, where Paul began his career teaching in a |
| 15 | one-room school house on Grape Creek for the Magoffin County School System; and |
| 16 | WHEREAS, after his first teaching assignment, Paul W. Rowe taught 7th grade at |
| 17 | Millard-Hensley Elementary and later spent a year teaching at Salyersville Grade School; |
| 18 | and |
| 19 | WHEREAS, after obtaining his principal's certificate, Paul W. Rowe was asked to |
| 20 | be the principal of the newly built Middle Fork Elementary School in the community of |
| 21 | Hendricks. He served 22 years as principal there; and |
| 22 | WHEREAS, Paul W. Rowe was an active member of the Prater Memorial United |
| 23 | Methodist Church in Salyersville, which he attended for 45 years. He served in several |
| 24 | capacities in the church, including Sunday school teacher, Sunday school superintendent, |
| 25 | and chairman of the administrative board, to name a few. If there was an event or work to |
| 26 | do at the church, Paul W. Rowe was always there to participate or lend a hand; and |
| 27 | WHEREAS, Paul W. Rowe was a man of many talents. He was an accomplished |

1 musician who played the guitar, mandolin, fiddle, and banjo. He was also known as being 2 a talented woodworker. He created beautiful muzzleloader guns, cabinetry, and furniture, 3 and provided help with updates and remodeling of the homes of family and friends; and 4 WHEREAS, Paul W. Rowe, along with his brother, painstakingly deconstructed a 5 Civil War era log cabin piece by piece and reconstructed the cabin on a farm on Grape 6 Creek. Many gatherings were and continue to be had there for their family and friends to 7 enjoy; and 8 WHEREAS, Paul W. Rowe was also a member of the Masonic Lodge of 9 Salversville #769, the United Methodist Men, and the Magoffin County Historical 10 Society, and was a charter member of the Magoffin County Muzzleloaders; and 11 WHEREAS, on April 27, 1990, after a meeting of administrators at the Magoffin 12 County Board of Education, Paul W. Rowe traversed these earthly bounds as a result of a 13 vehicle accident. He was survived by his wife, Marjileen Keeton Rowe; his two 14 daughters, Cathy Rowe-Sparks and Deborah Rowe-Cain; six grandchildren; and five 15 great-grandchildren; 16 NOW, THEREFORE, 17 Be it resolved by the General Assembly of the Commonwealth of Kentucky: 18 → Section 1.
