1	A RESOLUTION adjourning the House of Representatives in honor and loving
2	memory of former Kentucky state legislator Dr. Nicholas Z. "Nick" Kafoglis.
3	WHEREAS, the Kentucky General Assembly has lost one of its most distinguished
4	former members and dearest friends; and
5	WHEREAS, raised in Lexington, Dr. Nick Kafoglis went on to graduate from Yale
6	University and serve in the United States Air Force, and for 36 years practiced medicine
7	in Bowling Green; and
8	WHEREAS, Dr. Kafoglis served in the Kentucky House of Representatives from
9	1972 until 1976, and in the Kentucky Senate from 1987 until 1999. For six years he
10	chaired the Senate's Democratic Majority Caucus, and during his time in the General
11	Assembly he became known as a man who was unafraid to cross party lines while also
12	holding firm to his core ideals of fairness, decency, and public service; and
13	WHEREAS, a passionate advocate for public education, Dr. Kafoglis was
14	instrumental in the passage of the Kentucky Education Reform Act in 1999. He also
15	championed issues that revealed his unyielding belief in the power of the human spirit,
16	including forward-thinking legislation aimed toward curbing drug abuse and making
17	Kentuckians healthier; and
18	WHEREAS, Dr. Kafoglis was the recipient of the William H. Natcher Award for
19	Distinguished Government Service in 1995 and the Outstanding State Senator Award in
20	1996. He retired from the Kentucky Senate at the age of 69, and his service to this body
21	and to his fellow man still resonates to this day; and
22	WHEREAS, Dr. Kafoglis passed from this life on February 9, 2019, at the age of
23	89. He was a human being of the first order, and his presence in the lives of those he
24	touched will never be forgotten; and
25	WHEREAS, this august body pauses on this day to remember the many
26	accomplishments and the indelible legacy of our dear friend and colleague, and in so
27	doing we recall his many good works and his abiding belief in serving our fellow citizens:
