7	bravely served his country during the Korean War; and
8	WHEREAS, a lifelong tobacco and cattle farmer, Adrian Arnold was the recipient
9	of the Outstanding Young Farmer award in 1960. A staple of his Mt. Sterling community,
10	he was a member of Gateway Christian Church, American Legion Post #22, the
11	Montgomery County Fair Board for fifty years, the board of People's Exchange Bank, and
12	the Morehead State at Mt. Sterling Advisory Board. He was also instrumental in the
13	funding of Gateway Children's Services, which is housed in the Adrian Arnold Building
14	in his honor; and
15	WHEREAS, an avid pilot and lover of history, Adrian Arnold was a former
16	Montgomery County Man of the Year; and
17	WHEREAS, Adrian Arnold proudly served as a Kentucky State Representative for
18	33 years. As a member of the General Assembly, Representative Arnold served as the
19	chair of the Elections, Constitutional Amendments, and Governmental Affairs
20	Committee; he was an essential part of jail reform legislation during the 1980s, and also
21	served as a United States liaison to Lithuania in 1994. Often boasting that he was the only
22	fulltime farmer in Kentucky's General Assembly, Representative Arnold was a true
23	steward of his community, and his hard work and diligent public service on behalf of his
24	constituents still resonate to this day; and
25	WHEREAS, Adrian Arnold, beloved husband, father, and grandfather, departed this
26	earthly life and entered into the kingdom of Heaven on December 15, 2018, leaving his
27	family, friends, and all those whose lives he touched in solemn mourning; and
