1	A RESOLUTION commending Taiwan for its relationship with the Commonwealth
2	of Kentucky and the United States.
3	WHEREAS, Taiwan continues to be a responsible international stakeholder, despite
4	a continuous, hostile, security threat imposed by China; and
5	WHEREAS, 2024 marks the 45th anniversary of the enactment of the landmark
6	Taiwan Relations Act (TRA), which has facilitated a close partnership between the
7	United States and Taiwan on security, business, educational, cultural, and people-to-
8	people exchanges; and
9	WHEREAS, in 2023, Taiwan welcomed the largest number of United States
10	official delegations to date; and
11	WHEREAS, China repeatedly excludes Taiwan from the United Nations system by
12	constant distortion of United Nations Resolution 2758 (XXVI), as the resolution did not
13	address the issue of representation of Taiwan and its people in the United Nations or any
14	related organizations, nor did the resolution take a position on the relations between
15	China and Taiwan; and
16	WHEREAS, Taiwan is the United States' ninth-largest trading partner, and the
17	United States is Taiwan's second-largest trading partner, with an estimated \$160 billion
18	in trade in 2022; and
19	WHEREAS, in June 2023, the United States and Taiwan signed the first agreement
20	under the U.STaiwan Initiative on 21st-Century Trade, covering customs and border
21	procedures, regulatory practices, and small business; and
22	WHEREAS, under a higher education and K-12 cooperation memorandum of
23	understanding between Kentucky and Taiwan, and thanks to the cooperation between the
24	Kentucky Department of Education and the Asia Institute Crane House, Taiwan
25	welcomed nine English teachers to host a three-week English summer camp for 16
26	elementary or middle schools;

- 3 → Section 1. The House of Representatives supports the U.S.-Taiwan Initiative on
- 4 21st-Century Trade and an Avoid Double Taxation Agreement between the United States
- 5 and Taiwan, as Taiwanese companies are looking for a diverse and free market in the
- 6 United States.
- 7 → Section 2. The House of Representatives welcomes the anniversary of the TRA,
- 8 which reaffirms the United States' commitment to Taiwan, supports Taiwan's meaningful
- 9 participation in international organizations and economic cooperation such as the World
- 10 Health Organization, United Nations Framework Convention on Climate Change,
- 11 International Civil Aviation Organization, International Criminal Police Organization,
- 12 Comprehensive and Progressive Agreement for Trans-Pacific Partnership, and Indo-
- 13 Pacific Economic Framework for Prosperity. The House of Representatives further
- 14 encourages Kentuckians to take part in activities promoting Taiwan's cultures, cuisine,
- and tourism, and urges the members of this body to join the Kentucky-Taiwan Caucus in
- exploring increased collaboration with Taiwan, the Republic of China.
