- 9 housing and recreational facilities; residential facilities operated by any officially
- 10 recognized student organization; all sections of public property such as streets,

- remote facilities leased for use as classroom space or student living.
- 13 (2) "Campus security authority" means campus police, security officers, and any

- student judicial affairs, and student life administration. Professional mental health,

- 19 (3) "Crime" means any crime listed in 20 U.S.C. sec. 1092(f)(1)(F) as
- 20 amended; means murder, manslaughter, reckless homicide, assault, menacing,
- 21 wanton endangerment, terroristic threatening, stalking, forcible or nonforcible sex
- 22 offenses, burglary, criminal damage to property, arson, theft, motor vehicle theft,
- 23 robbery, weapons possession, and criminal attempt for any of the aforementioned
