

1 AN ACT relating to out-of-network billing.

2 ***Be it enacted by the General Assembly of the Commonwealth of Kentucky:***

3 ➔Section 1. KRS 304.17A-005 is amended to read as follows:

4 As used in this subtitle, unless the context requires otherwise:

- 5 (1) "Association" means an entity, other than an employer-organized association, that
6 has been organized and is maintained in good faith for purposes other than that of
7 obtaining insurance for its members and that has a constitution and bylaws;
- 8 (2) "At the time of enrollment" means:
9 (a) At the time of application for an individual, an association that actively
10 markets to individual members, and an employer-organized association that
11 actively markets to individual members; and
12 (b) During the time of open enrollment or during an insured's initial or special
13 enrollment periods for group health insurance;
- 14 (3) "Base premium rate" means, for each class of business as to a rating period, the
15 lowest premium rate charged or that could have been charged under the rating
16 system for that class of business by the insurer to the individual or small group, or
17 employer as defined in KRS 304.17A-0954, with similar case characteristics for
18 health benefit plans with the same or similar coverage;
- 19 (4) "Basic health benefit plan" means any plan offered to an individual, a small group,
20 or employer-organized association that limits coverage to physician, pharmacy,
21 home health, preventive, emergency, and inpatient and outpatient hospital services
22 in accordance with the requirements of this subtitle. If vision or eye services are
23 offered, these services may be provided by an ophthalmologist or optometrist.
24 Chiropractic benefits may be offered by providers licensed pursuant to KRS
25 Chapter 312;
- 26 (5) "Bona fide association" means an entity as defined in 42 U.S.C. sec. 300gg-
27 91(d)(3);

1 (6) "Church plan" means a church plan as defined in 29 U.S.C. sec. 1002(33);

2 (7) "COBRA" means any of the following:

3 (a) 26 U.S.C. sec. 4980B other than subsection (f)(1) as it relates to pediatric
4 vaccines;

5 (b) The Employee Retirement Income Security Act of 1974 (29 U.S.C. sec. 1161
6 et seq. other than sec. 1169); or

7 (c) 42 U.S.C. sec. 300bb;

8 **(8) "Cost-sharing":**

9 **(a) Means any expenditure required under a health insurance policy or plan to**
10 **be paid by or on behalf of an insured with respect to receiving plan benefits;**

11 **(b) Includes coinsurance, copayments, and deductibles; and**

12 **(c) Does not include premiums, balance billing amounts for out-of-network**
13 **providers, or spending for noncovered services;**

14 **(9)[(8)] "Creditable coverage":**

15 (a) Means, with respect to an individual, coverage of the individual under any of
16 the following:

17 1. A group health plan;

18 2. Health insurance coverage;

19 3. Part A or Part B of Title XVIII of the Social Security Act;

20 4. Title XIX of the Social Security Act, other than coverage consisting
21 solely of benefits under section 1928;

22 5. Chapter 55 of Title 10, United States Code, including medical and dental
23 care for members and certain former members of the uniformed services,
24 and for their dependents; for purposes of Chapter 55 of Title 10, United
25 States Code, "uniformed services" means the Armed Forces and the
26 Commissioned Corps of the National Oceanic and Atmospheric
27 Administration and of the Public Health Service;

- 1 6. A medical care program of the Indian Health Service or of a tribal
2 organization;
- 3 7. A state health benefits risk pool;
- 4 8. A health plan offered under Chapter 89 of Title 5, United States Code,
5 such as the Federal Employees Health Benefit Program;
- 6 9. A public health plan as established or maintained by a state, the United
7 States government, a foreign country, or any political subdivision of a
8 state, the United States government, or a foreign country that provides
9 health coverage to individuals who are enrolled in the plan;
- 10 10. A health benefit plan under section 5(e) of the Peace Corps Act (22
11 U.S.C. sec. 2504(e)); or
- 12 11. Title XXI of the Social Security Act, such as the State Children's Health
13 Insurance Program; and
- 14 (b) Does not include coverage consisting solely of coverage of excepted benefits
15 as defined in this section;

16 ~~(10)~~⁽⁹⁾ "Dependent" means any individual who is or may become eligible for
17 coverage under the terms of an individual or group health benefit plan because of a
18 relationship to a participant;

19 **(11) "Emergency medical condition" means:**

20 **(a) A medical condition manifesting itself by acute symptoms of sufficient**
21 **severity, including severe pain, that a prudent layperson would reasonably**
22 **have cause to believe constitutes a condition in which the absence of**
23 **immediate medical attention could reasonably be expected to result in:**

24 **1. Placing the health of the individual or, with respect to a pregnant**
25 **woman, the health of the woman or her unborn child, in serious**
26 **jeopardy;**

27 **2. Serious impairment to bodily functions; or**

1 **3. Serious dysfunction of any bodily functions; or**

2 **(b) With respect to a pregnant woman who is having contractions:**

3 **1. A situation in which there is inadequate time to effect a safe transfer**
 4 **to another hospital before delivery; or**

5 **2. A situation in which transfer may pose a threat to the health or safety**
 6 **of the woman or the unborn child;**

7 ~~(12)~~~~(10)~~ "Employee benefit plan" means an employee welfare benefit plan or an
 8 employee pension benefit plan or a plan which is both an employee welfare benefit
 9 plan and an employee pension benefit plan as defined by ERISA;

10 ~~(13)~~~~(11)~~ "Eligible individual" means an individual:

11 (a) For whom, as of the date on which the individual seeks coverage, the
 12 aggregate of the periods of creditable coverage is eighteen (18) or more
 13 months and whose most recent prior creditable coverage was under a group
 14 health plan, governmental plan, or church plan. A period of creditable
 15 coverage under this paragraph shall not be counted if, after that period, there
 16 was a sixty-three (63) day period of time, excluding any waiting or affiliation
 17 period, during all of which the individual was not covered under any
 18 creditable coverage;

19 (b) Who is not eligible for coverage under a group health plan, Part A or Part B of
 20 Title XVIII of the Social Security Act (42 U.S.C. secs. 1395j et seq.), or a
 21 state plan under Title XIX of the Social Security Act (42 U.S.C. secs. 1396 et
 22 seq.) and does not have other health insurance coverage;

23 (c) With respect to whom the most recent coverage within the coverage period
 24 described in paragraph (a) of this subsection was not terminated based on a
 25 factor described in KRS 304.17A-240(2)(a), (b), and (c);

26 (d) If the individual had been offered the option of continuation coverage under a
 27 COBRA continuation provision or under KRS 304.18-110, who elected the

1 coverage; and

2 (e) Who, if the individual elected the continuation coverage, has exhausted the
3 continuation coverage under the provision or program;

4 ~~(14)~~~~(12)~~ "Employer-organized association" means any of the following:

5 (a) Any entity that was qualified by the commissioner as an eligible association
6 prior to April 10, 1998, and that has actively marketed a health insurance
7 program to its members since September 8, 1996, and which is not insurer-
8 controlled;

9 (b) Any entity organized under KRS 247.240 to 247.370 that has actively
10 marketed health insurance to its members and that is not insurer-controlled;

11 (c) Any entity or association of employers, which has been actively in existence
12 for at least two (2) years, formed under the Employee Retirement Income
13 Security Act, 29 U.S.C. secs. 1001 et seq., to provide an employee welfare
14 benefit plan under guidance issued by the United States Department of Labor
15 prior to the issuance of 29 C.F.R. sec. 2510.3-5, and for which the entity's
16 health insurance decisions are made by a board or committee, the majority of
17 which are representatives of employer members of the entity who obtain
18 group health insurance coverage through the entity or through a trust or other
19 mechanism established by the entity, and whose health insurance decisions are
20 reflected in written minutes or other written documentation; and

21 (d) Any entity or association of employers, which has been actively in existence
22 for at least two (2) years, formed under the Employee Retirement Income
23 Security Act, 29 U.S.C. secs. 1001 et seq., to provide an employee welfare
24 benefit plan, whose members consist of employers or a group of employers
25 that satisfy the requirements of 29 C.F.R. sec. 2510.3-5.

26 Except as provided in KRS 304.17A-0954, 304.17A-200, and 304.17A-220, and
27 except as otherwise provided by the definition of "large group" contained in this

1 section, an employer-organized association shall not be treated as an association,
2 small group, or large group under this subtitle, except that an employer-organized
3 association as defined under paragraph (c) or (d) of this subsection shall be treated
4 as a large group under this subtitle;

5 ~~(15)~~~~(13)~~ "Employer-organized association health insurance plan" means any health
6 insurance plan, policy, or contract issued to an employer-organized association, or
7 to a trust established by one (1) or more employer-organized associations, or
8 providing coverage solely for the employees, retired employees, directors and their
9 spouses and dependents of the members of one (1) or more employer-organized
10 associations;

11 ~~(16)~~~~(14)~~ "Excepted benefits" means benefits under one (1) or more, or any combination
12 of the following:

- 13 (a) Coverage only for accident, including accidental death and dismemberment,
14 or disability income insurance, or any combination thereof;
- 15 (b) Coverage issued as a supplement to liability insurance;
- 16 (c) Liability insurance, including general liability insurance and automobile
17 liability insurance;
- 18 (d) Workers' compensation or similar insurance;
- 19 (e) Automobile medical payment insurance;
- 20 (f) Credit-only insurance;
- 21 (g) Coverage for on-site medical clinics;
- 22 (h) Other similar insurance coverage, specified in administrative regulations,
23 under which benefits for medical care are secondary or incidental to other
24 insurance benefits;
- 25 (i) Limited scope dental or vision benefits;
- 26 (j) Benefits for long-term care, nursing home care, home health care, community-
27 based care, or any combination thereof;

- 1 (k) Such other similar, limited benefits as are specified in administrative
2 regulations;
- 3 (l) Coverage only for a specified disease or illness;
- 4 (m) Hospital indemnity or other fixed indemnity insurance;
- 5 (n) Benefits offered as Medicare supplemental health insurance, as defined under
6 section 1882(g)(1) of the Social Security Act;
- 7 (o) Coverage supplemental to the coverage provided under Chapter 55 of Title 10,
8 United States Code;
- 9 (p) Coverage similar to that in paragraphs (n) and (o) of this subsection that is
10 supplemental to coverage under a group health plan; and
- 11 (q) Health flexible spending arrangements;
- 12 ~~(17)~~~~(15)~~ "Governmental plan" means a governmental plan as defined in 29 U.S.C. sec.
13 1002(32);
- 14 ~~(18)~~~~(16)~~ "Group health plan" means a plan, including a self-insured plan, of or
15 contributed to by an employer, including a self-employed person, or employee
16 organization, to provide health care directly or otherwise to the employees, former
17 employees, the employer, or others associated or formerly associated with the
18 employer in a business relationship, or their families;
- 19 ~~(19)~~~~(17)~~ "Guaranteed acceptance program participating insurer" means an insurer that
20 is required to or has agreed to offer health benefit plans in the individual market to
21 guaranteed acceptance program qualified individuals under KRS 304.17A-400 to
22 304.17A-480;
- 23 ~~(20)~~~~(18)~~ "Guaranteed acceptance program plan" means a health benefit plan in the
24 individual market issued by an insurer that provides health benefits to a guaranteed
25 acceptance program qualified individual and is eligible for assessment and refunds
26 under the guaranteed acceptance program under KRS 304.17A-400 to 304.17A-480;
- 27 ~~(21)~~~~(19)~~ "Guaranteed acceptance program" means the Kentucky Guaranteed

1 Acceptance Program established and operated under KRS 304.17A-400 to
2 304.17A-480;

3 ~~(22)~~~~(20)~~ "Guaranteed acceptance program qualified individual" means an individual
4 who, on or before December 31, 2000:

5 (a) Is not an eligible individual;

6 (b) Is not eligible for or covered by other health benefit plan coverage or who is a
7 spouse or a dependent of an individual who:

8 1. Waived coverage under KRS 304.17A-210(2); or

9 2. Did not elect family coverage that was available through the association
10 or group market;

11 (c) Within the previous three (3) years has been diagnosed with or treated for a
12 high-cost condition or has had benefits paid under a health benefit plan for a
13 high-cost condition, or is a high risk individual as defined by the underwriting
14 criteria applied by an insurer under the alternative underwriting mechanism
15 established in KRS 304.17A-430(3);

16 (d) Has been a resident of Kentucky for at least twelve (12) months immediately
17 preceding the effective date of the policy; and

18 (e) Has not had his or her most recent coverage under any health benefit plan
19 terminated or nonrenewed because of any of the following:

20 1. The individual failed to pay premiums or contributions in accordance
21 with the terms of the plan or the insurer had not received timely
22 premium payments;

23 2. The individual performed an act or practice that constitutes fraud or
24 made an intentional misrepresentation of material fact under the terms of
25 the coverage; or

26 3. The individual engaged in intentional and abusive noncompliance with
27 health benefit plan provisions;

1 ~~(23)~~~~(21)~~ "Guaranteed acceptance plan supporting insurer" means either an insurer, on
2 or before December 31, 2000, that is not a guaranteed acceptance plan participating
3 insurer or is a stop loss carrier, on or before December 31, 2000, provided that a
4 guaranteed acceptance plan supporting insurer shall not include an employer-
5 sponsored self-insured health benefit plan exempted by ERISA;

6 ~~(24)~~~~(22)~~ "Health benefit plan":

7 (a) Shall include any:

- 8 1. Hospital or medical expense policy or certificate;
- 9 2. Nonprofit hospital, medical-surgical, and health service corporation
10 contract or certificate;

- 12 4. Self-insured plan or a plan provided by a multiple employer welfare

- 4 7. Student health insurance offered by a Kentucky-licensed insurer under

1 (AIDS), angina pectoris, ascites, chemical dependency cirrhosis of the liver,
2 coronary insufficiency, coronary occlusion, cystic fibrosis, Friedreich's ataxia,
3 hemophilia, Hodgkin's disease, Huntington chorea, juvenile diabetes,
4 leukemia, metastatic cancer, motor or sensory aphasia, multiple sclerosis,
5 muscular dystrophy, myasthenia gravis, myotonia, open heart surgery,
6 Parkinson's disease, polycystic kidney, psychotic disorders, quadriplegia,
7 stroke, syringomyelia, Wilson's disease, and amyotrophic lateral sclerosis;

8 (29)~~[(27)]~~ "Index rate" means, for each class of business as to a rating period, the
9 arithmetic average of the applicable base premium rate and the corresponding
10 highest premium rate;

11 (30)~~[(28)]~~ "Individual market" means the market for the health insurance coverage
12 offered to individuals other than in connection with a group health plan. The
13 individual market includes an association plan that is not employer-related, issued
14 to individuals on an individually underwritten basis, other than an employer-
15 organized association or a bona fide association;

16 (31)~~[(29)]~~ "Insurer" means any insurance company; health maintenance organization;
17 self-insurer, including a governmental plan, church plan, or multiple employer
18 welfare arrangement, not exempt from state regulation by ERISA; provider-
19 sponsored integrated health delivery network; self-insured employer-organized
20 association, or nonprofit hospital, medical-surgical, dental, or health service
21 corporation authorized to transact health insurance business in Kentucky;

23 administrative hearing called specifically for that purpose, that an insurer has or had
24 a substantial involvement in the organization or day-to-day operation of the entity
25 for the principal purpose of creating a device, arrangement, or scheme by which the
26 insurer segments employer groups according to their actual or anticipated health
27 status or actual or projected health insurance premiums;

18 the standard practice of care where images are sent to a specialist for
19 evaluation. The requirement for a face-to-face encounter shall be satisfied
20 with the use of asynchronous telecommunications technologies in which the
21 health care provider has access to the patient's or client's medical history prior
22 to the telehealth encounter;

23 (b) Shall not include the delivery of services through electronic mail, text chat,
24 facsimile, or standard audio-only telephone call; and

25 (c) Shall be delivered over a secure communications connection that complies
26 with the federal Health Insurance Portability and Accountability Act of 1996,
27 42 U.S.C. secs. 1320d to 1320d-9.

1 ➔SECTION 2. A NEW SECTION OF SUBTITLE 17A OF KRS CHAPTER 304
2 IS CREATED TO READ AS FOLLOWS:

3 **(1) The commissioner shall promulgate administrative regulations to:**

4 **(a) Specify a nonprofit organization that maintains a database of billed charges**
5 **submitted by providers for health care services to be used as a benchmark**

7 **The nonprofit shall not be affiliated with an insurer offering health benefit**
8 **plans in Kentucky; and**

9 **(b) Require all insurers to submit to the department annually no later than**
10 **March 1 of each year, all billed charges received from both participating**
11 **and nonparticipating providers for each health care service.**

12 **(2) Any information required to be reported under this section shall:**

13 **(a) Be reported on a form and in a manner determined by the department;**

14 **(b) Not include any personally identifying information of an insured; and**

15 **(c) Include appropriate geographical information of the billing provider.**

16 **(3) The department shall provide information reported pursuant to this section to the**
17 **nonprofit identified in subsection (1) of this section, or if no nonprofit exists**
18 **meeting the requirements of subsection (1) of this section, then the department**
19 **shall publish this information in a report on its Web site by June 1 of each year.**

25 1. The insurer's median in-network rate for the current year; or

27 (b) Send a notice to the nonparticipating provider of any cost-sharing owed

- 1 under the insured's health benefit plan for the unanticipated out-of-network
2 care. The amount of cost-sharing owed shall:
- 3 1. Not exceed the amount of cost-sharing that would have been owed if
4 the services were provided by a participating provider; and
- 5 2. Be calculated based on the reimbursement amount determined under
6 this section.
- 7 (3) A nonparticipating provider who has been reimbursed by an insurer under
8 subsection (2) of this section:
- 9 (a) Shall not balance bill an insured; and
10 (b) May bill an insured for any applicable cost-sharing.
- 11 (4) (a) Any cost-sharing that the insured pays under this section shall be
12 attributable to any annual deductibles and out-of-pocket maximums
13 required under the terms of the insured's health benefit plan.
- 14 (b) The entire amount paid by the insured to the nonparticipating provider
15 shall be attributable to any annual deductible and out-of-pocket maximums
16 required under the terms of the insured's health benefit plan when an
17 insurer does not make a reimbursement under this section because the cost-
18 sharing owed for the unanticipated out-of-network care is more than the
19 reimbursement amount determined under this section.
- 20 (5) A nonparticipating provider shall accept the reimbursement made under
21 subsection (2) of this section, plus any applicable cost-sharing owed by an
22 insured, as the full and final payment for the unanticipated out-of-network care,
23 except as provided in Section 4 of this Act.
- 24 (6) An appropriate regulatory agency or board that licenses, certifies, or otherwise
25 authorizes a provider to provide health care services in this state may take any
26 disciplinary action that the board or agency is authorized to take against
27 regulated providers under the agency's or board's authorizing statutes against a

1 provider that violates this subsection.

2 ➔SECTION 4. A NEW SECTION OF SUBTITLE 17A OF KRS CHAPTER 304
3 IS CREATED TO READ AS FOLLOWS:

4 (1) As used in this section:

5 (a) "Usual and customary rate" means the eightieth percentile of all charges
6 for a particular health care service performed by a health care provider in
7 the same or similar specialty and provided in the same geographical area as

7 (b) If the commissioner has not received notification that the parties have
8 selected a reviewer within twenty (20) days, the commissioner shall, within
9 ten (10) days, select a qualified reviewer from his or her list of qualified

16 participate in the informal settlement conference.

18 parties reached a settlement within five (5) days of completion of the

20 (7) The parties shall not be entitled to engage in discovery in connection with the
21 independent dispute resolution proceeding.

23 (a) Set a date for the submission of all information to be considered by the
24 reviewer;

25 (b) Except as provided in subsection (11) of this section, hold in strict
26 confidence all information provided by a party and all communications of
27 the reviewer with the parties; and

1 (c) Not later than sixty (60) days after the date the independent dispute
2 resolution proceeding was requested, provide the parties with a written
3 decision that:

4 1. Determines the reasonable amount owed to the nonparticipating
5 provider for the unanticipated out-of-network care; and

6 2. Selects, as the amount awarded under this section, the following
7 amount which is closest to the amount determined under
8 subparagraph 1. of this paragraph:

9 a. The amount billed to the insurer by the nonparticipating
10 provider; or

11 b. The amount reimbursed by the insurer under Section 3 of this
12 Act.

13 (9) The reviewer's determination under subsection (8)(c)1. of this section shall take
14 into account:

15 (a) Whether there is a gross disparity between the charges billed by the
16 nonparticipating provider and:

17 1. Reimbursements paid to the nonparticipating provider for the same
18 service rendered by the provider to other insureds for which the
19 provider is a nonparticipating provider; and

20 2. Reimbursements paid by the insurer to reimburse similarly qualified
21 nonparticipating providers for the same health care services in the
22 same region;

23 (b) The level of training, education, and experience of the nonparticipating
24 provider;

25 (c) The nonparticipating provider's historical data for billing charges for
26 comparable services with regard to other insureds;

27 (d) The circumstance and complexity of an insured's particular case, including

- 1 the time and place of the provision of service;
- 2 (e) An individual insured's medical conditions, co-morbidities, and other
- 3 medical characteristics;
- 4 (f) The usual and customary rate of the health care service provided;
- 5 (g) The history of network contracting between the parties; and
- 6 (h) Historical data for the usual and customary rate of the health care service
- 7 provided.
- 8 (10) Except as provided in subsection (13) of this section, any deadline under this
- 9 section may be extended by agreement of the parties.
- 10 (11) A reviewer shall provide a report to the commissioner, in a form and manner
- 11 prescribed by the commissioner, that sets forth:
- 12 (a) The amount determined by the reviewer to be the reasonable amount owed
- 13 to the nonparticipating provider for the unanticipated out-of-network care;

- 15 (b) The amount awarded under this section.
- 16 (12) Not later than thirty (30) days after the date of the reviewer's decision, an insurer
- 17 shall pay the nonparticipating provider any amount necessary to satisfy the
- 18 amount awarded under this section.
- 19 (13) Within forty-five (45) days of a reviewer's decision under this section, a party may
- 20 file a civil action to determine the amount owed, if any, by the insurer to the
- 21 nonparticipating provider for unanticipated out-of-network care under Section 3
- 22 of this Act.
- 23 (14) Information submitted by the parties to the reviewer shall not be subject to public
- 24 disclosure under KRS 61.800 to 61.878.
- 25 (15) Nothing in this section shall be construed to limit the admissibility, in any civil
- 26 action, of the reviewer's determination or the information provided during the
- 27 independent dispute resolution process in any civil action.

2 IS CREATED TO READ AS FOLLOWS:

3 (1) Any health plan or health plan sponsor not otherwise required to comply with

8 Sections 3 and 4 of this Act may elect, on an annual basis, for Sections 3 and 4 of

11 section shall provide written notice of each election to the commissioner, in the
12 form and manner prescribed by the commissioner.

15 (1) An insurer shall provide written notice of any claim made for unanticipated out-

19 (b) The total amount the nonparticipating provider may bill the insured under

27 thereafter;

1 (b) If a participating health care provider's participation will be terminated or
 2 withdrawn prior to the date of the termination of the contract as a result of a

5 (c) If the insurer finds that a health care provider represents an imminent danger
 6 to an individual patient or to the public health, safety, or welfare, the medical

9 (9) Meet all requirements provided under KRS 304.17A-600 to 304.17A-633 and KRS
 10 304.17A-700 to 304.17A-730; and

11 **(10) Notify the covered person that:**

12 **(a) Some health care providers may not be included in the health benefit plan's**

14 **(b) Nonparticipating providers may balance bill the covered person for**
 15 **amounts not paid by the health benefit plan unless the health care services**
 16 **are subject to the balance billing prohibition under Section 3 of this Act.**

3 to protect the confidentiality of each individual employee; however,
4 confidentiality assertions shall not relieve a carrier from the requirement of
5 providing stipulated data to the Commonwealth.

6 (e) The Personnel Cabinet shall develop the necessary techniques and capabilities
7 for timely analysis of data received from carriers and, to the extent possible,
8 provide in the request-for-proposal specifics relating to data requirements,
9 electronic reporting, and penalties for noncompliance. The Commonwealth
10 shall own the enrollment, claims, and utilization data provided by each carrier
11 and shall develop methods to protect the confidentiality of the individual. The
12 Personnel Cabinet shall include in the October annual report submitted
13 pursuant to the provisions of KRS 18A.226 to the Governor, the General
14 Assembly, and the Chief Justice of the Supreme Court, an analysis of the
15 financial stability of the program, which shall include but not be limited to
16 loss ratios, methods of risk adjustment, measurements of carrier quality of
17 service, prescription coverage and cost management, and statutorily required
18 mandates. If state self-insurance was available as a carrier option, the report
19 also shall provide a detailed financial analysis of the self-insurance fund
20 including but not limited to loss ratios, reserves, and reinsurance agreements.

21 (f) If any agency participating in the state-sponsored employee health insurance
22 program for its active employees terminates participation and there is a state
23 appropriation for the employer's contribution for active employees' health
24 insurance coverage, then neither the agency nor the employees shall receive
25 the state-funded contribution after termination from the state-sponsored
26 employee health insurance program.

27 (g) Any funds in flexible spending accounts that remain after all reimbursements

1 have been processed shall be transferred to the credit of the state-sponsored
2 health insurance plan's appropriation account.

5 portion of the health insurance premium. For any participating entity that used
