6 (5) "Discrimination" means any direct or indirect act or practice of exclusion,  
7 distinction, restriction, segregation, limitation, refusal, denial, or any other act or  
8 practice of differentiation or preference in the treatment of a person or persons, or  
9 the aiding, abetting, inciting, coercing, or compelling thereof made unlawful under  
10 this chapter;~~[-]~~

11 (6) "Discriminatory housing practice" means an act that is unlawful under Section  
12 18, 19, 20, 21, or 23 of this Act;~~[Real property" includes buildings, structures, real~~  
13 ~~estate, lands, tenements, leaseholds, cooperatives, condominiums, and~~  
14 ~~hereditaments, corporeal and incorporeal, or any interest in the above.]~~

15 (7) (a) "Familial status" means one (1) or more individuals who have not attained  
16 the age of eighteen (18) years and are domiciled with:

17 1. A parent or another person having legal custody of the individual or  
18 individuals; or

19 2. The designee of a parent or other person having custody, with the  
20 written permission of the parent or other person.

21 (b) The protection afforded against discrimination on the basis of familial  
22 status shall apply to any person who is pregnant or is in the process of  
23 securing legal custody of any individual who has not attained the age of  
24 eighteen (18) years;~~["Housing accommodations" includes improved and~~

3 (8) **"Family" includes a single individual;**[Real estate operator" means any individual

6 joint stock companies, trusts, unincorporated organizations, trustees in bankruptcy,  
7 receivers, or other legal or commercial entity, the county, or any of its agencies, that  
8 is engaged in the business of selling, purchasing, exchanging, renting, or leasing  
9 real estate, or the improvements thereon, including options, or that derives income,  
10 in whole or in part, from the sale, purchase, exchange, rental, or lease of real estate;  
11 or an individual employed by or acting on behalf of any of these.]

12 (9) **"Financial institution" means a bank, banking organization, mortgage company,**  
13 **insurance company, or other lender to whom application is made for financial**  
14 **assistance for the purchase, lease, acquisition, construction, rehabilitation,**  
15 **repair, maintenance, or improvement of real property, or an individual employed**  
16 **by or acting on behalf of any of these;**[Real estate broker" or "real estate salesman"  
17 means any individual, whether licensed or not, who, on behalf of others, for a fee,  
18 commission, salary, or other valuable consideration, or who with the intention or  
19 expectation of receiving or collecting the same, lists, sells, purchases, exchanges,  
20 rents, or leases real estate, or the improvements thereon, including options, or who  
21 negotiates or attempts to negotiate on behalf of others such an activity; or who  
22 advertises or holds himself out as engaged in these activities; or who negotiates or  
23 attempts to negotiate on behalf of others a loan secured by mortgage or other  
24 encumbrance upon a transfer of real estate, or who is engaged in the business of  
25 charging an advance fee or contracting for collection of a fee in connection with a  
26 contract whereby he undertakes to promote the sale, purchase, exchange, rental, or  
27 lease of real estate through its listing in a publication issued primarily for this

1        purpose; or any person employed by or acting on behalf of any of these.]

2        (10) **"Gender identity" means having or being perceived as having a gender identity or**  
 3        **expression, whether or not traditionally associated with the sex assigned to that**  
 4        **person at birth;**[Financial institution" means bank, banking organization, mortgage  
 5        company, insurance company, or other lender to whom application is made for  
 6        financial assistance for the purchase, lease, acquisition, construction, rehabilitation,  
 7        repair, maintenance, or improvement of real property, or an individual employed by  
 8        or acting on behalf of any of these.]

9        (11) **"Housing accommodations" includes improved and unimproved property and**  
 10        **means any building, structure, lot, or portion thereof which is used or occupied,**  
 11        **or is intended, arranged, or designed to be used or occupied, as the home or**  
 12        **residence of one (1) or more families, and any vacant land which is offered for**  
 13        **sale or lease for the construction or location thereon of any such building or**  
 14        **structure;**

15        **(12)** "Licensing agency" means any public or private organization which has as one (1)  
 16        of its duties the issuing of licenses or the setting of standards which an individual  
 17        must hold or must meet as a condition to practicing a particular trade or profession  
 18        or to obtaining certain employment within **this Commonwealth**[the state] or as a  
 19        condition to competing effectively with an individual who does hold a license or  
 20        meet the standards;[.]

 25 **(b) The selling, brokering, or appraising of real property, except that a person**

 8            homosexuality, or bisexuality; and

9            (20) "To rent" means to lease, to sublease, to let, or otherwise to grant for a  
 10            consideration the right to occupy premises not owned by the occupant.

11            ➔Section 2. KRS 344.020 is amended to read as follows:

12            (1) The general purposes of this chapter are:

13            (a) To provide for execution within the Commonwealth[~~state~~] of the policies  
 14            embodied in the [~~Federal~~] Civil Rights Act of 1964, Pub. L. No. 88-352, as  
 15            amended [~~(78 Stat. 241), Title VIII of the Federal Civil Rights Act of 1968~~  
 16            ~~(82 Stat. 81)]], the Fair Housing Act, Pub. L. No. 90-284, as amended [~~(42~~  
 17            ~~U.S.C. 360)]], the [~~Federal~~] Age Discrimination in Employment Act of 1967,  
 18            Pub. L. No. 90-202, as amended [~~(81 Stat. 602)]], the Americans with  
 19            Disabilities Act of 1990, Pub. L. No. [~~(P.L.) 101-336~~], as amended, and the  
 20            Civil Rights Act of 1991, Pub. L. No. 102-166 [~~as amended (P.L. 102-166,~~

22            (b) To safeguard all individuals within the Commonwealth[~~state~~] from  
 23            discrimination because of familial status, race, color, religion, national origin,  
 24            sex, sexual orientation, gender identity, age forty (40) and over, or because of  
 25            the person's status as a qualified individual with a disability as defined in [~~]~~  
 26            ~~KRS 344.010 and~~ KRS 344.030; thereby to protect their interest in personal  
 27            dignity and freedom from humiliation, to make available to the

1            Commonwealth<sup>[state]</sup> their full productive capacities, to secure the  
 2            Commonwealth<sup>[state]</sup> against domestic strife and unrest which would menace  
 3            its democratic institutions, to preserve the public safety, health, and general  
 4            welfare, and to further the interest, rights, and privileges of individuals within  
 5            the Commonwealth<sup>[state]</sup>; **and**

6            (c) To establish as the policy of the Commonwealth the safeguarding of the rights  
 7            of an individual selling or leasing his primary residence through private sale  
 8            without the aid of any real estate operator, broker, or salesman and without  
 9            advertising or public display.

10          (2) This chapter shall be construed to further the general purposes stated in this section  
 11          and the special purposes of the particular provision involved.

12          (3) Nothing in this chapter shall be construed as indicating an intent to exclude local  
 13          laws on the same subject matter not inconsistent with this chapter.

14          (4) Nothing contained in this chapter shall be deemed to repeal any other law of this  
 15          Commonwealth<sup>[state]</sup> relating to discrimination because of familial status, race,  
 16          color, religion, national origin, sex, **sexual orientation, gender identity**, age forty  
 17          (40) and over, or because of the person's status as a qualified individual with a  
 18          disability as defined in KRS 344.030.

19          ➔Section 3. KRS 344.025 is amended to read as follows:

20          No provision in KRS Chapter 18A shall be construed to preclude any classified or  
 21          unclassified state employee from appealing to the personnel board any action alleged to  
 22          be in violation of laws prohibiting discrimination based on **an individual's**<sup>[a person's</sup>  
 23          ~~status as a qualified individual with a disability,]~~ sex, **sexual orientation, gender identity**,  
 24          age, religion, ~~or~~ race, or national origin, **or because the person is a qualified individual**  
 25          **with a disability as defined in KRS 344.030**, in accordance with this chapter.

26          ➔Section 4. KRS 344.040 is amended to read as follows:

27          (1) It is an unlawful practice for an employer:



- 1 (a) To fail or refuse to hire, or to discharge any individual, or otherwise to  
2 discriminate against an individual with respect to compensation, terms,  
3 conditions, or privileges of employment, because of the individual's race,  
4 color, religion, national origin, sex, sexual orientation, gender identity, age  
5 forty (40) and over, because the person is a qualified individual with a  
6 disability, or because the individual is a smoker or nonsmoker, as long as the  
7 individual~~person~~ complies with any workplace policy concerning smoking;
- 8 (b) To limit, segregate, or classify employees in any way which would deprive or  
9 tend to deprive an individual of employment opportunities or otherwise  
10 adversely affect status as an employee, because of the individual's race, color,  
11 religion, national origin, sex, sexual orientation, gender identity, or age forty  
12 (40) and over, because the person is a qualified individual with a disability, or  
13 because the individual is a smoker or nonsmoker, as long as the  
14 individual~~person~~ complies with any workplace policy concerning smoking;
- 15 (c) To fail to make reasonable accommodations for any employee with limitations  
16 related to pregnancy, childbirth, or a related medical condition who requests  
17 an accommodation, including but not limited to the need to express breast  
18 milk, unless the employer can demonstrate the accommodation would impose  
19 an undue hardship on the employer's program, enterprise, or business. The  
20 following shall be required as to reasonable accommodations:
- 21 1. An employee shall not be required to take leave from work if another  
22 reasonable accommodation can be provided;
  - 23 2. The employer and employee shall engage in a timely, good faith, and  
24 interactive process to determine effective reasonable accommodations;  
25 and
  - 26 3. If the employer has a policy to provide, would be required to provide, is  
27 currently providing, or has provided a similar accommodation to other

1 classes of employees, then a rebuttable presumption is created that the  
2 accommodation does not impose an undue hardship on the employer; or

3 (d) To require as a condition of employment that any employee or applicant for  
4 employment abstain from smoking or using tobacco products outside the  
5 course of employment, as long as the individual~~person~~ complies with any  
6 workplace policy concerning smoking.

7 (2) (a) A difference in employee contribution rates for smokers and nonsmokers in  
8 relation to an employer-sponsored health plan shall not be deemed to be an  
9 unlawful practice in violation of this section.

10 (b) The offering of incentives or benefits offered by an employer to employees  
11 who participate in a smoking cessation program shall not be deemed to be an  
12 unlawful practice in violation of this section.

13 (3) (a) An employer shall provide written notice of the right to be free from  
14 discrimination in relation to pregnancy, childbirth, and related medical  
15 conditions, including the right to reasonable accommodations, to:

- 16 1. New employees at the commencement of employment; and
- 17 2. Existing employees not later than thirty (30) days after June 27, 2019.

18 (b) An employer shall conspicuously post a written notice of the right to be free  
19 from discrimination in relation to pregnancy, childbirth, and related medical  
20 conditions, including the right to reasonable accommodations, at the  
21 employer's place of business in an area accessible to employees.

22 ➔Section 5. KRS 344.050 is amended to read as follows:

23 (1) It is an unlawful practice for an employment agency to fail or refuse to refer for  
24 employment~~[,]~~ or to otherwise~~to~~ discriminate against~~[,]~~ an individual because of~~]~~  
25 ~~his~~ race, color, religion, national origin, sex, sexual orientation, gender identity, or  
26 age forty (40) and over, or because the person is a qualified individual with a  
27 disability, or to classify or refer for employment an individual because of~~on the~~

1 basis of disability,] race, color, religion, national origin, sex, **sexual orientation,**  
 2 **gender identity,** or age [~~between~~] forty (40) and **over, or because the person is a**  
 3 **qualified individual with a disability** [~~seventy (70)]].~~

4 (2) It is an unlawful practice for a licensing agency to refuse to license, or to bar or  
 5 terminate from licensing an individual because of race, color, religion, national  
 6 origin, sex, **sexual orientation, gender identity,** or age forty (40) and over, or  
 7 because the person is a qualified individual with a disability.

8 ➔Section 6. KRS 344.060 is amended to read as follows:

9 It is an unlawful practice for a labor organization:

10 (1) To exclude or to expel from its membership[~~]~~ or **to** otherwise [~~to~~] discriminate  
 11 against[~~]~~ a member, or applicant for membership, because of race, color, religion,  
 12 national origin, sex, **sexual orientation, gender identity,** or age forty (40) and over,  
 13 or because the person is a qualified individual with a disability.

14 (2) To limit, segregate, or classify its membership, or to classify or fail to refer  
 15 for employment an individual, in any way which would deprive or tend to deprive  
 16 an individual of employment opportunities, or would limit such employment  
 17 opportunities or otherwise adversely affect the status as an employee or as an  
 18 applicant for employment, because of race, color, religion, national origin, sex,  
 19 **sexual orientation, gender identity,** or age forty (40) and over, or because the  
 20 person is a qualified individual with a disability.

21 (3) To cause or attempt to cause an employer to discriminate against an individual in  
 22 violation of this section.

23 ➔Section 7. KRS 344.070 is amended to read as follows:

24 It is an unlawful practice for an employer, labor organization, or joint labor-management  
 25 committee controlling apprenticeship or other training or retraining, including on-the-job  
 26 training programs, to discriminate against an individual because of race, color, religion,  
 27 national origin, sex, **sexual orientation, gender identity,** or age forty (40) and over, or

1 because the person is a qualified individual with a disability in admission to or  
2 employment in, any program established to provide apprenticeship or other training.

3 →Section 8. KRS 344.080 is amended to read as follows:

4 It is an unlawful practice for an employer, labor organization, licensing agency, or  
5 employment agency to print or publish or cause to be printed or published a notice or  
6 advertisement relating to employment by such an employer or membership in or any  
7 classification or referral for employment by the employment or licensing agency,  
8 indicating any preference, limitation, specification, or discrimination, based on race,  
9 color, religion, national origin, sex, **sexual orientation, gender identity,** or age forty (40)  
10 and over, or because the person is a qualified individual with a disability, except that such  
11 a notice or advertisement may indicate a preference, limitation, or specification based on  
12 religion, national origin, sex, or age forty (40) and over, or because the person is a  
13 qualified individual with a disability, when religion, national origin, sex, or age forty (40)  
14 and over, or because the person is a qualified individual with a disability, is a bona fide  
15 occupational qualification for employment.

16 →Section 9. KRS 344.100 is amended to read as follows:

17 ~~[Notwithstanding] Any [other]~~ provision of this chapter **to the contrary notwithstanding,**  
18 it is not an unlawful practice for an employer to apply different standards of  
19 compensation, or different terms, conditions, or privileges of employment pursuant to a  
20 bona fide seniority or merit system, or a system which measures earnings by quantity or  
21 quality of production or to employees who work in different locations, if the differences  
22 are not the result of an intention to discriminate because of race, color, religion, national  
23 origin, sex, **sexual orientation, gender identity,** or age forty (40) and over, or because the  
24 person is a qualified individual with a disability, nor is it an unlawful practice for an  
25 employer to give and to act upon the results of any professionally developed ability test  
26 provided that the test, its administration, or action upon the results **thereof** is not  
27 designed, intended, or used to discriminate because of race, color, religion, national

1 origin, sex, **sexual orientation, gender identity**, or age forty (40) and over, or because the  
2 person is a qualified individual with a disability.

3 →Section 10. KRS 344.110 is amended to read as follows:

4 (1) Nothing~~[contained]~~ in this chapter requires an employer, employment agency, labor  
5 organization, or joint labor-management committee subject to this chapter to grant  
6 preferential treatment to an individual or to a group because of the race, color,  
7 religion, national origin, sex, **sexual orientation, gender identity**, or age forty (40)  
8 and over, or because the person is a qualified individual with a disability, of the  
9 individual or group on account of an imbalance which may exist with respect to the  
10 total number or percentage of **individuals**~~[persons]~~ of any race, color, religion,  
11 national origin, sex, **sexual orientation, gender identity**, or age forty (40) and over,  
12 or because the person is a qualified individual with a disability, employed by an  
13 employer, referred or classified for employment by an employment agency or labor  
14 organization, admitted to membership or classified by a labor organization, or  
15 admitted to, or employed in, an apprenticeship or other training program, in  
16 comparison with the total number or percentage of **individuals**~~[persons]~~ of race,

- 23 (b) State compliance with federal regulations.
- 24 (c) Termination of the employment of any person who is unable to perform the  
25 essential functions of the job, with or without reasonable accommodation.
- 26 (d) Any post-job-offer physical or medical examinations of applicants or  
27 employees which an employer requires to determine their ability to perform

1 the essential functions of the job, with or without reasonable accommodation.  
2 (e) An employer, labor organization, or employment agency from observing the  
3 terms of a bona fide seniority system or any bona fide employee benefit plan  
4 such as a retirement, pension, or insurance plan which is not a subterfuge to  
5 evade the purposes of this chapter, except that no such employee benefit plan  
6 shall excuse the failure to hire any individual.

22 eligible of his action and the reasons therefor, together with his right of appeal. An  
23 eligible's name shall be restored to the register upon presentation of reasons  
24 satisfactory to the secretary or in accordance with the decision of the board.

25 (14) (a) Any employee, applicant for employment, or eligible on a register, who  
26 believes that he has been discriminated against, may appeal to the board.

27 (b) Any applicant whose application for admission to an open-competitive

1 examination has been rejected shall be notified of this rejection and the  
2 reasons therefor and may appeal to the board for reconsideration of his  
3 qualifications and for admission to the examination. Applicants may be  
4 conditionally admitted to an examination by the secretary pending  
5 reconsideration by the board.

6 (c) Any applicant who has taken an examination may appeal to the board for a  
7 review of his rating in any part of the examination to assure that uniform  
8 rating procedures have been applied equally and fairly.

9 (d) An appeal to the board by applicants or eligibles under subsections (11) and  
10 (13) of this section and under this subsection shall be filed in writing with the  
11 executive director not later than thirty (30) calendar days after the notification  
12 of the action in question was mailed.

13 (15) An evaluation may be appealed to the board if an employee has complied with the  
14 review procedure established in KRS 18A.110(7)(j).

15 (16) (a) Appeals to the board shall be in writing on an appeal form prescribed by the  
16 board. Appeal forms shall be available at the employee's place of work. The  
17 Personnel Cabinet shall be responsible for the distribution of these forms.

18 (b) The appeal form shall be attached to any notice, or copy of any notice, of  
19 dismissal, demotion, suspension, fine, involuntary transfer, or other  
20 penalization, reallocation, or notice of any other action an employee may  
21 appeal under the provisions of this section. The appeal form shall instruct the  
22 employee to state whether he is a classified or unclassified employee, his full  
23 name, his appointing authority, work station address and telephone number,  
24 and, if he has retained counsel at the time he files an appeal, the name,  
25 address, and telephone number of his attorney.

26 (c) The form shall also instruct a classified employee to state the action he is  
27 appealing in a short, plain, concise statement of the facts. The form shall

1           instruct an unclassified employee to make a short, plain, concise statement of  
2           the reason for the appeal and the cause given for his dismissal.

3           (d) Upon receipt of the appeal by the board, the appointing authority and the  
4           Personnel Cabinet shall be notified and the board shall schedule a hearing.

5 (17) All administrative hearings conducted by the board shall be conducted in  
6           accordance with KRS Chapter 13B.

7 (18) (a) The board may deny a hearing to an employee who has failed to file an appeal  
8           within the time prescribed by this section; and to an unclassified employee  
9           who has failed to state the reasons for the appeal and the cause for which he  
10          has been dismissed. The board may deny any appeal after a preliminary  
11          hearing if it lacks jurisdiction to grant relief. The board shall notify the  
12          employee of its denial in writing and shall inform the employee of his right to  
13          appeal the denial under the provisions of KRS 18A.100.

14          (b) Any investigation by the board of any matter related to an appeal filed by an  
15          employee shall be conducted only upon notice to the employee, the  
16          employee's counsel, and the appointing authority. All parties to the appeal  
17          shall have access to information produced by the investigations and the  
18          information shall be presented at the hearing.

19 (19) Each appeal shall be decided individually, unless otherwise agreed by the parties  
20          and the board. The board shall not:

21          (a) Employ class action procedures; or

22          (b) Conduct test representative cases.

23 (20) Board members shall abstain from public comment about a pending or impending  
24          proceeding before the board. This shall not prohibit board members from making  
25          public statements in the course of their official duties or from explaining for public  
26          information the procedures of the board.

27 (21) An appeal to the board may be heard by the full board or one (1) or more of the

1 following: Its executive director, its general counsel, any nonelected member of the  
2 board, or any hearing officer secured by the board pursuant to KRS 13B.030.

3 (22) (a) If the board finds that the action complained of was taken by the appointing  
4 authority in violation of laws prohibiting favor for, or discrimination against,  
5 or bias with respect to, his political or religious opinions or affiliations or  
6 ethnic origin, or in violation of laws prohibiting discrimination because of  
7 such individual's sex, sexual orientation, gender identity, or age or disability,  
8 the appointing authority shall immediately reinstate the employee to his  
9 former position or a position of like status and pay, without loss of pay for the  
10 period of his penalization, or otherwise make the employee whole unless the  
11 order is stayed by the board or the court on appeal.

12 (b) If the board finds that the action complained of was taken without just cause,  
13 the board shall order the immediate reinstatement of the employee to his  
14 former position or a position of like status and pay, without loss of pay for the  
15 period of his penalization, or otherwise make the employee whole unless the  
16 order is stayed by the board or the court on appeal.

17 (c) If the board finds that the action taken by the appointing authority was  
18 excessive or erroneous in view of all the surrounding circumstances, the board  
19 shall direct the appointing authority to alter, modify, or rescind the  
20 disciplinary action.

21 (d) In all other cases, the board shall direct the appointing authority to rescind the  
22 action taken or otherwise grant specific relief or dismiss the appeal.

23 (23) If a final order of the board is appealed, a court shall award reasonable attorney fees  
24 to an employee who prevails by a final adjudication on the merits as provided by  
25 KRS 453.260. This award shall not include attorney fees attributable to the hearing  
26 before the board.

27 (24) When any employee is dismissed and not ordered reinstated after the appeal, the

1 board in its discretion may direct that his name be placed on an appropriate  
2 reemployment list for employment in any similar position other than the one from  
3 which he had been removed.

4 (25) After a final decision has been rendered by the board or court, an employee who  
5 prevails in his appeal shall be credited with the amount of leave time used for time  
6 spent at his hearing before the board or court. Employees who had an insufficient  
7 amount of leave time shall be credited with leave time equal to the amount of time  
8 spent at their hearings before the board or court.

9 (26) If the appointing authority appeals the final order of the board, unless the board  
10 rules otherwise, the reinstated employee shall remain in his former position, or a  
11 position of like status or pay, until the conclusion of the appeals process, at which  
12 time the appointing authority shall take action in accordance with the court order.

13 (27) After a final decision in a contested case has been rendered by the last  
14 administrative or judicial body to which the case has been appealed, the board shall  
15 make the decision available to the public in electronic format on its Web site and  
16 shall organize the decisions according to the statutory basis for which the appeal  
17 was based.

18 (28) For the purposes of subsections (2), (3), (4), (5), (6), and (7) of this section, the  
19 word "agency" means any agency not assigned to a cabinet for organizational  
20 purposes.

21 (29) Notwithstanding any other prescribed limitation of action, an employee that has  
22 been penalized, but has not received a written notice of his or her right to appeal as  
23 provided in this section, shall file his or her appeal with the Personnel Board within  
24 one (1) year from the date of the penalization or from the date that the employee  
25 reasonably should have known of the penalization.
