

1 AN ACT relating to health, welfare, and family services.

2 ***Be it enacted by the General Assembly of the Commonwealth of Kentucky:***

3 ➔Section 1. KRS 12.020 is amended to read as follows:

4 Departments, program cabinets and their departments, and the respective major  
5 administrative bodies that they include are enumerated in this section. It is not intended  
6 that this enumeration of administrative bodies be all-inclusive. Every authority, board,  
7 bureau, interstate compact, commission, committee, conference, council, office, or any  
8 other form of organization shall be included in or attached to the department or program  
9 cabinet in which they are included or to which they are attached by statute or statutorily  
10 authorized executive order; except in the case of the Personnel Board and where the  
11 attached department or administrative body is headed by a constitutionally elected  
12 officer, the attachment shall be solely for the purpose of dissemination of information and  
13 coordination of activities and shall not include any authority over the functions,  
14 personnel, funds, equipment, facilities, or records of the department or administrative  
15 body.

22 ➔Section 2. KRS 13B.020 is amended to read as follows:

- 23 (1) The provisions of this chapter shall apply to all administrative hearings conducted
- 24 by an agency, with the exception of those specifically exempted under this section.
- 25 The provisions of this chapter shall supersede any other provisions of the Kentucky
- 26 Revised Statutes and administrative regulations, unless exempted under this section,
- 27 to the extent these other provisions are duplicative or in conflict. This chapter

1 creates only procedural rights and shall not be construed to confer upon any person  
2 a right to hearing not expressly provided by law.

3 (2) The provisions of this chapter shall not apply to:

4 (a) Investigations, hearings to determine probable cause, or any other type of  
5 information gathering or fact finding activities;

6 (b) Public hearings required in KRS Chapter 13A for the promulgation of  
7 administrative regulations;

8 (c) Any other public hearing conducted by an administrative agency which is  
9 nonadjudicatory in nature and the primary purpose of which is to seek public  
10 input on public policy making;

11 (d) Military adjudicatory proceedings conducted in accordance with KRS Chapter  
12 35;

13 (e) Administrative hearings conducted by the legislative and judicial branches of  
14 state government;

15 (f) Administrative hearings conducted by any city, county, urban-county, charter  
16 county, or special district contained in KRS Chapters 65 to 109, or any other  
17 unit of local government operating strictly in a local jurisdictional capacity;

18 (g) Informal hearings which are part of a multilevel hearing process that affords  
19 an administrative hearing at some point in the hearing process if the  
20 procedures for informal hearings are approved and promulgated in accordance  
21 with subsections (4) and (5) of this section;

22 (h) Limited exemptions granted for specific hearing provisions and denoted by  
23 reference in the text of the applicable statutes or administrative regulations;

24 (i) Administrative hearings exempted pursuant to subsection (3) of this section;

25 (j) Administrative hearings exempted, in whole or in part, pursuant to  
26 subsections (4) and (5) of this section; and

27 (k) Any administrative hearing which was commenced but not completed prior to

- 6 (2) Oversee and submit Kentucky's annual applications to the Corporation for National  
7 Service, the federal funding authority, and other funding sources for the  
8 continuation and any expansion of the current Kentucky Serve initiative;
- 9 (3) Conduct a competitive application process to determine the organizations that will  
10 be awarded subgrants to operate national service programs;
- 11 (4) Fulfill any other responsibilities required by the Corporation for National Service  
12 and other funding sources; and
- 13 (5) Promulgate administrative regulations pursuant to KRS Chapter 13A to establish  
14 operational guidelines for Serve Kentucky.

15 ➔Section 75. KRS 403.212 is amended to read as follows:

- 16 (1) The following provisions and child support table shall be the child support  
17 guidelines established for the Commonwealth of Kentucky.
- 18 (2) The Cabinet for Health and Family Services shall:
- 19 (a) Promulgate an administrative regulation in accordance with KRS Chapter  
20 13A establishing a child support obligation worksheet; and
- 21 (b) Make accessible on its Web site a manual providing examples or illustrations  
22 of the application of the child support guidelines and the child support  
23 obligation worksheet.
- 24 (3) For the purposes of the child support guidelines:
- 25 (a) "Income" means actual gross income of the parent if employed to full capacity  
26 or potential income if unemployed or underemployed;
- 27 (b) "Gross income" includes income from any source, except as excluded in this



1 subsection, and includes but is not limited to income from salaries, wages,  
2 retirement and pension funds, commissions, bonuses, dividends, severance  
3 pay, pensions, interest, trust income, annuities, capital gains, Social Security  
4 benefits, workers' compensation benefits, unemployment insurance benefits,  
5 disability insurance benefits, Supplemental Security Income (SSI), gifts,  
6 prizes, and alimony or maintenance received. Specifically excluded are  
7 benefits received from means-tested public assistance programs, including but  
8 not limited to public assistance as defined under Title IV-A of the Federal  
9 Social Security Act, and food stamps;

10 (c) For income from self-employment, rent, royalties, proprietorship of a  
11 business, or joint ownership of a partnership or closely held corporation,  
12 "gross income" means gross receipts minus ordinary and necessary expenses  
13 required for self-employment or business operation. Straight-line  
14 depreciation, using Internal Revenue Service (IRS) guidelines, shall be the  
15 only allowable method of calculating depreciation expense in determining  
16 gross income. Specifically excluded from ordinary and necessary expenses for  
17 purposes of this guideline shall be investment tax credits or any other business  
18 expenses inappropriate for determining gross income for purposes of  
19 calculating child support. Income and expenses from self-employment or  
20 operation of a business shall be carefully reviewed to determine an

5 accordance with 45 C.F.R. sec. 302.56(c)(1)(ii), and as applied under  
6 subsection (5) of this section;

7 (e) 1. If there is a finding that a parent is voluntarily unemployed or  
8 underemployed, child support shall be calculated based on a  
9 determination of potential income, except that a finding of voluntary  
10 unemployment or underemployment and a determination of potential  
11 income shall not be made for a parent who is incarcerated, physically or  
12 mentally incapacitated, or is caring for a very young child, age three (3)  
13 or younger, for whom the parents owe a joint legal responsibility;

14 2. A court may find a parent is voluntarily unemployed or underemployed  
15 without finding that the parent intended to avoid or reduce the child  
16 support obligation; and

17 3. Imputation of potential income, when applicable, shall include  
18 consideration of the following circumstances of the parents, to the extent  
19 known:

20 a. Assets and residence;

21 b. Employment, earning history, and job skills;

22 c. Educational level, literacy, age, health, and criminal record that  
23 could impair the ability to gain or continue employment;

24 d. Record of seeking work;

25 e. Local labor market, including availability of employment for  
26 which the parent may be qualified and employable;

27 f. Prevailing earnings in the local labor market; and

- 1                   g. Other relevant background factors, including employment barriers;
- 2           (f) "Obligor" has the same meaning as in Section 8 of this Act~~[KRS 205.710]~~;
- 3           (g) "Imputed child support obligation" means the amount of child support the  
4           parent would be required to pay from application of the child support  
5           guidelines;
- 6           (h) Income statements of the parents shall be verified by documentation of both  
7           current and past income. Suitable documentation shall include, but shall not  
8           be limited to, income tax returns, paystubs, employer statements, or receipts  
9           and expenses if self-employed;
- 10          (i) "Combined monthly adjusted parental gross income" means the combined  
11          monthly gross incomes of both parents, less any of the following payments  
12          made by the parent:
- 13               1. The amount of pre-existing orders for current maintenance for prior  
14               spouses to the extent payment is actually made and the amount of  
15               current maintenance, if any, ordered paid in the proceeding before the  
16               court;
- 17               2. The amount of pre-existing orders of current child support for prior-born  
18               children to the extent payment is actually made under those orders; and
- 19               3. A deduction for the support to the extent payment is made, if a parent is  
20               legally responsible for and is actually providing support for other prior-

22               prior-born children reside with that parent, an "imputed child support  
23               obligation" shall be allowed in the amount which would result from

- 26          (j) "Split custody arrangement" means a situation where each parent has sole

1 her residence. Visitation only occurs when the child is in residence with the

3 (4) Any child support obligation shall be calculated by using the number of children for  
4 whom the parents share a joint legal responsibility.

5 (5) (a) Except as provided in paragraph (b) of this subsection, the child support  
6 obligation set forth in the child support guidelines table shall be divided  
7 between the parents in proportion to their combined monthly adjusted parental  
8 gross income.

9 (b) The child support obligation of an obligated parent whose monthly adjusted  
10 gross income is equal to or less than the amounts in subparagraphs 1. to 5. of  
11 this paragraph shall be calculated using the monthly adjusted gross income of  
12 the obligated parent alone to provide for the self-support reserve. The  
13 following monthly adjusted gross income amounts shall qualify an individual  
14 for the self-support reserve:

- 15 1. One thousand one hundred dollars (\$1,100) with one (1) child;
- 16 2. One thousand three hundred dollars (\$1,300) with two (2) children;
- 17 3. One thousand four hundred dollars (\$1,400) with three (3) children;
- 18 4. One thousand five hundred dollars (\$1,500) with four (4) or five (5)  
19 children; or
- 20 5. One thousand six hundred dollars (\$1,600) with six (6) or more children.

21 (c) The obligated parent shall pay the lesser support amount calculated in  
22 accordance with:

- 23 1. Paragraph (a) of this subsection;
- 24 2. Paragraph (b) of this subsection; and
- 25 3. As determined under KRS 403.2121 if the shared parenting time credit  
26 is applicable.

27 (6) The minimum amount of child support shall be sixty dollars (\$60) per month,

1           except as provided in KRS 403.2121(3).

2       (7) The court may use its judicial discretion in determining child support in  
3       circumstances where combined adjusted parental gross income exceeds the  
4       uppermost levels of the guideline table.

5       (8) The child support obligation in a split custody arrangement shall be calculated in  
6       the following manner:

7           (a) Two (2) separate child support obligation worksheets shall be prepared, one  
8           (1) for each household, using the number of children born of the relationship  
9           in each separate household, rather than the total number of children born of  
10          the relationship.

11          (b) The parent with the greater monthly obligation amount shall pay the  
12          difference between the obligation amounts, as determined by the worksheets,  
13          to the other parent.
