1 AN ACT relating to the Kentucky Horse Racing Commission.

## 2 Be it enacted by the General Assembly of the Commonwealth of Kentucky:

- 3 → Section 1. KRS 230.225 is amended to read as follows:
- The Kentucky Horse Racing Commission is created as an independent agency of state government to regulate the conduct of horse racing and pari-mutuel wagering on horse racing, and related activities within the Commonwealth of Kentucky. The racing commission shall be attached to the Public Protection Cabinet for administrative purposes.
- 9 (2) (a) The Kentucky Horse Racing Commission shall consist of fifteen (15)
  10 members appointed by the Governor, with the secretaries of the Public
  11 Protection Cabinet, Tourism, Arts and Heritage Cabinet, and Economic
  12 Development Cabinet, or their designees, serving as ex officio
  13 nonvoting[voting] members.
- 14 (b) Two (2) members shall have no financial interest in the business or industry 15 regulated.
- 16 (c) The members of the racing commission shall be appointed to serve for a term 17 of four (4) years, except the initial terms shall be staggered as follows:
  - 1. Five (5) members shall serve for a term of four (4) years;
  - 2. Five (5) members shall serve for a term of three (3) years; and
- 20 3. Five (5) members shall serve for a term of two (2) years.

- 21 (d) Any member appointed to fill a vacancy occurring other than by expiration of a term shall be appointed for the remainder of the unexpired term.
  - (e) In making appointments, the Governor may consider members broadly representative of the Thoroughbred industry and members broadly representative of the standardbred, quarter horse, Appaloosa, or Arabian industries. The Governor may also consider recommendations from the Kentucky Thoroughbred Owners and Breeders, Inc., the Kentucky Division of
