1 A CONCURRENT RESOLUTION making a formal application to Congress to call 2 a convention for the sole purpose of proposing for ratification an amendment to the 3 Constitution of the United States requiring a balanced federal budget. 4 WHEREAS, Article V of the Constitution of the United States mandates that upon the "Application of the Legislatures of two thirds of the several States," Congress shall 5 6 "call a Convention for proposing Amendments"; and 7 WHEREAS, the General Assembly deems that an amendment to the Constitution of 8 the United States requiring a balanced federal budget is necessary for the good of the 9 American people; 10 NOW, THEREFORE, 11 Be it resolved by the Senate of the General Assembly of the Commonwealth of 12 Kentucky, the House of Representatives concurring therein: 13 → Section 1. The General Assembly of the Commonwealth of Kentucky hereby 14 applies to the Congress of the United States, under the provisions of Article V of the 15 Constitution of the United States, for the calling of a convention of the states limited to 16 proposing an amendment to the Constitution of the United States requiring that in the 17 absence of a national emergency the total of all federal outlays made by Congress for any 18 fiscal year may not exceed the total of all estimated federal revenues for that fiscal year, 19 together with any related and appropriate fiscal restraints. 20 → Section 2. This application is to be considered as covering the balanced budget 21 amendment language of the presently outstanding balanced budget applications from 22 other states, including but not limited to previously adopted applications from Alabama, 23 Alaska, Arkansas, Colorado, Florida, Georgia, Indiana, Iowa, Kansas, Louisiana, 24 Maryland, Michigan, Mississippi, Missouri, Nebraska, Nevada, New Hampshire, New 25 Mexico, North Carolina, North Dakota, Ohio, Pennsylvania, South Dakota, Tennessee, 26 Texas, and Utah; and this application shall be aggregated with same for the purpose of 27 attaining the two-thirds of states necessary to require the calling of a convention for

proposing a balanced budget amendment, but shall not be aggregated with any applications on any other subject.

- → Section 3. This application constitutes a continuing application in accordance
   with Article V of the Constitution of the United States until the legislatures of at least
   two-thirds of the several states have made applications on the same subject. It supersedes
   all previous applications by the General Assembly on the same subject.
- Section 4. Copies of this Resolution shall be delivered by the Kentucky

  8 Secretary of State to the Speaker of the United States House of Representatives, the Clerk

  9 of the United States House of Representatives, the President of the United States Senate,

  10 the Secretary of the United States Senate, every member of Congress from Kentucky, and

  11 the presiding officer of each house of the legislatures of the several states, requesting their

  12 cooperation.
