1	A CONCURRENT RESOLUTION establishing the Abandoned Horse Task Force.
2	WHEREAS, abandoning horses on reclaimed mine sites and other remote areas of
3	the state has become a problem in the Commonwealth; and
4	WHEREAS, the problem first presented in 2015 and in response, the General
5	Assembly established the Free Roaming Horse Task Force in 2016; and
6	WHEREAS, through the work of the Free Roaming Horse Task Force, the public
7	learned that abandoned domestic horses quickly become feral, reproduce, and become
8	dangerous and unwieldly for animal control officers to capture; and
9	WHEREAS, abandoned feral horses roam in search of food and shelter, need
10	veterinary care, and are at risk of causing accidents and injuring themselves on reclaimed
11	coal mine sites; and
12	WHEREAS, there have been incidents where feral horses have run out in front of
13	automobiles causing a public safety hazard; and
14	WHEREAS, unfortunately in reaction to the difficulties in catching and removing
15	these horses, the problem has gone largely unattended leading to lawless actions such as
16	the recent shooting of abandoned horses in Floyd County, Kentucky, in 2019; and
17	WHEREAS, the General Assembly finds that reconvening a task force of various
18	stakeholder groups is necessary and appropriate to produce a consensus for humanely
19	addressing the problem of individuals abandoning their horses and removing those horses
20	from these remote, reclaimed mine sites;
21	NOW, THEREFORE,
22	Be it resolved by the Senate of the General Assembly of the Commonwealth of
23	Kentucky, the House of Representatives concurring therein:
24	→ Section 1. The Legislative Research Commission is hereby directed to establish
25	the Abandoned Horse Task Force to discuss the problems caused by the growing
26	population of abandoned horses, ways to stop individuals from abandoning their horses
27	and ways to remove the horses that are currently running at large, becoming feral, and

- 3 the final membership of the task force being subject to the consideration and approval of

- 6 to serve as co-chair;
- 7 (2) The chair of the Senate Standing Committee on Natural Resources and Energy
- 8 to serve as co-chair;
- 9 (3) Two additional members of the Senate, one to be appointed by the President
- of the Senate, and one to be appointed by the Minority Floor Leader of the Senate;
- 11 (4) Two additional members of the House of Representatives, one to be appointed
- by the Speaker of the House of Representatives, and one to be appointed by the Minority
- 13 Floor Leader of the House of Representatives;
- 14 (5) The state veterinarian, or his or her designee;
- 15 (6) The commissioner of the Department of Fish and Wildlife Resources, or his or
