

1 A RESOLUTION adjourning the Senate in honor of 2020-2021 Kentucky  
2 Optometric Association President Dr. Tyler Hudson.

3 WHEREAS, this honorable body commends those doctors who go above and  
4 beyond their field of study and become foundations in their chosen disciplines; and

5 WHEREAS, Dr. Tyler Hudson is one such doctor. An optometrist who grew up in  
6 Patoka, Indiana, Dr. Hudson has practiced optometry since 2009. He received his  
7 Bachelor of Science degree in biology from the University of Evansville, and earned his  
8 Doctorate of Optometry degree from Indiana University; and

9 WHEREAS, Dr. Hudson and his wife, Dr. Kimberly Hudson, also an optometrist,  
10 own Hudson Eye Center in Walton, Kentucky, and have a second location in  
11 Lawrenceburg, Indiana, focusing on primary eye care, ocular disease treatment and  
12 management, use of specialty contact lenses, and emergency eye services; and

13 WHEREAS, in the spring of 2020, Dr. Hudson was named President of the  
14 Kentucky Optometric Association (KOA). He has been a KOA board member since 2005,  
15 and was awarded the KOA's Young Optometrist of the Year in 2015. Dr. Hudson is a  
16 member of the American Optometric Association (AOA) and serves on the AOA's  
17 Meetings Center Committee. Dr. Hudson participates in the Kentucky Vision Project and  
18 donates eye exams to qualifying citizens; and

19 WHEREAS, Dr. Hudson is known as a trusted and exemplary doctor and a  
20 committed volunteer throughout his community; and

21 WHEREAS, this body commends Dr. Tyler Hudson for his years of service as an  
22 optometrist and for being named the 2020-2021 Kentucky Optometric Association  
23 President; wishes him the best of luck as he continues his term, and duly honors his wife,  
24 Kimberly, and their two children, Lincoln and Brynn;
