2       Renae Hanks.

3           WHEREAS, Kara Renae Hanks was born to Patrick Dean and Pamela Kay Glenn  
4       on May 20, 1979, in Fort Thomas, Kentucky; and

5           WHEREAS, Kara Hanks trained and worked as a legal secretary for a short time,  
6       before finding her true calling as a servant to the Lord, a dedicated homemaker, and a  
7       stay-at-home mother; and

8           WHEREAS, Kara Hanks dedicated her life to the care of not only her family, but  
9       also her church family at Grace Fellowship; and

10          WHEREAS, Kara Hanks led bible study classes and ministered to many young  
11       people in the youth program at Grace Fellowship; and

12          WHEREAS, Kara Hanks was a voracious reader and devoured as many books as  
13       she could get her hands on including her favorites, Louis L'Amour's westerns and *The*  
14       *Chronicles of Narnia* series by C.S. Lewis. However, the one book she could not live  
15       without was *The Holy Bible*; and

17       journaling and writing notes in the margins of her Bible. To take away her Bible would

21          WHEREAS, Kara Hanks is survived by her loving husband, Benjamin Hanks; her
