

1           A RESOLUTION recognizing and proclaiming Boone Trace as a road of historical  
2 significance worthy of being further identified, preserved, protected, marked, and made  
3 accessible to the public.

4           WHEREAS, Daniel Boone and his party of trailblazers departed from Long Island  
5 on the Holston River, near what is today known as Kingsport, Tennessee, in March 1775,  
6 and passed through the Cumberland Gap into present-day Kentucky, with their journey  
7 terminating at Boonesborough; and

8           WHEREAS, by traversing that route, they demonstrated to the world that others  
9 could venture into the western area of the continent, claim land, and survive; and

10          WHEREAS, the road created by Daniel Boone and fellow members of his group  
11 came to be known as Boone Trace; and

12          WHEREAS, Boone Trace was the first road opened into land that was to become  
13 Kentucky; and

14          WHEREAS, some 48 million present-day Americans can trace their genealogy to  
15 ancestors who came through the Cumberland Gap; and

16          WHEREAS, the Wilderness Road, a designed wagon road terminating in  
17 Louisville, evolved from the original Boone Trace bridle path to become the predominant  
18 arterial road over which travelers entered the West; and

19          WHEREAS, Boone Trace appears on the Tourism Cabinet's Office of Adventure  
20 Tourism's recently released Cross Kentucky Master Trail Plan Map as one of eleven  
21 currently designated major routes; and

22          WHEREAS, engraved on a monument at Daniel Boone Park, Flat Lick, Kentucky,  
23 are the words, "No other trail is of greater historical significance to the founding of  
24 Kentucky and opening of the West";

25          NOW, THEREFORE,

26          *Be it resolved by the Senate of the General Assembly of the Commonwealth of*  
27          *Kentucky:*

1           ➔Section 1. This honorable body hereby recognizes the historical significance of  
2 Boone Trace to the settlement of Kentucky and westward lands, and finds that Boone  
3 Trace is worthy of being further identified, preserved, protected, marked, and made  
4 accessible to the public.

5           ➔Section 2. The Transportation Cabinet is encouraged to utilize the experience  
6 and expertise of the Kentucky Historical Society and the Kentucky Heritage Council, and  
7 to seek funding, both public and private, to appropriately designate and mark highways  
8 that most closely parallel the original path of Boone Trace.

9           ➔Section 3. The Tourism, Arts and Heritage Cabinet is encouraged to continue  
10 the progress made by the Office of Adventure Tourism in developing Boone Trace as one  
11 of the major trail routes, and to promote trail connectivity between communities located  
12 on or near Boone Trace in order to enhance tourism development, historic appreciation,  
13 and outdoor recreation.

14           ➔Section 4. The Clerk of the Senate is directed to transmit a copy of this  
15 Resolution to the Governor of the Commonwealth, the secretary of the Transportation  
16 Cabinet, the secretary of the Tourism, Arts and Heritage Cabinet, and Dr. John Fox,
