2 Ligouri Newcomb.

3           WHEREAS, John Newcomb was born in New Hope, Kentucky, on March 27,  
4 1927, the cherished son of the late John C. and Alice Bowling Newcomb; and

5           WHEREAS, John Newcomb was a proud veteran of the United States Navy; and

6           WHEREAS, John Newcomb worked with his father at J.C. Newcomb and Son,  
7 which later became Newcomb Oil Co. He served as chairman of the company and was  
8 active in the business until his passing; and

9           WHEREAS, John Newcomb was a pillar of the Bardstown community. He was an  
10 inductee into the St. Joe Prep Hall of Fame and a recipient of the Bardstown-Nelson  
11 County Chamber of Commerce Man of the Year in 2001, a Distinguished Honoree of the  
12 Catholic Education Foundation in 2003, and had served for 42 years on the board of  
13 Wilson and Muir Bank; and

14           WHEREAS, John Ligouri Newcomb, beloved husband, father, stepfather, and  
15 grandfather, departed this earthly life on March 15, 2017, leaving his family, friends, and  
16 all those whose lives he touched in solemn mourning; and

17           WHEREAS, John Newcomb was preceded in death by his first wife, Edna Boone  
18 Newcomb; daughter, Rose Alice Newcomb; and grandson, David C. Newcomb. He is  
19 survived by his wife of 19 years, Sally O'Daniel Johnson; daughters, Ann Newcomb and  
20 her husband, Phil Kirk, Cathy Mendenhall and her husband, Tom, and Barbara Greenwell  
21 and her husband, Chuck Mattingly; sons, Jack Newcomb and his wife, Michelle, and Bill  
22 Newcomb and his wife, Karen; stepsons, Pat Johnson and his wife, Anita, Paul Johnson  
23 and his wife, Stephanie, and Daniel Johnson and his wife, Vicki; 25 grandchildren; 20
