1	A RESOLUTION honoring Providence Christian Church (Disciples of Christ) in
2	Nicholasville on the occasion of its bicentennial.
3	WHEREAS, the Great Awakening in the American colonies that began in the 1730s
4	was of profound significance, challenging religious authority while fostering a deep
5	spiritual conviction; and
6	WHEREAS, Lewis Craig, pastor of a Separate Baptist church in Upper
7	Spottsylvania, Virginia, organized in 1767, was jailed for 43 days for "holding unlawful
8	conventicles and preaching the gospel contrary to the law"; and
9	WHEREAS, Mr. Craig's arrest led him on a long, hard journey following an old
10	buffalo trail to relocate the entire congregation of 200 members along with the old Bible,
11	the communion set, and the church record books to the banks of South Elkhorn Creek in
12	Fayette County, Kentucky, settling there in 1783. He ministered there for nine years; and
13	WHEREAS, on January 13, 1817, members of South Elkhorn Baptist Church met at
14	Daniel Bryan's home, called Waveland, to discuss the idea of starting the fifth daughter
15	congregation in the area, and a committee was appointed to petition members; and
16	WHEREAS, on February 22, 70 members were dismissed from South Elkhorn to
17	constitute a new church, Providence Baptist Church, three days later baptizing the first
18	new convert, George Farra, and soon after calling the first pastor, Brother Jeremiah
19	Vardman, who served for nine years for an annual salary of \$37.50; and
20	WHEREAS, in April 1828 the church board voted to celebrate the Lord's Supper at
21	every worship service instead of twice a year and rejected doctrines and creeds following
22	the ranks of the reformers led by Alexander Campbell; and
23	WHEREAS, Jeremiah Vardman brought forth a resolution in 1830 to have
24	Providence removed from the Elkhorn Baptist Association, therefore causing Providence
25	to affiliate with the Christian Church; and
26	WHEREAS, erected in 1819, the first building was severely damaged in 1849 by a
27	tornado and rebuilt the following year. A schoolhouse was built on the church grounds in

1 1828, a new church building was constructed in 1917 in the adjacent lot, and a beautiful

- 2 new building was constructed in 2007 that merged antique artifacts from the church's
- 3 history with new furnishings and equipment; and
- 4 WHEREAS, Providence Christian Church (Disciples of Christ) has been an
- 5 important and active part of the communities of Jessamine County and southern Fayette
- 6 County for 200 years, serving through education, worship, charity, and volunteering, and
- 7 spreading the Gospel of Jesus Christ;
- 8 NOW, THEREFORE,
- 9 Be it resolved by the Senate of the General Assembly of the Commonwealth of
- 10 Kentucky:
- → Section 1. The Senate hereby recognizes the 200th anniversary of Providence
- 12 Christian Church (Disciples of Christ) and commends the congregation for two centuries
- of Christian service in the Commonwealth of Kentucky.
- → Section 2. When the Senate adjourns this day, it does so in honor of Providence
- 15 Christian Church (Disciples of Christ).
