

1           A RESOLUTION adjourning the Senate in honor and loving memory of Carolyn M.  
2 Miller-Cooper.

3           WHEREAS, Carolyn M. Miller-Cooper was a proud graduate of Hunter College;  
4 the University of Kentucky College of Law; and the McGeorge School of Law, where she  
5 obtained a Master of Law degree; and

6           WHEREAS, Carolyn Miller-Cooper was an educator at Jefferson Community and  
7 Technical College and Brown Mackie College, a mentor with the Black Achievers  
8 Program, and an active member of EMERGE Kentucky, an organization that trains and  
9 encourages Democratic women to run for public office; and

10           WHEREAS, Carolyn Miller-Cooper was the executive director of the Louisville  
11 Metro Human Relations Commission and a senior member of Louisville Mayor Greg  
12 Fischer's administration, where she oversaw the agency enforcing antidiscrimination  
13 laws. For her courageous and groundbreaking career in civil rights, she was a 2014  
14 inductee into the Kentucky Civil Rights Hall of Fame; and

15           WHEREAS, Carolyn Miller-Cooper was a member of Evangel World Prayer Center  
16 and a beloved servant of Christ; and

17           WHEREAS, Carolyn Miller-Cooper, a tireless public servant who chose as her life's  
18 work the pursuit of equality for all people in the Louisville community and across this  
19 great Commonwealth, departed this earthly life and entered into the kingdom of Heaven  
20 on December 30, 2016, leaving her friends, family, and all those whose lives she touched  
21 in solemn mourning; and

22           WHEREAS, Carolyn Miller-Cooper is survived by her husband, David Cooper;  
23 children, Rachel and Sean David Cooper; father, Melvin Miller (Carmen); siblings, David  
24 Miller (Tina), Cynthia Cotton (Truly), and Janet Frederick; and a host of other family  
25 members, friends, and loved ones who will dearly miss her presence in their lives;
