18	for all people never failed to show up in her writing, and her columns enlightened readers
19	who looked to her words for inspiration, wit, and the trademark generosity with which
20	she lived her life; and

22	community, departed this earthly life on January 1, 2018, leaving her family, friends, and
23	all those whose lives she touched in solemn mourning; and
