- recognized political party, all of the candidates affiliated with the same political

1	party who received the same second highest number of votes and the candidate
2	affiliated with the same political party who received the highest number of votes
3	qualify for the second party primary.
4	(3) If one of the persons receiving the highest number of votes in the first
5	party primary withdraws his candidacy, dies, or is otherwise disqualified, thereby
6	leaving only one candidate from the same political party in the race, the remaining
7	candidate who has received the highest number of votes for the office for which he
8	was a candidate shall be declared the nominee of the party.
9	C. There shall be no third party primary. For any situation not specifically
10	provided for herein, the state central committee of the recognized political party
11	involved shall provide for the selection of a nominee from the candidates and shall
12	provide notice of the selection of a nominee to the secretary of state no later than five
13	business days after the second party primary election."
