10 On page 1, between lines 8 and 9, insert the following

11 "§301. Definitions

13 meaning ascribed to them in this Section, unless the context clearly indicates a

31 Paragraph (29) of this Subsection."

2 On page 1, delete lines 15 through 17 in their entirety and insert the following:

3 "(29) Beginning October 1, 2017, the following exclusions shall apply:

4 (a) Sales and purchases of platinum, gold, or silver bullion, ingots, or coins
5 as provided in R.S. 47:301(16)(bb)(ii)(aa).

6 (b) Numismatic coins that have a sales price of no more than one thousand
7 dollars as provided in R.S. 47:301(16)(bb)(ii)(bb).

8 (c) Numismatic coins sold at a national, statewide, or multi-parish
9 numismatic trade show as provided in R.S. 47:301(16)(bb)(ii)(cc)."

17 as provided in R.S. 47:301(16)(bb)(ii)(aa).

18 (ii) Numismatic coins that have a sales price of no more than one thousand
19 dollars as provided in R.S. 47:301(16)(bb)(ii)(bb).

21 numismatic trade show as provided in R.S. 47:301(16)(bb)(ii)(cc)."
