1 has the experience required in Subparagraphs (a) and (b) of this Paragraph to fill the 2 office; and the person thus however, selection preference may be given to any person 3 having such experience in the municipal fire and police classified civil service 4 system. The person appointed shall serve a working test period of six (6) months 5 which shall be considered a portion of the examination. At the termination of such working test period, if successfully completed, the appointee shall become a regular 6 7 employee as defined in the State Civil Service Law and subject and amenable thereto 8 to the same extent as the original State Examiner as hereinbefore set forth; and may 9 be subjected to removal or other disciplinary action by the State Civil Service 10 Commission only for a good and sufficient cause set forth in written charges filed 11 with the Commission by any one of the Municipal Fire and Police Civil Service Boards created by this Act, or by any qualified elector of the State, and only after a 12 13 public hearing by the State Commission to be held in accordance with rules to be 14 adopted by the State Civil Service Commission.
