(15) Four members of the Louisiana House of Representatives appointed by 24 25 the speaker of the House of Representatives. 26 (16) Four members of the Louisiana Senate appointed by the president of the Senate. 27 28 (17) Four members appointed by the governor. 29 (18) One representative of the Louisiana Tax Institute appointed by the board 30 of the Louisiana Tax Institute. (B)(1) Appointments made pursuant to this Section shall be submitted to the 31 32 chairman of the convention and the secretary of state no later than fifteen days after 33 the convention requests the appointments. The secretary of state shall issue a 34 commission to each person appointed as provided in this Section. 35 (2) If a person appointed as an advisory member is unable to serve for any 36 reason, the vacancy shall be filled in the manner of the original appointment. 37 (C) Advisory members appointed pursuant to this Section may participate 38 in discussion and debate only in committees established by the convention and only 39 if authorized in the rules of the convention but shall not have the right to vote. (B) If any provision of the revision of the constitution, or the application thereof, is deemed invalid after ratification by the electors, such invalidity shall not affect other provisions, items, or applications of the revision which can be given effect without the invalid provision, item, or application."
