Amendments proposed by House Committee on Education to Original House Bill No. 6 by Representative Hughes

1 AMENDMENT NO. 1

2 On page 1, line 2, after "reenact" delete the remainder of the line and at the beginning of line
3 3, delete "timing of certain board meetings;" and insert the following:

4 "R.S. 17:1833(E), 1853(E), and 3123(E), relative to meetings of certain public
5 postsecondary education boards; to provide relative to the first meeting each year of
6 the Board of Regents and the University of Louisiana and Southern University
7 boards of supervisors;"

8 AMENDMENT NO. 2

9 On page 1, line 5, after "Section 1." and before "hereby" delete "R.S. 17:3123(E) is" and
10 insert "R.S. 17:1833(E), 1853(E), and 3123(E) are"

11 AMENDMENT NO. 3

12 On page 1, between lines 5 and 6, insert the following:
