AMENDMENT NO. 2

5 On page 1, at the beginning of line 3, change "355(B)(3)," to "355(B)(3) and (E),"

AMENDMENT NO. 3

7 On page 1, line 5, after "schools;" and before "and" insert "to provide for penalties;"

AMENDMENT NO. 4

9 On page 1, line 7, after "Section 1." and before "hereby" change "R.S. 17:355(C) and (D)
10 are" to "R.S. 17:355(D) is"

AMENDMENT NO. 5

12 On page 1, line 8, after "and" and before "are" change "355(B)(3)" to "355(B)(3) and (E)"

AMENDMENT NO. 6

14 On page 1, line 15, after "teacher" delete the remainder of the line and on line 16, delete
15 "pursuant to this Subsection to a student"

AMENDMENT NO. 7

17 On page 1, delete line 17 and insert "of any student he taught for the subject he taught in that
18 school year and is entitled to review an individualized student assessment report that
19 identifies the student's performance in each assessment domain."

AMENDMENT NO. 8

21 On page 1, line 20, after "student" delete the remainder of the line and on page 2, at the
22 beginning of line 1, delete "assessment." and insert "he taught for the subject he taught in
23 that school year."

AMENDMENT NO. 9

25 On page 2, at the end of line 9, change the period "." to a comma "," and add "pursuant to
26 Subsection E of this Section."

AMENDMENT NO. 10

28 On page 2, delete lines 10 through 20 in their entirety and insert "* * *"

AMENDMENT NO. 11

30 On page 2, line 22, after "means" and before "assessment" change "an" to "a state"

2 On page 2, line 23, after "17:24.4" delete the remainder of the line and insert "but shall not
3 include a national assessment that the state Department of Education is prohibited by the
4 assessment vendor from providing to a parent for review."

5 AMENDMENT NO. 13

6 On page 3, after line 7, insert the following:

7 "E.(1) The state Department of Education shall provide for an
8 assessment review period for parents of students who are administered such
9 assessments. The review period shall begin not later than ten business days
10 following the dissemination of assessment results to parents and shall be
11 offered for at least ten consecutive business days. The review shall be held
12 at the department's main office during regular business hours in the presence
13 of the director of assessments or his designee. During the review, the parent
14 shall not photocopy or photograph any assessment item or question or make
15 handwritten or typed notes that identify an assessment item or question.

16 (2) A parent who violates the provisions of his Subsection shall be
17 fined not more than ten thousand dollars or imprisoned for not more than six
18 months and may be required to reimburse the state Department of Education
19 for any costs incurred by the department to replace any assessment items or
20 questions determined to no longer be secure due to the actions of the parent."
