13 AMENDMENT NO. 13

14 On page 4, line 11, after "shall" delete the remainder of the line, delete lines 12 and 13 in
15 their entirety, insert a comma "," and insert the following:

16 "for the purpose of administering the reporting provisions required by this Act,
17 collect a fee of two hundred dollars per motion picture production for which reports
18 and payroll withholding information are mandated by ths Act."
