However, nothing in this Subpart shall 14 15 prohibit a health insurance issuer or its agent from establishing differing copayments or other cost sharing amounts within the benefit plan for covered 16 persons who acquire physician-administered drugs from other providers. 17 Nothing in this Subpart shall prohibit a health insurance issuer or its agent 18 19 from refusing to authorize or approve or from denying coverage of a 20 physician-administered drug based upon failure to satisfy medical necessity 21 criteria. For purposes of this Section, the location of receiving the physician-administered drug shall not be included in the medical necessity 22 23 criteria."
