20 On page 1, between lines 10 and 11 insert the following:

21 "§1. Louisiana Workforce Commission established; purpose; definitions  
22 A. The Louisiana Workforce Commission is hereby created and established  
23 to operate an integrated workforce development delivery system in this state, in  
24 particular through the integration of job training, employment and employment-  
25 related education and training programs, vocational rehabilitation services,  
26 independent living services, and blind services programs, and to administer the  
27 state's unemployment and workers' compensation programs. The duties of this  
28 commission shall be exercised and discharged under the supervision and direction  
29 of the ~~executive director~~ secretary. He shall have charge of the administration and  
30 enforcement of all laws, rules, policies, and regulations, which it is the duty of the  
31 commission to administer and enforce, and shall direct all inspections and  
32 investigations, except as otherwise provided by law.

34 C. As used in this Title, unless the context clearly indicates otherwise, the  
35 following terms shall be defined as follows:

37 (3) ~~"Executive director"~~ means the executive director "Secretary" means the  
38 secretary of the commission.

40 §382. Apprenticeship council

1 A. The ~~executive director~~ secretary shall appoint an apprenticeship council,  
 2 composed of three representatives each from employer and employee organizations  
 3 respectively, and of two representatives of the general public. The three employer  
 4 representatives shall be selected from lists supplied by employer organizations which  
 5 are participating in bona fide apprenticeship programs. The three employee  
 6 representatives may be representatives of labor organizations, who have been  
 7 nominated by state labor federations. The state official in charge of trade and  
 8 industrial education shall, ex officio, be a member of the ~~said~~ council. Each member  
 9 shall be appointed for a term of three years. Any member appointed to fill a vacancy  
 10 occurring prior to the expiration of the term of his predecessor shall be appointed for  
 11 the remainder of the ~~said~~ term. Each member of the council not otherwise  
 12 compensated by public monies, shall be reimbursed for transportation and shall be  
 13 paid thirty-five dollars per day for each day spent in attendance at meetings of the  
 14 apprenticeship council.

15 B. The apprenticeship council shall meet at the call of the ~~executive director~~  
 16 secretary or the director of apprenticeship and shall aid in formulating policies for  
 17 the effective administration of this Chapter. Subject to the approval of the ~~executive~~  
 18 ~~director~~ secretary, the apprenticeship council may recommend standards and  
 19 procedures for registration and de-registration of apprenticeship programs in  
 20 conformity with established programs approved by the United States Department of  
 21 Labor, Office of Apprenticeship, and for approval of apprenticeship agreements  
 22 which in no case shall be lower than those prescribed by this Chapter and by the  
 23 United States Department of Labor, Office of Apprenticeship, or lower than  
 24 approved national standards; shall issue such rules and regulations as may be  
 25 necessary to carry out the intent and purposes thereof; and shall perform such other  
 26 functions as the ~~executive director~~ secretary may direct. Not less than once a year the  
 27 apprenticeship council shall make a report, through the ~~executive director~~ secretary,  
 28 of its activities and findings to the legislature and to the public.

30 §390. Settlement of controversies or complaints

31 \* \* \*

32 C. Upon the complaint of any interested person or upon his own initiative,  
 33 the director of apprenticeship may investigate to determine if there has been a  
 34 violation of the terms of an apprenticeship agreement made under this Chapter and  
 35 hold hearings, inquiries, and other proceedings necessary to such investigations and  
 36 determination. The director of apprenticeship shall investigate programs only as  
 37 necessary to establish compliance, and then only upon proper notice. The parties to  
 38 such agreement shall be given a fair and impartial hearing, after reasonable notice  
 39 thereof. All hearings, investigations, and determinations shall be made under  
 40 authority of reasonable rules and procedure prescribed by the apprenticeship council,  
 41 subject to the approval of the ~~executive director~~ secretary.

42 D. The determination of the director of apprenticeship shall be filed with the  
 43 ~~executive director~~ secretary. If no appeal therefrom is filed with the ~~executive~~  
 44 ~~director~~ secretary within twenty days after the date thereof, such determination shall  
 45 become the order of the ~~executive director~~ secretary. Any person aggrieved by any  
 46 determination or action of the director of apprenticeship may appeal therefrom to the  
 47 ~~executive director~~ secretary who shall hold a hearing thereon, after due notice to the  
 48 interested parties. Orders and decisions of the ~~executive director~~ secretary shall be  
 49 prima facie lawful and reasonable if supported by reasonable and competent  
 50 evidence. Any party to an apprenticeship agreement aggrieved by an order or  
 51 decision of the ~~executive director~~ secretary may appeal to the courts on questions of  
 52 law. The decision of the ~~executive director~~ secretary shall be conclusive if no appeal  
 53 therefrom is filed within thirty days after the date of the order or decision.

55 §1203.1. Definitions; medical treatment schedule; medical advisory council

56 A. For use in this Section, the following terms ~~shall~~ have the following  
 57 meanings, unless clearly indicated otherwise by the context:



1 seq. In no event shall the schedule contain multiple guidelines covering the same  
 2 aspects of the same medical condition which are simultaneously in force.

4 J.(1) After a medical provider has submitted to the payor the request for  
 5 authorization and the information required by the Louisiana Administrative Code,  
 6 Title 40, Chapter 27, the payor shall notify the medical provider of their action on  
 7 the request within five business days of receipt of the request. If any dispute arises  
 8 after January 1, 2011, as to whether the recommended care, services, or treatment is  
 9 in accordance with the medical treatment schedule, or whether a variance from the  
 10 medical treatment schedule is reasonably required as contemplated in Subsection I  
 11 of this Section, any aggrieved party shall file, within fifteen calendar days, an appeal  
 12 with the office of workers' compensation administration medical director or associate  
 13 medical director on a form promulgated by the ~~director~~ assistant secretary. The  
 14 medical director or associate medical director shall render a decision as soon as is  
 15 practicable, but in no event, not more than thirty calendar days from the date of  
 16 filing.

17 (2) If either party, the medical director, or associate medical director believes  
 18 that a potential conflict of interest exists, he shall communicate in writing such  
 19 information to the ~~director~~ assistant secretary, who shall make a determination as to  
 20 whether a conflict exists within two business days. The ~~director~~ assistant secretary  
 21 shall notify in writing the patient, the physician, and, if applicable, the attorney of  
 22 his decision within two business days.

24 §1203.1.1. Medical director and associate medical director

25 A. The ~~director~~ assistant secretary shall hire a medical director and an  
 26 associate medical director to render decisions on disputed cases filed pursuant to R.S.  
 27 23:1203.1(J).

 30 Section 2. R.S. 36:3(2), (4), (6) and (7), 8(E)(1), 301(C), 302, 303,  
 31 304(A)(introductory paragraph), (8), (9)(b), (B)(introductory paragraph), (1)(a)(i) and (ii),  
 32 and 305 through 307 are hereby amended and reenacted to read as follows:

33 §3. Definitions

34 For the purposes of this Title the following terms shall have the following  
 35 meanings unless the context clearly indicates otherwise:

37 (2) "Assistant secretary" means the officer designated by law or by the  
 38 secretary of each department to carry out the duties and functions of an office within  
 39 certain departments, except an office of management and finance and the office of  
 40 state police of the Department of Public Safety and Corrections. ~~For the Louisiana~~  
 41 ~~Workforce Commission, the "director" shall mean the officer designated by law or~~  
 42 ~~by the executive director to carry out the duties and functions of an office within the~~  
 43 ~~Louisiana Workforce Commission except the office of management and finance.~~

45 (4) "Deputy secretary" means the officer authorized to be appointed by the  
 46 secretary to serve as his principal administrative assistant. For the Department of  
 47 Public Safety and Corrections, the "deputy secretary for public safety services" and  
 48 the "deputy secretary for corrections services" shall be the officers of the department  
 49 appointed by the secretary to serve as the principal administrative assistants of the  
 50 secretary and references in any provision of law to the deputy secretary, where  
 51 reference is to a deputy secretary of the Department of Public Safety and  
 52 Corrections, shall include these two officers. ~~For the Louisiana Workforce~~  
 53 ~~Commission, the "deputy executive director" shall mean the officer authorized by the~~  
 54 ~~executive director to serve as his principal administrative assistant.~~

56 (6) "Secretary" means the officer appointed by the governor as the executive  
 57 head and chief administrative officer of certain departments created and provided for  
 58 by this Title. ~~For the Louisiana Workforce Commission, the "executive director"~~

1 shall mean the officer appointed by the governor as the executive head and chief  
 2 administrative officer.

3 (7) "Undersecretary" means the officer designated to direct and be  
 4 responsible for the functions of the office of management and finance of certain  
 5 departments. ~~For the Louisiana Workforce Commission, the "chief financial officer"~~  
 6 ~~shall mean the officer designated to direct and be responsible for the functions of the~~  
 7 ~~office of management and finance.~~ For the Department of Children and Family  
 8 Services, "undersecretary" means the officer designated to direct and be responsible  
 9 for the functions of the division of management and finance within the office of  
 10 children and family services.

14 E. As used in this Section, the following words shall have the following  
 15 meanings unless the context clearly indicates otherwise:

16 (1) "Secretary" means the chief administrative officer of each department of  
 17 the executive branch of state government, except that with respect to agencies of the  
 18 Department of Education transferred under the provisions of R.S. 36:651(K),  
 19 "secretary" means the Louisiana Student Financial Assistance Commission, with  
 20 respect to the Department of Public Service, "secretary" means the Public Service  
 21 Commission, and with respect to the Department of State Civil Service, "secretary"  
 22 means the State Civil Service Commission, through the director of state civil service  
 23 ~~and with respect to the Louisiana Workforce Commission, "secretary" means the~~  
 24 ~~executive director.~~

26 §301. Louisiana Workforce Commission; creation; domicile; composition; purposes  
 27 and functions

28 \* \* \*

29 C.(1) The Louisiana Workforce Commission shall be composed of the  
 30 executive office of the ~~executive director~~ secretary, the office of management and  
 31 finance, the office of workforce development, the office of unemployment insurance  
 32 administration, the office of workers' compensation administration, the office of  
 33 occupational information services, and such other offices as shall be created by law.  
 34 The Louisiana Workforce Investment Council, as more specifically provided in R.S.  
 35 23:2042 et seq., shall be placed within the executive office of the ~~executive director~~  
 36 secretary.

37 (2) Whenever the ~~executive director~~ secretary determines that the  
 38 administration of the functions of the commission may be more efficiently performed  
 39 by eliminating, merging, or consolidating existing offices or establishing new  
 40 offices, he shall present a plan therefor to the legislature for its approval by statute.

41 §302. Officers of the commission; compensation for one office only

42 A. The officers of the commission shall be the ~~executive director, the chief~~  
 43 ~~financial officer, the deputy executive director if a deputy executive director is~~  
 44 ~~appointed, and directors;~~ secretary, the undersecretary, the deputy secretary if a  
 45 deputy secretary is appointed, and assistant secretaries, each of whom shall be  
 46 selected and shall perform functions as provided in this Title.

47 B. No person serving as ~~executive director, chief financial officer, deputy~~  
 48 ~~executive director, or director~~ secretary, undersecretary, deputy secretary, or assistant  
 49 secretary shall receive any additional salary from the state other than that salary  
 50 which he receives by virtue of serving in any one of such offices. Any statewide  
 51 elected official appointed to serve as ~~executive director, chief financial officer,~~  
 52 ~~deputy executive director, or director;~~ secretary, undersecretary, deputy secretary,  
 53 or assistant secretary shall not receive any additional salary from the state other than  
 54 that salary which he receives as a statewide elected official.

55 C. Notwithstanding any provision herein to the contrary, subject to approval  
 56 of the governor, any person, including any statewide elected official, serving or  
 57 appointed to serve as ~~executive director, chief financial officer, deputy executive~~  
 58 ~~director or director;~~ secretary, undersecretary, deputy secretary, or assistant secretary

1 may receive additional compensation for part-time services rendered as an instructor  
 2 in post-secondary educational institutions, or as a member of the National Guard.

3 §303. ~~Executive director~~ Secretary

4 There shall be ~~an executive director~~ a secretary, who shall be appointed by  
 5 the governor with consent of the Senate and who shall serve at the pleasure of the  
 6 governor at a salary fixed by the governor, which salary shall not exceed the amount  
 7 approved for the position by the legislature while in session. The ~~executive director~~  
 8 secretary shall serve as the executive head and chief administrative officer of the  
 9 Louisiana Workforce Commission and shall have the responsibility for the policies  
 10 of the commission, except as otherwise provided by this Title, and for the  
 11 administration, control, and operation of the functions, programs, and affairs of the  
 12 commission; provided that the ~~executive director~~ secretary shall perform his  
 13 functions under the general control and supervision of the governor.

14 §304. Powers and duties of ~~executive director~~ secretary

15 A. In addition to the functions, powers, and duties otherwise vested in the  
 16 ~~executive director~~ secretary by law, he shall:

18 (8) Provide for the ongoing merger and consolidation of the agencies and  
 19 functions transferred to his commission and submit a report thereon to the governor  
 20 and the legislature, which report shall accompany the budget request which he  
 21 submits under provisions of R.S. 39:33. Such report shall include a statement of the  
 22 goals of the commission and of the programs thereof and shall summarize the  
 23 accomplishments of the commission in meeting such goals and implementing such  
 24 programs. The report shall also contain a specific statement of the reorganization  
 25 and consolidation plan for the commission for the next year and shall include a report  
 26 on the implementation of such reorganization and consolidation plan for the previous  
 27 year. The report concerning reorganization shall specifically detail the extent to  
 28 which the commission has achieved goals stated the previous year with respect to  
 29 merger and consolidation of functions, abolition of agencies, consolidation of  
 30 offices, elimination of job positions, and efficiency and economy in delivery of  
 31 services. The report shall contain any recommendations with respect to  
 32 reorganization which may require legislative action under the provisions of this Title.  
 33 A copy of the report and recommended legislation shall also be submitted by the  
 34 ~~executive director~~ secretary to the presiding officer of both houses of the legislature.  
 35 The presiding officer shall refer the report to the appropriate committee having  
 36 jurisdiction of the subject matter as provided in the rules of the respective house.

56 §305. Deputy ~~executive director~~ secretary

57 There may be a deputy ~~executive director~~ secretary of the commission, who  
 58 shall be appointed by the ~~executive director~~ secretary with consent of the Senate and  
 59 who shall serve at the pleasure of the ~~executive director~~ secretary at a salary fixed

1 by the ~~executive director~~ secretary, which salary shall not exceed the amount  
 2 approved for such position by the legislature while in session. The duties and  
 3 functions of the deputy ~~executive director~~ secretary shall be determined and assigned  
 4 by the ~~executive director~~ secretary. If appointed, he shall serve as acting ~~executive~~  
 5 ~~director~~ secretary in the absence of the ~~executive director~~ secretary.

6 §306. ~~Chief financial officer~~ Undersecretary; functions; office of management and  
 7 finance

8 A. There shall be a ~~chief financial officer~~ an undersecretary of the Louisiana  
 9 Workforce Commission, who shall be appointed by the governor with the consent  
 10 of the Senate and who shall serve at the pleasure of the governor at a salary fixed by  
 11 the governor, which salary shall not exceed the amount approved for such position  
 12 by the legislature while in session. The ~~chief financial officer~~ undersecretary shall  
 13 be directly responsible to and shall perform his functions under the supervision and  
 14 control of the ~~executive director~~ secretary.

15 B. The ~~chief financial officer~~ undersecretary shall direct and be responsible  
 16 for the functions of the office of management and finance within the Louisiana  
 17 Workforce Commission. In such capacity he shall be responsible for accounting and  
 18 budget control, procurement and contract management, management and program  
 19 analysis, personnel management, and grants management for the commission and all  
 20 of its offices, including all agencies transferred to the Louisiana Workforce  
 21 Commission, except as otherwise specifically provided in this Title. He shall  
 22 employ, appoint, remove, assign, and promote such personnel as is necessary for the  
 23 efficient administration of the office of management and finance and the  
 24 performance of its powers, duties, functions, and responsibilities, in accordance with  
 25 applicable civil service laws, rules, and regulations, and with policies and rules of  
 26 the commission, all subject to budgetary control and applicable laws. The ~~chief~~  
 27 ~~financial officer~~ undersecretary shall exercise all powers and authority granted to  
 28 him in this Title subject to the overall direction and control of the ~~executive director~~  
 29 secretary.

30 §307. ~~Directors~~ Assistant secretaries

31 A. Each office within the Louisiana Workforce Commission, except the  
 32 office of management and finance, shall be under the immediate supervision and  
 33 direction of a ~~director~~ an assistant secretary, who shall be appointed by the governor  
 34 with consent of the Senate. Each shall serve at the pleasure of the governor and shall  
 35 be paid a salary which shall be fixed by the governor, which salary shall not exceed  
 36 the amount approved for such position by the legislature while in session.

37 B. Except as otherwise expressly provided in this Title, the duties and  
 38 functions of each office and its ~~director~~ assistant secretary shall be determined by the  
 39 ~~executive director~~ secretary, and all of such duties and functions shall be exercised  
 40 under the direct supervision and control of the ~~executive director~~ secretary.

41 C. Except as otherwise provided in R.S. 36:801, each ~~director~~ assistant  
 42 secretary shall employ, appoint, remove, assign, and promote such personnel as is  
 43 necessary for the efficient administration of his office and its programs and the  
 44 performance of its powers, duties, functions, and responsibilities, in accordance with  
 45 applicable civil service laws, rules, and regulations, and with policies and rules of  
 46 the commission, all subject to budgetary control and applicable laws.

47 D. Each ~~director~~ assistant secretary shall exercise all powers and authority  
 48 granted to him in this Title subject to the overall direction and control of the  
 49 ~~executive director~~ secretary."
