1 AMENDMENT NO. 1

2 On page 1, line 2, after "To' and before "relative" delete "enact R.S. 47:301(14)(g)(iv)," and
3 insert the following:

4 "amend and reenact R.S. 47:302(AA)(introductory paragraph), and to enact R.S.
5 47:301(14)(g)(iv), 302(AA)(29), and 321.1(F)(67),"

6 AMENDMENT NO. 2

7 On page 1, line 3, after "property;" and before "to provide" insert the following:

8 "to provide for effectiveness and applicability of the exclusion;"

9 AMENDMENT NO. 3

10 On page 1, line 6, after "Section 1." and before "hereby" delete "R.S. 47:301(14)(g)(iv) is"
11 and insert the following:

12 "R.S. 47:302(AA)(introductory paragraph) is hereby amended and reenacted and
13 R.S. 47:301(14)(g)(iv), 302(AA)(29), and 321.1(F)(67) are"

14 AMENDMENT NO. 4

15 On page 1, line 17, after "**personal**" and before "**shall**" delete "**property**" and insert
16 "**property and fabrication**"

17 AMENDMENT NO. 5

18 On page 2, between lines 10 and 11, insert the following:

19 "§302. Imposition of tax

20 * * *

21 AA. Notwithstanding any other provision of this Section to the contrary,
22 **except as provided in Paragraph (29) of this Subsection**, beginning July 1, 2016,
23 the following specific exclusions and exemptions shall be applicable to the tax levied
24 pursuant to the provisions of this Section:

25 * * *

26 **(29) Beginning July 1, 2017, the exclusion for surface preparation,**
27 **painting, and coating fixed or rotary wing aircraft and certified transport**
28 **category aircraft registered outside of this state, as provided in R.S.**
29 **47:301(14)(g)(iv).**

2 §321.1. Imposition of Tax

4 F. Notwithstanding any other provision of law to the contrary, including but
5 not limited to any contrary provision of this Chapter, there shall be no exemptions
6 or exclusions as defined in R.S. 47:301 to the tax levied pursuant to the provisions
7 of this Section, except for the sales or purchases of the following items:

8 * * *

9 (67) Beginning July 1, 2017, in addition to those exclusions and
10 exemptions provided for in Paragraphs (1) through (66) of this Subsection, the
11 exclusion for surface preparation, painting, and coating fixed or rotary wing
12 aircraft and certified transport category aircraft registered outside of this state,
13 as provided in R.S. 47:301(14)(g)(iv).
