ELECTIONS EN INCREASE GF EX See Note Page 1 of 2  
 Provides for closed party primary elections for certain offices (Items #7, #8, and #10)

Proposed law creates a closed party primary system for congressional elections, the Louisiana Supreme Court, the Board of Elementary and Secondary Education (BESE), and Public Service Commissioners starting in Spring 2026. Proposed law provides that voters are required to be members of the recognized political party to participate in its primary unless the bylaws and regulations of the party's state central committee allow for unaffiliated voters to participate. Proposed law provides that the candidate who receives the majority of votes in a party primary election qualifies for the general election. Proposed law provides for a runoff second party primary election in the case that no candidate receives a majority of votes in the first party primary election.

Proposed law effective January 1, 2026.

**EXPENDITURE EXPLANATION**

Proposed law will result in a significant increase in SGF expenditures in FY 26 and a potentially significant increase in FY 28 for the Secretary of State to prepare for and implement a closed party primary system for United States congressional offices and Louisiana Supreme Court Justices starting in the Spring of 2026. **The LFO estimates that the minimum exposure is approximately \$11.7 M in FY 26 and \$9.5 M in FY 27. The maximum exposure for FY 26 is approximately \$19.7 M, the maximum exposure for FY 27 is approximately \$17.6 M, and the maximum exposure for FY 28 is approximately \$9.5 M. These costs will depend on whether and how many runoff elections, or second party primary elections, will occur. To the extent any runoff elections do not require a full statewide election, maximum exposure costs for FY 26, FY 27, and FY 28 will decrease accordingly. The maximum exposure is shown in the expenditure table above.**

FY 25:

The Secretary of State's office anticipates a potentially significant increase in SGF expenditures in FY 25 to prepare for the inclusion of unaffiliated voters in the party primary elections. Due to the complexity of this issue, the department cannot develop accurate estimates of the increased costs at this time. The department anticipates needing additional SGF for voter outreach and IT development. If necessary, some of these costs may need to be carried forward into FY 26 to complete the process.

One-time Expenditures in FY 26:

In addition to the costs to hold a statewide election the Secretary of State indicates an increase of \$2.1 M in one-time expenditures for IT programming (\$100,000) and voters outreach (\$2 M) in FY 26 to prepare for the closed party primary system.

**EXPENDITURE EXPLANATION CONTINUED:**

FY 26 Election Expenses:

The implementation of a closed party primary for Congressional Members, the Supreme Court, and Public Service Commissioners will require the Secretary of State to hold a new statewide election in FY 26. The costs of the statewide election are enumerated in the "Minimum Exposure" column below. The costs in FY 26 will depend on whether and how many runoff elections, or second party primary elections, will occur. If all six congressional districts need to hold a runoff election, then the Secretary of State will have to hold an additional statewide election, represented by the "Maximum Exposure" column below.

**The total costs for FY 26 is estimated at \$11.7 M (\$9.6 M in various election expenses + \$2.1 M in one-time costs) at a minimum and \$19.7 M (\$17.6 M in various election expenses + \$2.1 M in one-time costs) at a maximum.**

FY 27:

The BESE board members are elected in conjunction with the governor. Proposed law requires party primary elections to be held in March. This implies that the BESE board primary elections will occur in March of FY 27. The implementation of a closed party primary for BESE board members will require the Secretary of State to hold a new statewide election in FY 27. The costs of the statewide election are enumerated in the "Minimum Exposure" column below. The costs in FY 27 will depend on whether and how many runoff elections, or second party primary elections, will occur. If all BESE board members need to hold a runoff election, then the Secretary of State will have to hold an additional statewide election, represented by the "Maximum Exposure" column below.

FY 28 Election:

There is an existing presidential primary election scheduled in March 2028. The United State Congressional and Louisiana Supreme Court Justice races will be added to this ballot. However, the requirement for a majority vote to move on to the general ballot means the Secretary of State may have to hold runoff elections. If all six congressional districts need to hold a runoff election, then the Secretary of State will have to hold an additional statewide election in FY 28. The costs of holding that additional election is represented below.
