Requires students who are entering eleventh grade or who are 16 and entering any grade to provide satisfactory evidence of current immunization against meningococcal disease as a condition of school entry

**Present law** requires a student to provide satisfactory evidence of current immunization against meningococcal disease as a condition of entry into the sixth grade or who is 11 years old and entering a grade other than 6th in any city, parish, or other public school, or nonpublic school. **Proposed legislation** would make this same requirement a condition of entry into 11th grade and entry into any grade by a student who is 16 years of age; requires a student who is 16 and participating in a home study program to provide such evidence to BESE.

## **EXPENDITURE EXPLANATION**

There is no anticipated direct material effect on the expenditures of local school districts as a result of this measure. The La Department of Health (LDH) reports that this will require additional resources, including a program monitor (\$81,000 salary and related benefits \$6,168 plus operating expenses) to coordinate assessments of students to provide evidence of the required immunization. However, the bill does not specify such coordination and based on information received from school districts, current immunization requirements are not coordinated in this manner. Thus, the LFO believes there will be no impact to LDH.

## **REVENUE EXPLANATION**

There is no anticipated direct material effect on governmental revenues as a result of this measure.
