FEES/LICENSES/PERMITS EG INCREASE SG RV See Note Page 1 of 1

Provides for an application for licensure fee and licensure renewal fee for professional geoscientists and geoscientists-in-training

Present law provides for the licensure of professional geoscientists and geoscientists-in-training under the Louisiana Professional Geoscience Practice Act. Proposed law retains present law and requires the payment of an application fee for licensure established at the discretion of the board, not to exceed \$200. Prohibits the board from increasing the fee by more than \$30 in a any three-year period. Further requires the payment of renewal of licensure or certification renewal fee established by the board, not to exceed \$150. Prohibits the board from increasing the renewal fee by more than \$20 in any one-year period. A maximum fee for the late renewal shall be established by the board, but shall not exceed three times the normal renewal fee.

**EXPENDITURE EXPLANATION**

There is no anticipated direct material effect on governmental expenditures as a result of this measure.

**REVENUE EXPLANATION**

The proposed legislation is anticipated to increase agency self-generated revenues of the Board of Professional Geoscientists by an indeterminable amount. According to the board, approximately 900 geoscientists will apply for licensure and approximately 100 will apply for certification initially. The application fees will be established at the discretion of the board but may not exceed \$200. For illustrative purposes, if the licensure fees are \$200 and certification fees are \$100 in FY 14, the increase in self-generated revenue in FY 14 would be \$190,000. The board cannot increase the fee by more than \$30 in any three-year period. Self-generated revenues would be less in subsequent years, because a majority of funds received will be from renewals, which cannot exceed \$150 annually and cannot increase more than \$20 in any one-year period.
