<u>Present law</u> (R.S. 18:562 and 1309) requires election officials to establish the identity of a person who seeks to vote at a polling place during early voting or on election day. Requires the person to present a La. driver's license, a La. special identification card issued pursuant to present law (R.S. 40:1321), or other generally recognized picture identification card that contains the name and signature of the person.

<u>Proposed law</u> retains present law and adds to the acceptable forms of identification a U.S. military identification card that contains the person's name and picture.

## **EXPENDITURE EXPLANATION**

**Proposed law** is anticipated to create one-time expenditures of approximately \$110,200 due to required changes to the Voter Portal and GeauxVote mobile apps (\$16,000) and to replace the current stock of voter forms and pamphlets (\$94,200) to include the U.S. military ID card as an acceptable form of identification for voting. The Secretary of State (SOS) estimated total costs for programming changes to the Voter Portal and GeauxVote mobile apps are based upon 160 hours at \$100 per hour. The changes are anticipated to take two months.

The forms and pamphlet costs are broken down below. These forms and pamphlets are updated either when required by legislative changes or when the Secretary of State (SOS) changes a procedure, makes design improvements, or adds additional necessary details. Since these forms are not routinely updated (i.e., annually), **proposed law** will require SOS to incur these additional costs to replace these forms and pamphlets that otherwise could have been used. However, to the extent additional legislation is enacted or SOS deems a change to the forms/procedures is necessary, the changes outlined in **proposed law** would be performed regardless of the cost identified herein.
