## **EXPENDITURE EXPLANATION**

There is no anticipated direct material effect on governmental expenditures as a result of this measure.

An official with the New Orleans Municipal Court indicated that making copies and retrieval of files are services currently provided, but the court is absorbing the costs.

## **REVENUE EXPLANATION**

As a result of this measure, there may be an increase in local revenue of \$25,000 in 2013-2014, decreasing annually to \$20,000 in 2017-2018.

An official with the court estimated that 15-20 documents per day or 3,000-5,000 copies per year would be subject to the fee, generating approximately \$5,000 annually. The New Orleans Municipal Court will continue to allow local, state, and federal agencies to make copies at no charge, and will implement the proposed fee on copies requested by defendants, witnesses, or attorneys.

In addition, it is estimated that 18-20 file retrievals are requested each week for revenue of approximately \$20,000 beginning in fiscal year 2013-14, decreasing to \$15,000 in fiscal year 2017-18.
