Revises provisions relative to aid to needy families and employment services for TANF cash assistance recipients

Present law provides for federal Temporary Assistance for Needy Families (TANF) block grant program to be coordinated at a state level by the Department of Children and Family Services (DCFS) as well as designates the La. Workforce Investment Council as a state partner of DCFS for Strategies to Empower People (STEP) program that provides employment and job training services to Family Independence Temporary Assistance Program (FITAP) recipients. Proposed law revises present law to (1) designate the Louisiana Workforce Commission (LWC) as the state partner of DCFS for such services; (2) stipulates that employment and job training services be delivered pursuant to performance-based contracts with LWC or other community partners; (3) deletes and simplifies provisions relating to Strategies to Empower People (STEP) program requirements that do no improve outcomes.

The department has indicated that it will promulgate rules regarding these provisions in accordance with the Administrative Procedure Act. It appears that the intent of the legislation is to give the department more flexibility in designing and operating the STEP program. The proposed legislation does not remove any work requirements or functions of the STEP program. The Legislative Fiscal Offices does not anticipate any STEP services being eliminated as a result of this legislation.
