Repeals certain provisions of law referring to inheritance taxes

<u>Current law</u> levies no inheritance tax, and does not include the value of property acquired by inheritance in taxable income. <u>Previous law</u> levying an inheritance tax was repealed in 2008.

Proposed law removes multiple references to the repealed inheritance tax from the Revised Statutes.

Effective upon governor's signature.
