WILDLIFE/FISHERIES DEPT RE +\$20,000 SD EX See Note Page 1 of 1  
 Requires the Department of Wildlife & Fisheries to notify applicants for recreational fishing and hunting licenses of the option to become an organ and tissue donor and make an organ donation. (8/1/24)  
 Proposed law requires the Louisiana Department of Wildlife and Fisheries (LDWF) to include the Organ Donor designation on recreational hunting and fishing licenses. Proposed law requires that LDWF provide information on anatomical donations through its recreational licensing system and that applicants for recreational fishing and hunting licenses who are not registered donors be provided an opportunity to confirm their donor intention. Additionally, proposed law requires the applicants response to be indicated on their licenses.

**EXPENDITURE EXPLANATION**


The Louisiana Department of Wildlife and Fisheries (LDWF) estimates a one time cost of \$20,000 in dedications out of the Conservation Fund to implement anatomical donations into the existing recreational licensing system. LDWF's recreational license vendor, *Envoc*, estimates needing 160 hours of planning, development, and testing to add this feature. LDWF pays \$125 per hour for their services for a total of \$20,000 for 160 hours (160 x \$125).

**REVENUE EXPLANATION**
